Equipment Function

The EUT is a portable body worn digital device. The device displays time, incorporates sensors to log movement and other parameters and includes transmitter functions for communication with compatible equipment. The design provides a single unique connection point for use with the unique USB interface cable and offers no other interface options as presented below in the configuration diagrams. The transmitters provide operation capability across the 2402-2480 MHz frequency band. The design provides wireless communications with compatible ANT and Bluetooth® Low Energy (BLE) equipment. The product operates from internal rechargeable battery only and requires battery recharge through the provided USB interface cable and compatible USB power source. The design utilizes internal fixed antenna systems and offers no provision for antenna replacement or modification. Two samples were provided for testing, one representative of production design, and the other modified for testing purposes replacing the integral 2.4 GHz antenna with RF connection port. The test samples were provided with SW 0.22 providing testing personnel the ability to enable transmitter functions on defined modulations and channels. The test software enabled near 100% transmit duty cycle for testing purposes. The production product will operate at lower duty cycle to conserve battery life. The antenna modification offered testing facility the ability to connect test equipment to the temporary 2.4 GHz antenna port. The EUT was arranged as described by the manufacturer emulating typical user configurations for testing purposes. For testing purposes, the EUT received powered from freshly charged internal battery and/or AC power configurations and configured to operate in available modes. As requested by the manufacturer and required by regulations, the equipment was tested for compliance using the available configurations with the worst-case data presented. This report documents the testing performed and results for applicable configurations and product modes of operation. Applicable Standards

The following information is submitted in accordance with the eCFR Title 47 Code of Federal Regulations (47CFR), dated January 20, 2021: Part 2, Subpart J, Part 15C Paragraph 15.249, Industry Canada RSS-210 Issue 10, and RSS-GEN Issue 5. Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in ANSI C63.10-2013. This report documents compliance for the EUT operations as Low Power Transmitter.

Equipment Testing Procedures

AC Line Conducted Emission Test Procedure

Testing for the AC line-conducted emissions was performed as required in 47CFR 15C, RSS-210 Issue 10 and specified in ANSI C63.10-2013. The test setup, including the EUT, was arranged in the test configurations as presented during testing. The test configuration was placed on a 1 x 1.5meter bench, 0.8 meters high located in a screen room. The power lines of the system were isolated from the power source using a standard LISN with a 50-µHy choke. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor internal to the LISN. The LISN was positioned on the floor beneath the wooden bench supporting the EUT. The power lines and cables were draped over the back edge of the table. Refer to diagram one showing typical test arrangement and photographs in exhibits for EUT placement used during testing.

Radiated Emission Test Procedure

Radiated emissions testing was performed as required in 47 CFR 15C, RSS-210 Issue 10, and specified in ANSI C63.10-2013. The EUT was placed on a rotating 0.9 x 1.2-meter platform, elevated as required above the ground plane at a distance of 3 meters from the FSM antenna. EMI energy was maximized by equipment placement permitting orientation in three orthogonal axes, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken and recorded. The frequency spectrum from 9 kHz to 25,000 MHz was searched for emissions during preliminary investigation. Refer to diagrams two and three showing typical test setup. Refer to photographs in the test setup exhibits for specific EUT placement during testing.










Diagram 4 Test arrangement for Antenna Port Conducted emissions

Antenna Requirements

The EUT incorporates integral chip antenna system. Production equipment offers no provision for connection to alternate antenna system. The antenna connection point complies with the unique antenna connection requirements. There are no deviations or exceptions to the specification.

Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and receiver / spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worstcase data presented below. Test procedures of ANSI C63.10-2013 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values consider the received radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

AC Line Conducted EMI Procedure

The EUT was arranged in typical equipment configurations operating from AC power adapter. Testing was performed with the EUT placed on a 1 x 1.5-meter wooden bench 80 cm above the conducting ground plane, floor of a screen room. The bench was positioned 40 cm away from the wall of the screen room. The LISN was positioned on the floor of the screen room 80-cm from the rear of the EUT. Testing for the line-conducted emissions were the procedures of ANSI C63.10-2013 paragraph 6. The AC power source for the EUT was connected to the LISN for line-conducted emissions testing. A second LISN was positioned on the floor of the screen room 80-cm from the rear of the supporting equipment of the EUT. All power cords except the EUT were then powered from the second LISN. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor, internal to the LISN. Power line conducted emissions testing was carried out individually for each current carrying conductor of the EUT. The excess length of lead between the system and the LISN receptacle was folded back and forth to form a bundle not exceeding 40 cm in length. The screen room, conducting ground plane, analyzer, and LISN were bonded together to the protective earth ground. Preliminary testing was performed to identify the frequencies of each of the emissions, which demonstrated the highest amplitudes. The cables were repositioned to obtain maximum amplitude of measured EMI level. Once the worst-case configuration was identified, plots were made of the EMI from 0.15 MHz to 30 MHz then data was recorded with maximum conducted emissions levels.




Figure 1 AC Line Conducted emissions of EUT line 1 (Configuration #2, EUT – Computer)




Figure 2 AC Line Conducted emissions of EUT line 2 (Configuration #2, EUT – Computer)




Figure 3 AC Line Conducted emissions of EUT line 1 (Configuration #3, EUT – 362-00087-00)




Figure 4 AC Line Conducted emissions of EUT line 2 (Configuration #3, EUT – 362-00087-00)

General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available mode during testing. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated measurements were performed. Final data was taken with the EUT located on the OATS at 3 meters distance between the EUT and the receiving antenna. The frequency spectrum from 9 kHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Loop from 9 kHz to 30 MHz, Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or double Ridge or pyramidal horns and mixers above 1 GHz, notch filters and appropriate amplifiers and external mixers were utilized.

Operation in the Band 2400 - 2483.5 MHz

The transmitter output power; harmonic and general emissions were measured on an open area test site @ 3 meters. The EUT was placed on a turntable elevated as required above the ground plane and at a distance of 3 meters from the FSM antenna. The peak and quasi-peak amplitude of frequencies below 1000 MHz were measured using a spectrum analyzer. The peak and average amplitude of frequencies above 1000 MHz were measured using a spectrum analyzer. The amplitude of each emission was then recorded from the analyzer display. 


Figure 5 Plot of Transmitter Emissions Operation in 2402-2480 MHz Mode 1 ANT (GFSK)




Figure 6 Plot of Transmitter Emissions Low Band Edge Mode 1 ANT (GFSK)




Figure 7 Plot of Transmitter Emissions High Band Edge Mode 1 ANT (GFSK)




Figure 8 Plot of Transmitter Emissions 99% Occupied Bandwidth Mode 1 ANT (GFSK)




Figure 9 Plot of Transmitter Emissions Operation in 2402-2480 MHz Mode 2 BLE (GMSK)




Figure 10 Plot of Transmitter Emissions Low Band Edge Mode 2 BLE (GMSK)




Figure 11 Plot of Transmitter Emissions High Band Edge Mode 2 BLE (GMSK)




Figure 12 Plot of Transmitter Emissions 99% Occupied Bandwidth Mode 2 BLE (GMSK)
