


Figure 2 - Radiated Emissions Test Setup




Figure 3 - Duty Cycle

Test procedures:

a. The EUT was placed on the top of a rotating table above the ground plane in a 10 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation. The table was 0.8m high for measurements from 30MHz-1Ghz and 1.5m for measurements from 1GHz and higher.

- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna was a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are used to make the measurement.
- d. For each suspected emission, the EUT was arranged to maximize its emissions and then the antenna height was varied from 1 meter to 4 meters and the rotating table was turned from 0 degrees to 360 degrees to find the maximum emission reading.
- e. The test-receiver system was set to use a peak detector with a specified resolution bandwidth. For spectrum analyzer measurements, the composite maximum of several analyzer sweeps was used for final measurements.
- f. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
- g. The EUT was maximized in all 3 orthogonal positions. The results are presented for the axis that had the highest emissions.




Figure 4 - Radiated Emissions Test Setup




Figure 5 - Radiated Emissions Plot, Receive




Figure 6 - Radiated Emissions Plot, BT EDR 2MB

4.5 CONDUCTED SPURIOUS EMISSIONS

Test Method: ANSI C63.10-2013, Section 7.8.8

Limits of spurious emissions:

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in § 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in § 15.205(a), must also comply with the radiated emission limits specified in § 15.209(a) (see § 15.205(c)).




Figure 8 - Radiated Emissions Plot, 2EDR, 30M - 1G




Figure 9 - Radiated Emissions Plot, 2EDR, 1G - 3.6G




Figure 10 - Radiated Emissions Plot, 2EDR, 3.6G - 25G




Figure 11 - Radiated Emissions Plot, 3EDR, 30M - 1G




Figure 12 - Radiated Emissions Plot, 3EDR, 1G - 3.6G




Figure 13 - Radiated Emissions Plot, 3EDR, 3.6G - 25G




Figure 14 - Conducted Emissions Plot, Line, TX




Figure 16 - Conducted Emissions Plot, Line, IDLE

APPENDIX A: SAMPLE CALCULATION

Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$FS = RA + AF - (-CF + AG) + AV$$

where FS = Field Strength

RA = Receiver Amplitude

AF = Antenna Factor

CF = Cable Attenuation Factor

AG = Amplifier Gain

AV = Averaging Factor (if applicable)

Assume a receiver reading of 55 dB μ V is obtained. The Antenna Factor of 12 and a Cable Factor of 1.1 is added. The Amplifier Gain of 20 dB is subtracted, giving a field strength of 48.1 dB μ V/m.

$$FS = 55 + 12 - (-1.1 + 20) + 0 = 48.1 \text{ dB}\mu\text{V/m}$$

The 48.1 dBμV/m value can be mathematically converted to its corresponding level in μV/m.

Level in $\mu V/m = Common Antilogarithm [(48.1 dB<math>\mu V/m)/20$]= 254.1 $\mu V/m$

AV is calculated by the taking the $20*log(T_{on}/100)$ where T_{on} is the maximum transmission time in any 100ms window.




15 Power, Mid Channel, 3EDR




16 Power, High Channel, 3EDR








20 PSD, Low Channel, 3EDR




21 PSD, Mid Channel, 3EDR






