- 15.247 (a) (2) Systems using digital modulation techniques may operate in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.
- (b) The maximum peak conducted output power of the intentional radiator shall not exceed the following:
- (3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one-Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.
- (d) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).
- (e) For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

5.2 Digital transmission systems

DTSs include systems that employ digital modulation techniques resulting in spectral characteristics similar to direct sequence systems. The following applies to the bands 902-928 MHz and 2400-2483.5 MHz

a) The minimum 6 dB bandwidth shall be 500 kHz.

b)The transmitter power spectral density conducted from the transmitter to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of section 5.4(d),(i.e. the power spectral density shall be determined using the same method as is used to determine the conducted output power).

5.4 Transmitter output power and equivalent isotropically radiated power (e.i.r.p.) requirements d) For DTSs employing digital modulation techniques operating in the bands 902-928 MHz and 2400-2483.5 MHz, the maximum peak conducted output power shall not exceed 1W. The e.i.r.p. shall not exceed 4 W, except as provided in section 5.4(e).

5.5 Unwanted emissions

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under section 5.4(d), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

Equipment Function

The E3545 is a device incorporating Wi-Fi, BLE, and ANT wireless transmission via a MEDIATEK Inc. MT6630QN transceiver. It is powered externally by 9-16V DC power. The antenna is a PCB inverted F with a 2dbi gain. The Wi-Fi radio uses the 2.4 GHz band (2412 – 2462MHz). The ANT radio operates in the 2.4 GHz band using (2402 – 2480 MHz). The BLE radio operates in the 2.4 GHz Band using (2402 – 2480 MHz). Two samples were provided for testing, one representative of production design, and the other modified for testing purposes replacing the integral 2.4 GHz antenna with 50-ohm RF connection port. The test samples were provided with test software enabling testing personnel the ability to enable transmitter functions on defined modulations and channels. The test software enabled near 100% transmit duty cycle for testing purposes. The antenna modification offered testing facility the ability to connect test equipment to the temporary 2.4 GHz antenna port. The EUT was arranged as described by the manufacturer emulating typical user configuration for testing purposes. For testing purposes, the EUT received power from external direct current power supply and configured to operate in available modes. As requested by the manufacturer and required by regulations, the equipment was tested for compliance using the available configurations with the worst-case data presented. Test results in this report relate only to the products described in this report.



Applicable Standards & Test Procedures

The following information is submitted in accordance with the eCFR Title 47 Federal Communications Code of Federal Regulations (47 CFR), dated August 6, 2019, Part 2, Subpart J, Paragraphs 2.907, 2.911, 2.913, 2.925, 2.926, 2.1031 through 2.1057, and applicable parts of paragraph 15, Part 15C Paragraph 15.247, and Industry Canada RSS-GEN Issue 5, and RSS-247 Issue 2. Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in ANSI C63.10-2013. This report documents compliance for the EUT operations as Digital Transmission Systems operation.

Testing Procedures

AC Line Conducted Emission Test Procedure

The EUT operates on direct current power only provided by the aircraft installation. Therefore, no AC line conducted emission testing was required or performed.

Radiated Emission Test Procedure

Radiated emissions testing was performed as required in 47 CFR 15C, RSS-210 and specified in ANSI C63.10-2013. The EUT was placed on a rotating 0.9 x 1.2-meter platform, elevated as required above the ground plane at a distance of 3 meters from the FSM antenna. EMI energy was maximized by equipment placement permitting orientation in three orthogonal axes, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken and recorded. The frequency spectrum from 9 kHz to 25,000 MHz was searched for emissions during preliminary investigation. Refer to diagrams one and two showing typical test setup. Refer to photographs in the test setup exhibits for specific EUT placement during testing.

Antenna Port Conducted Emission Test Procedure

The EUT was assembled as required for operation placed on a benchtop. This configuration provided the ability to connect test equipment to the provided test antenna port. Antenna Port conducted emissions testing was performed presented in the regulations and specified in ANSI C63.10-2013. Testing was completed on a laboratory bench in a shielded room. The active antenna port of the device was connected to appropriate attenuation and the spectrum analyzer. 


Diagram 1 Test arrangement for radiated emissions of tabletop equipment




Diagram 3 Test arrangement for Antenna Port Conducted emissions

Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worst-case data presented below. Test procedures of ANSI C63.10-2013 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values consider the received radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

Summary of Results for Radiated Emissions in Restricted Bands

The EUT demonstrated compliance with the radiated emissions requirements of 47 CFR Part 15C RSS-Gen, and RSS-247 Intentional Radiators. The EUT worst-case BT and Wi-Fi operations demonstrated a minimum radiated emission margin of -9.3 dB below the requirements in restricted frequency bands. General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available mode during testing. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated measurements were performed. Final data was taken with the EUT located on the OATS at 3 meters distance between the EUT and the receiving antenna. The frequency spectrum from 9 kHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Loop from 9 kHz to 30 MHz, Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or double Ridge or pyramidal horns and mixers above 1 GHz, notch filters and appropriate amplifiers and external mixers were utilized.

Operation in the Band 2400 – 2483.5 MHz

Test procedures of ANSI C63.10-2013 paragraph 6, and KDB 558074 were used during transmitter testing. Test sample #2 was provided for testing antenna port conducted emissions. This sample was modified by replacing the internal antenna with a 50-ohm antenna port connector and attenuator for testing purposes. The transmitter peak and average power was measured at the antenna port using a wideband RF power meter as described in KDB 558074 and ANSI C63.10-2013. Average power measured did not include any time intervals during which the transmitter was off or transmitting at a reduced power level. The peak Power Spectral Density (PKPSD) was measured as defined in KDB 558074 and ANSI C63.10-2013. DTS Emission bandwidth was measured as described in KDB 558074 and ANSI C63.10-2013. The amplitude of each harmonic and general radiated emission was measured on the OATS at distance of 3 meters from the FSM antenna (radiated emission testing was performed on sample #1 representative of production equipment with integral antenna). The EUT was positioned on supporting turntable elevated as required above the ground plane, at a distance of 3 meters from the FSM antenna. Radiated emission investigations were performed from 9 kHz to 25,000 MHz. Each radiated emission was maximized by varying the FSM antenna height and polarization, and by rotating the turntable. The worst-case amplitude of each emission was then recorded from the analyzer display. The peak and quasi-peak amplitude of frequencies below 1000 MHz were measured using a spectrum analyzer. The peak and average amplitude of frequencies above 1000 MHZ were measured using a spectrum analyzer. A Loop antenna was used for measuring emissions from 0.009 to 30 MHz, Biconilog Antenna for 30 to 1000 MHz, Double-Ridge, and/or Pyramidal Horn Antennas from 1 GHz to 25 GHz. Radiated Emissions were measured in dBμV/m @ 3 meters. Plots were taken of transmitter performance (using sample #2) for reference in this and other documentation.




Figure 1 Plot of Transmitter Operation in 2402-2480 MHz (Mode 2 BLE (GMSK))




Figure 2 Plot of Transmitter Operation in 2412-2462 MHz (Mode 3 802.11b)




Figure 3 Plot of Transmitter Operation in 2412-2462 MHz (Mode 4 802.11g)




Figure 4 Plot of Transmitter Operation in 2412-2462 MHz (Mode 5 802.11n)




Figure 5 Plot of Transmitter Emissions Low Band Edge (Mode 2 BLE (GMSK))




Figure 6 Plot of Transmitter Emissions Low Band Edge (Mode 3 802.11b)




Figure 7 Plot of Transmitter Emissions Low Band Edge (Mode 4 802.11g)




Figure 8 Plot of Transmitter Emissions Low Band Edge (Mode 5 802.11n)




Figure 9 Plot of Transmitter Emissions High Band Edge (Mode 2 BLE (GMSK))




Figure 10 Plot of Transmitter Emissions High Band Edge (Mode 3 802.11b)




Figure 11 Plot of Transmitter Emissions High Band Edge (Mode 4 802.11g)




Figure 12 Plot of Transmitter Emissions High Band Edge (Mode 5 802.11n)




Figure 14 Plot of 99% Occupied Bandwidth (Mode 2 BLE (GMSK))




Figure 15 Plot of 6-dB Occupied Bandwidth (Mode 3 802.11b)




Figure 16 Plot of 99% Occupied Bandwidth (Mode 3 802.11b)




Figure 17 Plot of 6-dB Occupied Bandwidth (Mode 4 802.11g)




Figure 18 Plot of 99% Occupied Bandwidth (Mode 4 802.11g)




Figure 19 Plot of 6-dB Occupied Bandwidth (Mode 5 802.11n)




Figure 20 Plot of 99% Occupied Bandwidth (Mode 5 802.11n)




Figure 21 Plot of Transmitter Power Spectral Density (Mode 2 BLE (GMSK))




Figure 22 Plot of Transmitter Power Spectral Density (Mode 3 802.11b)




Figure 23 Plot of Transmitter Power Spectral Density (Mode 4 802.11g)




Figure 24 Plot of Transmitter Power Spectral Density (Mode 5 802.11n)
