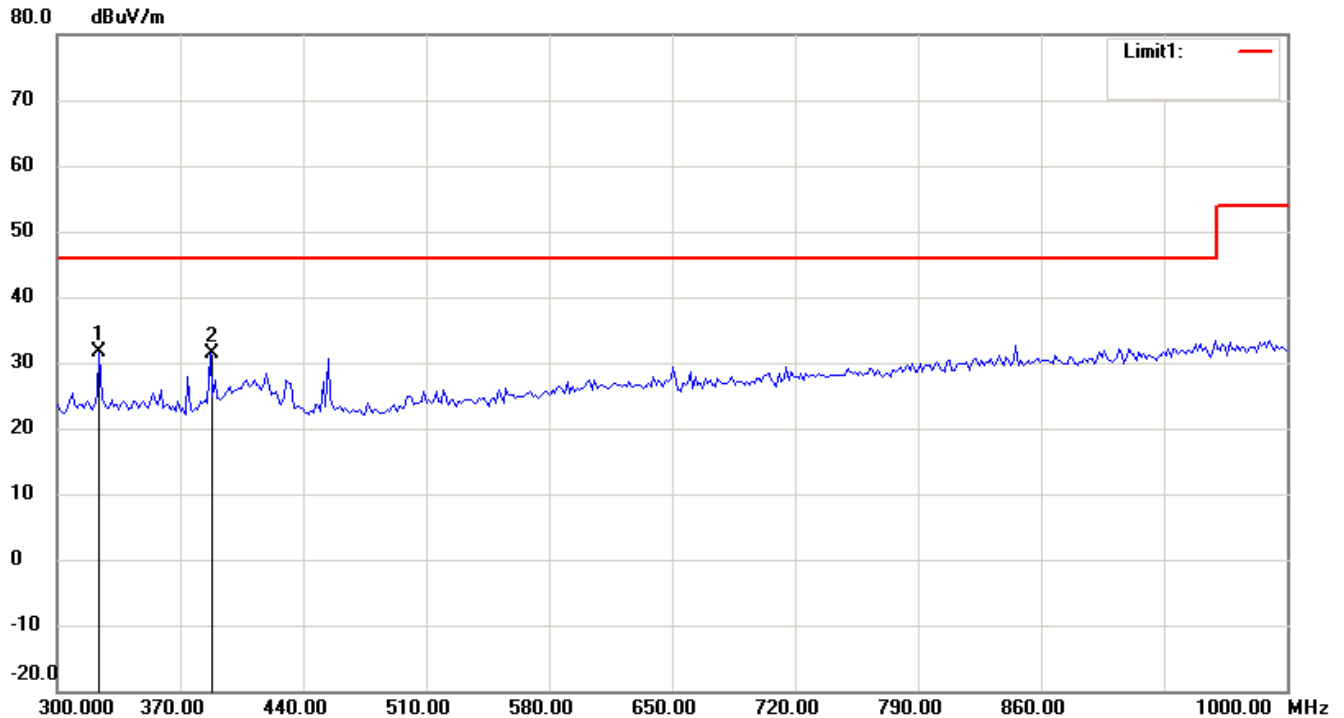
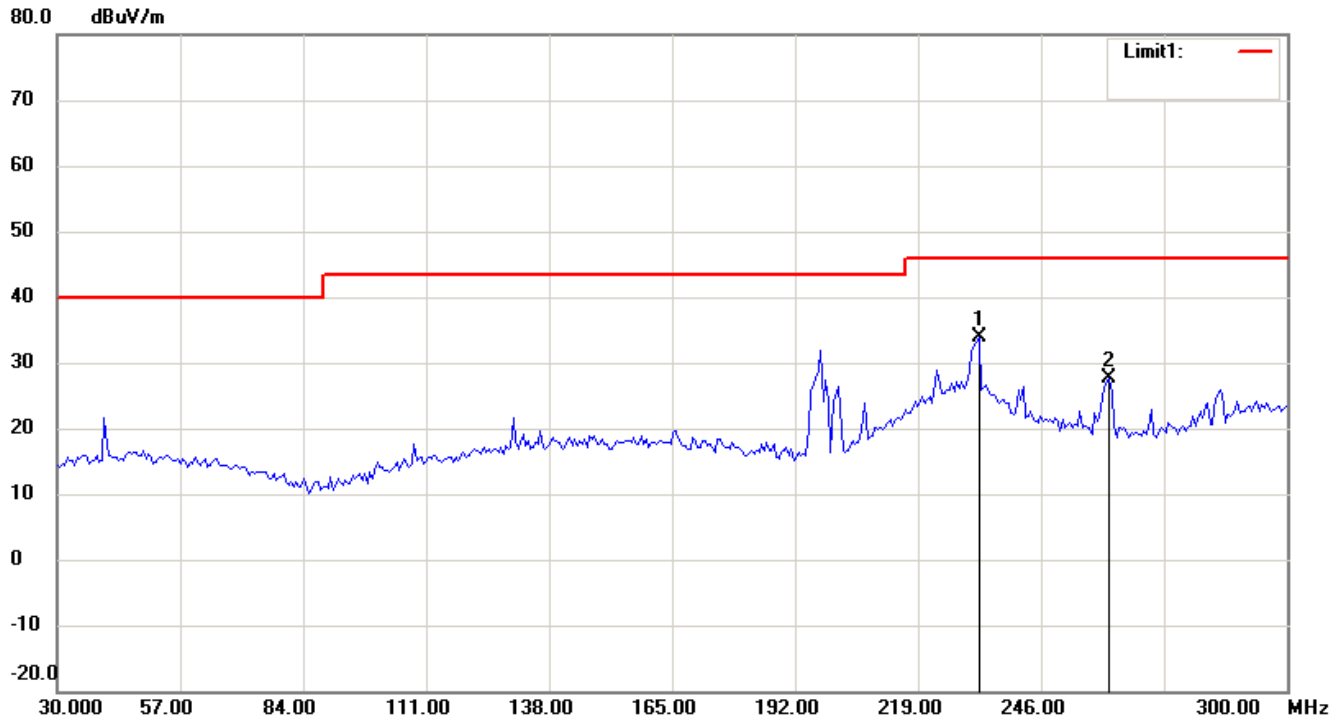

Spurious Emissions radiated ANT A_TX 802.11a 5745MHz Antenna Polarization H



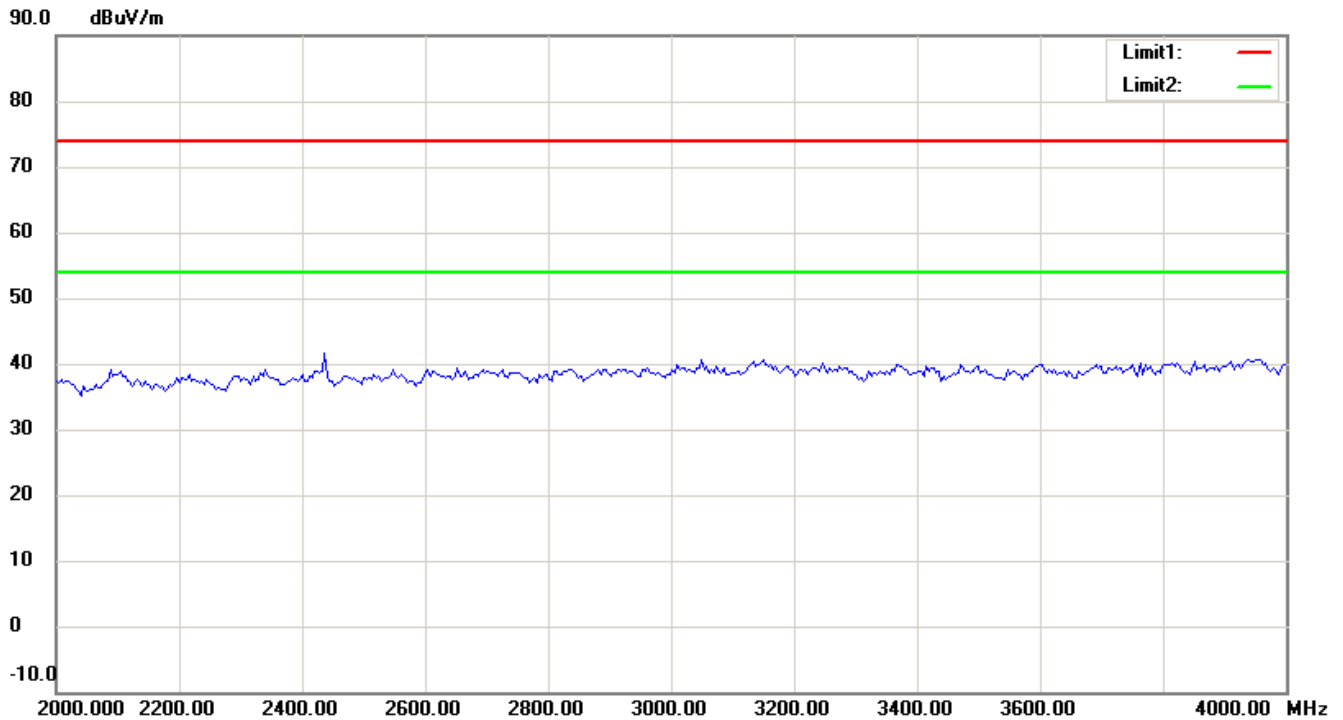
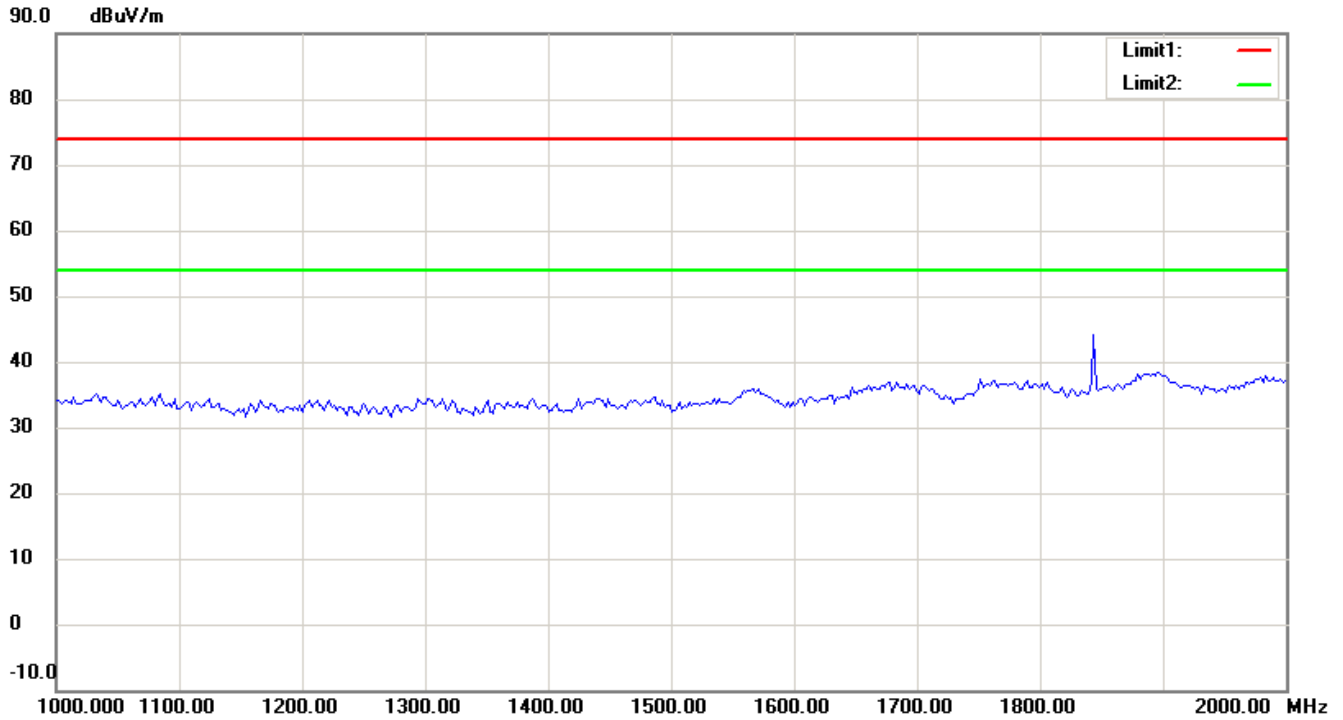
