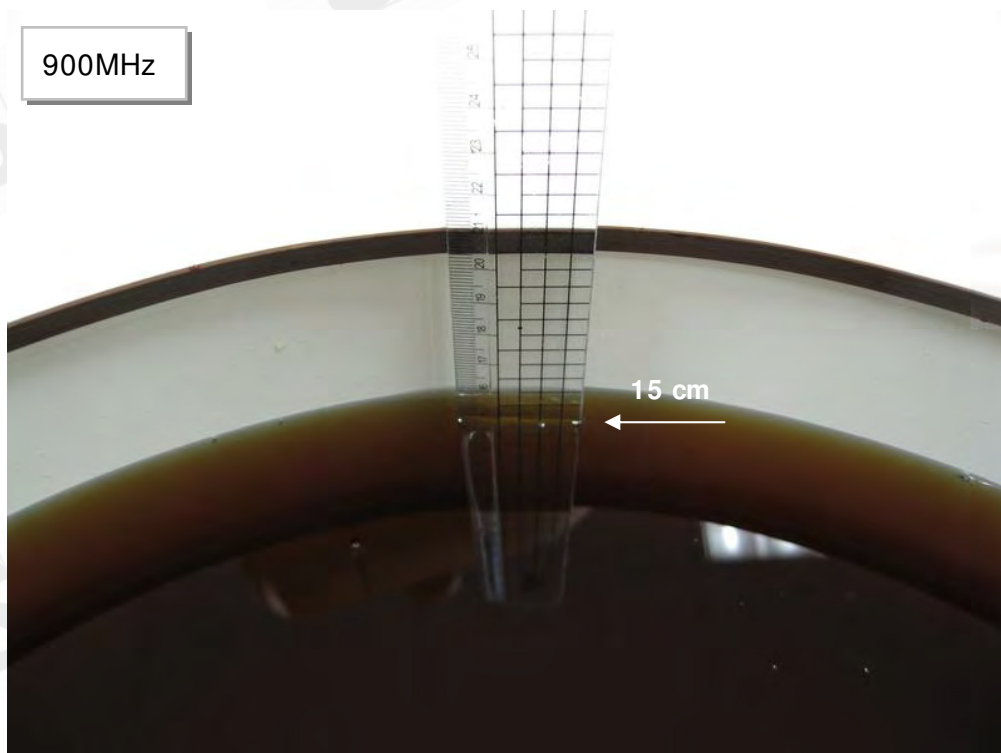

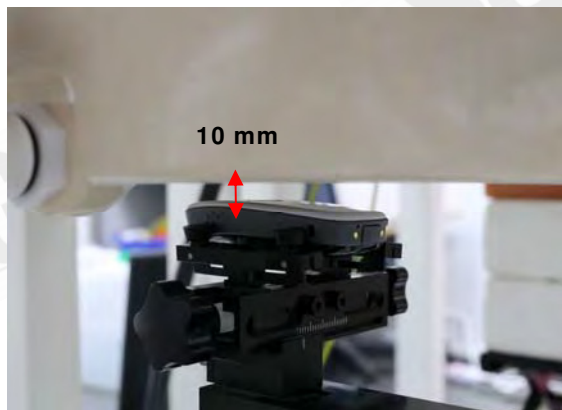


Fig.3 EUT Front side to flat phantom

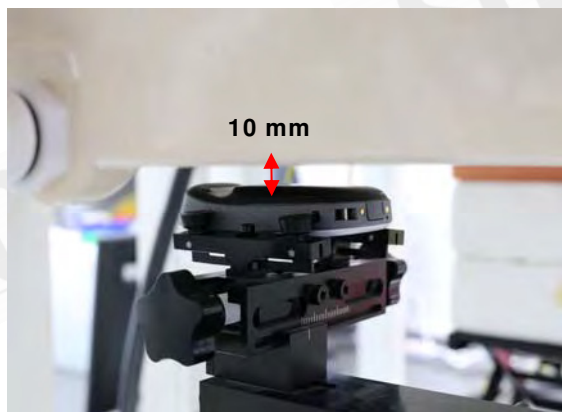


Fig.4 EUT Back side to flat phantom

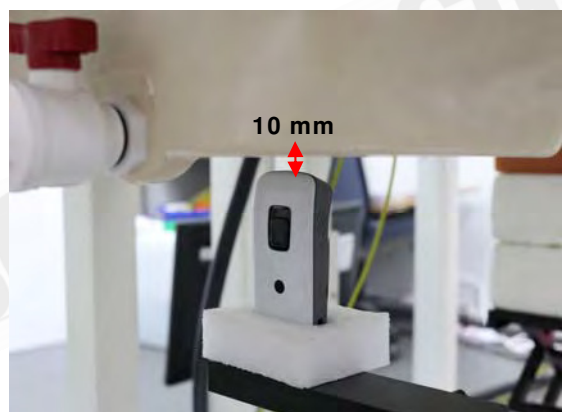
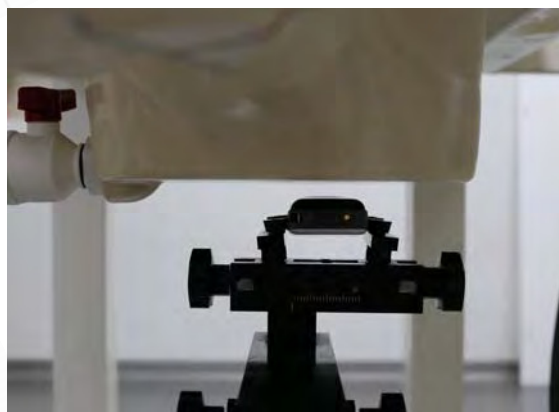


Fig.5 EUT Top side to flat phantom

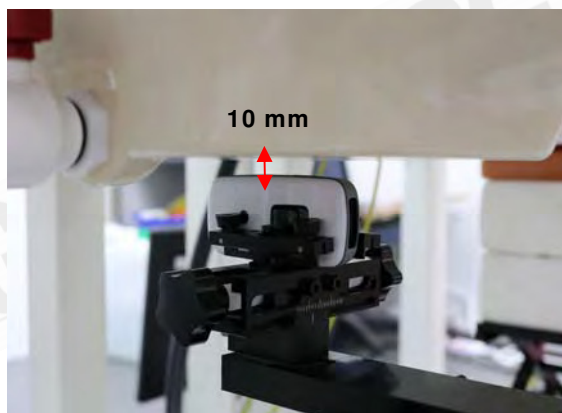


Fig.6 EUT Left side to flat phantom

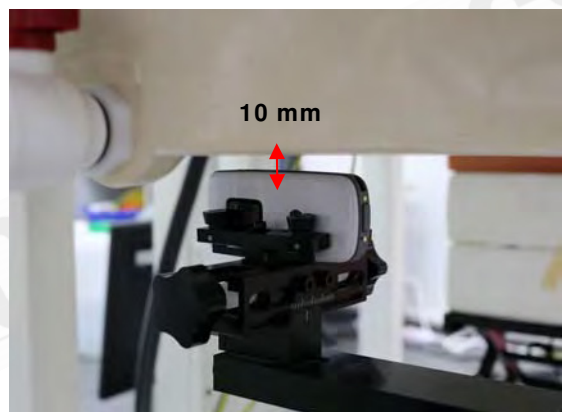


Fig.7 EUT Right side to flat phantom

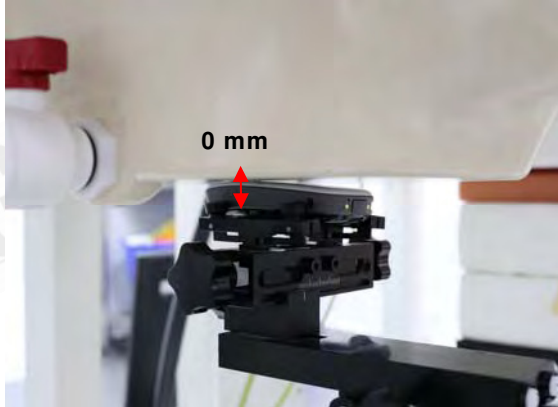


Fig.8 EUT Front side mode to flat phantom

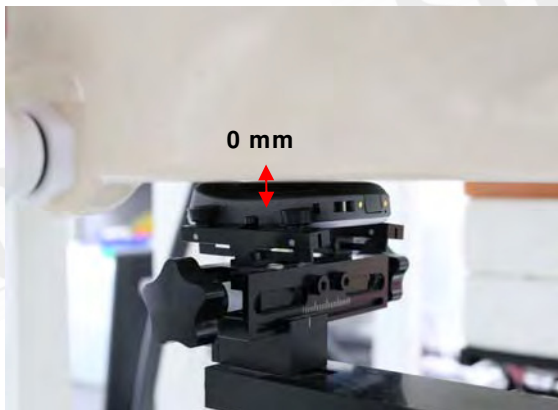
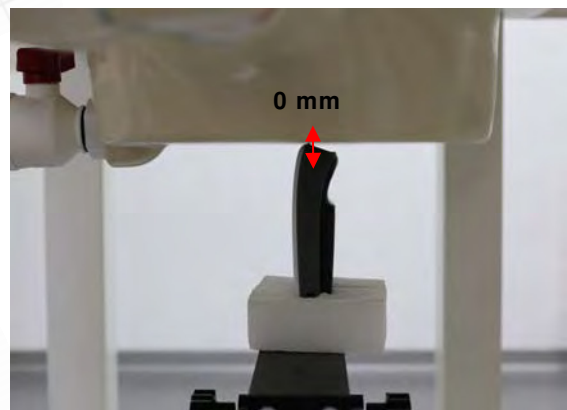


Fig.9 EUT Back side to flat phantom

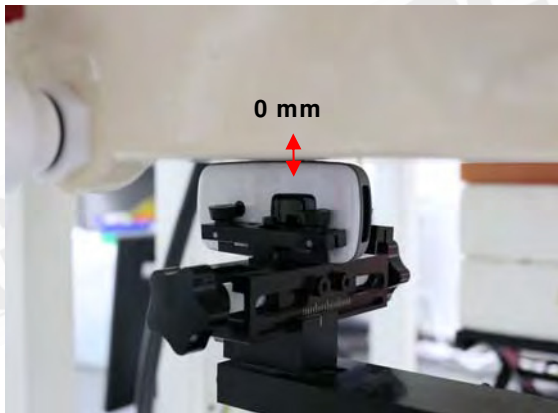


Fig11 EUT Left side to flat phantom

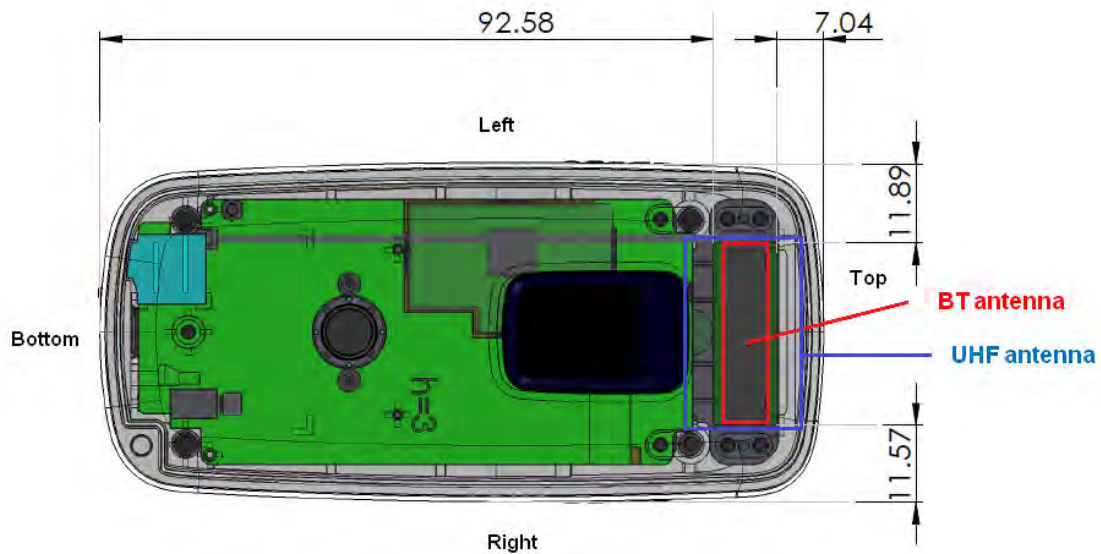


Fig.15 Antenna location (front view)
