This letter is to request Single Modular Approval in accordance with under FCC Rule Part 15.212(a)(1) for certification request under FCC ID: IXLPRDI4IC. This product is an RFID Card Reader and can be used in devices requiring ID data from RFID cards for use by the said device into which it is incorporated.

Declaration of conditions.

Y	(i) The radio elements of the module have their own shielding. The physical crystal and tuning capacitors may be located external to the shielded radio elements
Y	(ii) The module has buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with part 15 requirements under conditions of excessive data rates or over-modulation.
Y	(iii) The module has its own power supply regulation.
Y	(iv) The module complies with the antenna and transmission system requirements of §§15.203, 15.204(b) and 15.204(c). The antenna(s) are either permanently attached or employ a “unique” antenna coupler (at all connections between the module and the antenna, including the cable).
Y	(v) The module was tested in a stand-alone configuration, i.e., the module was not inside another device during testing for compliance with part 15 requirements. Unless the transmitter module will be battery powered, it complies with the AC line conducted requirements found in §15.207. Any accessories, peripherals, or support equipment connected to the module during testing were unmodified and commercially available (see §15.31(i)).
