

USI WLAN CF Card 802.11b 2.4GHz Quick Start Guide



Install the Driver

To install the driver and utility on your Pocket PC from the software and documentation CD:

- Using your sync cable or cradle, connect your Pocket PC to the computer. For additional information, see the documentation that came with your Pocket PC.
- 2. Insert the software and documentation CD into the drive on the computer.
- 3. Using Microsoft Windows Explorer or My Computer, navigate to **x:\Setup**, where **x** is the CD drive letter.
- 4. Double-click setup.exe.
- 5. Follow the instructions on the computer screen to finish the installation.
- Insert the USI WLAN CF Card into the CF Card slot on your PocketPC.

Configure the Wireless Network

To configure the wireless network in a PocketPC environment:

- 1. Tap Start → Settings → System tab.
- 2. Tap the USI WLAN CF Card icon to run the Wireless Networking Setting utility.
