## **GENERAL INFORMATION**

#### **Product Description for Equipment under Test (EUT)**

The *Hobbico, Inc.'s* product, model number: *TTX600 mode 1 and TTX600 mode 2 (FCC ID: IYFTTX600 )* or the "EUT" as referred to in this report is a 2.4*GHz FHSS TRANSMITTER*, which measures approximately: 18.4 cm (L) x 7.6 cm (W) x 19.7 cm (H), rated input voltage: DC 6.0 V battery.

Frequency Range: 2403-2480 MHz (TX/RX)

Modulation Mode: FHSS

Transmitter Output Power:  $\leq 20 \text{ dBm}$ 

Note: The model *TTX600 mode 1 and TTX600 mode 2*, they are electrically identical, only button placement is different, which were explained in the attached declaration letter.

All measurement and test data in this report was gathered from production sample serial number: 1011030 (Assigned by BACL, Shenzhen). The EUT was received on 2010-11-05.

#### Objective

This Type approval report is prepared on behalf of *Hobbico, Inc* in accordance with Part 2, Subpart J, Part 15, Subparts A, B and C of the Federal Communication Commissions rules.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, and section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.





#### **Result:**

The predicted power density level at 20 cm is  $0.015 \text{ mw/cm}^2$  which is below the uncontrolled exposure limit of  $1.0 \text{ mw/cm}^2$ , The EUT is used at least 20 cm away from user's body. It is determined as mobile equipment and complies with the MPE limit.

## FCC §15.203 - ANTENNA REQUIREMENT

#### **Applicable Standard**

According to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. The structure and application of the EUT were analyzed to determine compliance with section §15.203 of the rules. §15.203 state that the subject device must meet the following criteria: a. Antenna must be permanently attached to the unit.

b. Antenna must use a unique type of connector to attach to the EUT.

Unit must be professionally installed, and installer shall be responsible for verifying that the correct antenna is employed with the unit.

And according to FCC 47 CFR section 15.247 (b), if the transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

#### **Antenna Connector Construction**

The EUT has a integral antennas, the gain is 2.0 dBi, which in accordance to section 15.203, please refer to the internal photos.



#### **Measurement Uncertainty**

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on NIS 81, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at Bay Area Compliance Laboratories Corp. (Shenzhen) is  $\pm 4.0 \text{ dB}$  (k=2, 95% level of confidence).

#### **EUT Setup**



The radiated emission tests were performed in the 3 meters, using the setup accordance with the ANSI C63.4-2009. The specification used was the FCC 15.209, and FCC 15.247 limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

## EMI Test Receiver & Spectrum Analyzer Setup

The system was investigated from 30 MHz to 25 GHz.

#### **Test Procedure**

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz-1GHz and peak and Average detection modes for frequencies above 1GHz.

#### **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "**Margin**" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude




#### Low Channel

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT on the test table without connection to measurement instrument. Turn on the EUT. Then set it to any one convenient frequency within its operating range. Set a reference level on the measuring instrument equal to the highest peak value.
- 3. Measure the frequency difference of two frequencies that were attenuated 20 dB from the reference level. Record the frequency difference as the emission bandwidth.
- 4. Repeat above procedures until all frequencies measured were complete.







## FCC §15.247(a) (1) (iii) - QUANTITY OF HOPPING CHANNEL TEST

#### **Applicable Standard**

Frequency hopping systems in the 2400–2483.5 MHz band shall use at least 15 channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 channels are used.






#### Low Channel




