

# **MPE Calculation**

§ 1.1310: The criteria listed in table 1 shall be used to evaluate the environmental impact of human exposure to radiofrequency (RF) radiation as specified in §1.1307(b), except in the case of portable devices which shall be evaluated according to the provisions of §2.1093 of this chapter.

 NOTE 1 TO TABLE 1: Occupational/controlled limits apply in situations in which persons are exposed as a consequence of their employment provided those persons are fully aware of the potential for exposure and can exercise control over their exposure. Limits for occupational/controlled exposure also apply in situations when an individual is transient through a location where occupational/controlled limits apply provided he or she is made aware of the potential for exposure.

NOTE 2 TO TABLE 1: General population/uncontrolled exposures apply in situations in which the general public may be exposed, or in which persons that are exposed as a consequence of their employment may not be fully aware of the potential for exposure or can not exercise control over their exposure.

# Table 4: RF Field Strength Limits for Devices Used by the General Public (Uncontrolled Environment)

## 1.1 Test Procedure

An MPE evaluation for was performed in order to show that the device was compliant with §2.1091. The maximum power density was calculated for each transmitter at a separation distance of 20cm.

For each transmitter the maximum RF exposure at a 20 cm distance using the formula:  $ConductedPower_{mW} = 10^{ConductedPower(dBm)/10}$ 

 $PowerDensity = \frac{ConductedPower_{mW} \times Ant.Gain}{4\pi \times (20_{cm})^2}$

### 1.2 Results:

- Maximum Conducted Output Power = 2.829dbm = 1.918mW
- Maximum Antenna Gain = 3.25dbi (CBL-EMWQU-A Antenna)

Power Density = (1.918mW x 3.25dbi) / 5025.6

Power Density =  $0.001 \text{mW/cm}^2$ 

Limit at 2.4GHz = 1mW/cm<sup>2</sup>

RSS-102 Issue 5 Exposure Limit at 2.4GHz = 5.35W/m<sup>2</sup>

Power Density = 0.01W/m<sup>2</sup>

The calculated maximum power density at 20cm distance is less that the limit for general population / uncontrolled exposure.
