Note 2: Throughout these test procedures an additional 1 dB has been added to the amplitude of the test transmission waveforms to account for variations in measurement equipment. This will ensure that the test signal is at or above the detection threshold level to trigger a DFS response.

Note3: EIRP is based on the highest antenna gain. For MIMO devices refer to KDB Publication 662911 D01.

Note 2: The Channel Closing Transmission Time is comprised of 200 milliseconds starting at the beginning of the Channel Move Time plus any additional intermittent control signals required to facilitate a Channel move (an aggregate of 60 milliseconds) during the remainder of the 10 second period. The aggregate duration of control signals will not count quiet periods in between transmissions.

Note 3: During the U-NII Detection Bandwidth detection test, radar type 0 should be used. For each frequency step the minimum percentage of detection is 90 percent. Measurements are performed with no data traffic.



## **Parameters of DFS Test Signals**

Step intervals of 0.1 microsecond for Pulse Width, 1 microsecond for PRI, 1 MHz for chirp width and 1 for the number of pulses will be utilized for the random determination of specific test waveforms.

Three subsets of trials will be performed with a minimum of ten trials per subset. The subset of trials differ in where the Long Pulse Type 5 Signal is tuned in frequency.

- a) the Channel center frequency
- b) tuned frequencies such that 90% of the Long Pulse Type 5 frequency modulation is within the low edge of the EUT Occupied Bandwidth




#### 5. Test Procedure

### 5.1 DFS Measurement System

A complete DFS Measurement System consists of Radar signal generate system to generating the radar waveforms in Table 10, 11 and 12. The traffic monitoring system is specified to the type of unit under test (EUT).

## **Conducted Setup Configuration of DFS Measurement System**



### **Channel Loading**

System testing will be performed with channel-loading using means appropriate to the data types that are used by the unlicensed device. The following requirements apply:


a)	The data file must be of a type that is typical for the device (i.e., MPEG-2, MPEG-4, WAV, MP3, MP4, AVI, etc.) and must generally be transmitting in a streaming mode.	
b)	Software to ping the client is permitted to simulate data transfer but must have random ping intervals.	
c)	Timing plots are required with calculations demonstrating a minimum channel loading of approximately 17% or greater.	<b>√</b>
d)	Unicast or Multicast protocols are preferable but other protocols may be used. The appropriate protocol used must be described in the test procedures.	



#### 5.2 Calibration of DFS Detection Threshold Level

The measured channel is chosen from the operating channels of the EUT within the 5.25-5.35 GHz band and the 5.47-5.725 GHz and using the all bandwidth mode available for the link. The radar signal was the same as transmitted channels, and injected into the antenna port of AP (master) or Client Device with Radar Detection, measured the channel closing transmission time and channel move time. The Master antenna gain is 0dBi and required detection threshold is -64dBm. The calibrated conducted detection threshold level is set to -60.76 dBm.

### Conducted Setup Configuration of Calibration of DFS Detection Threshold Level





The radar test signals are injected into the Master Device.


This test was investigated for different bandwidth (20/40/80/160MHz).

Radar Signal 0







Client performed with channel-loading via master.










### 6.2.4 Non-Associated Test


