


Fig. 2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig. 2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig. 4 Bottom side of the Notebook is paralleled with flat phantom, open the panel with 90 degrees, bottom side is contact with flat phantom.
