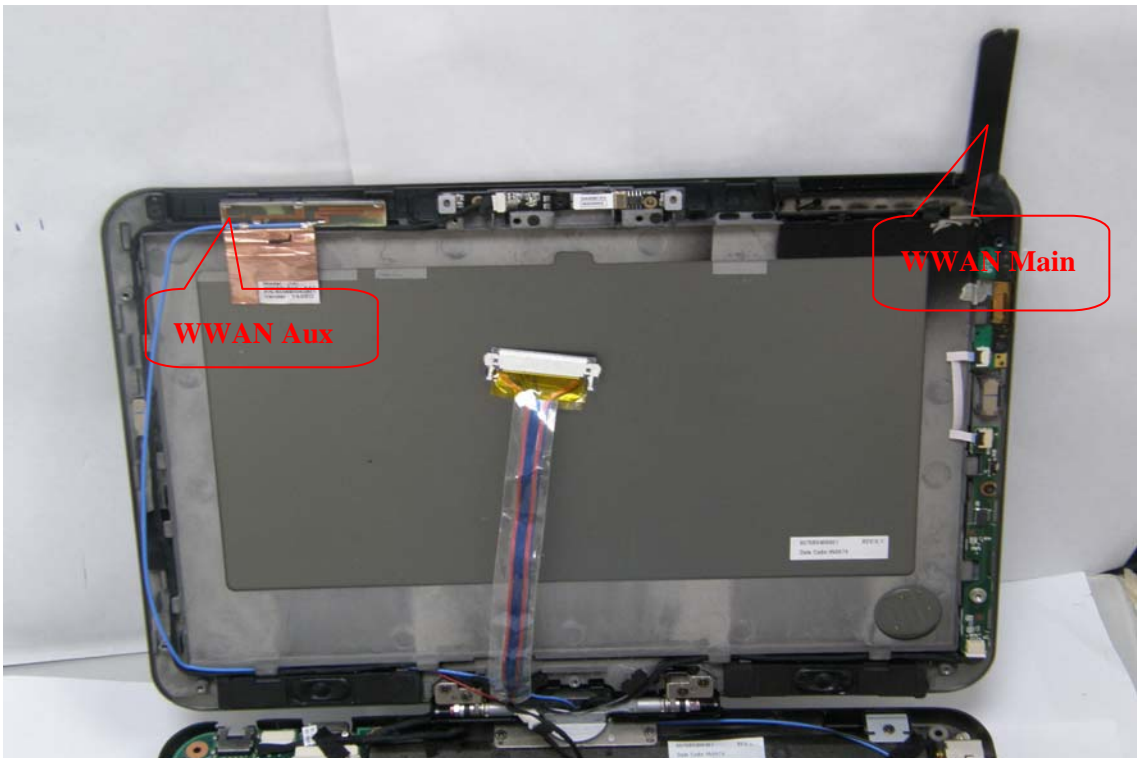

*Internal View of EUT -1 (WWAN Module)*

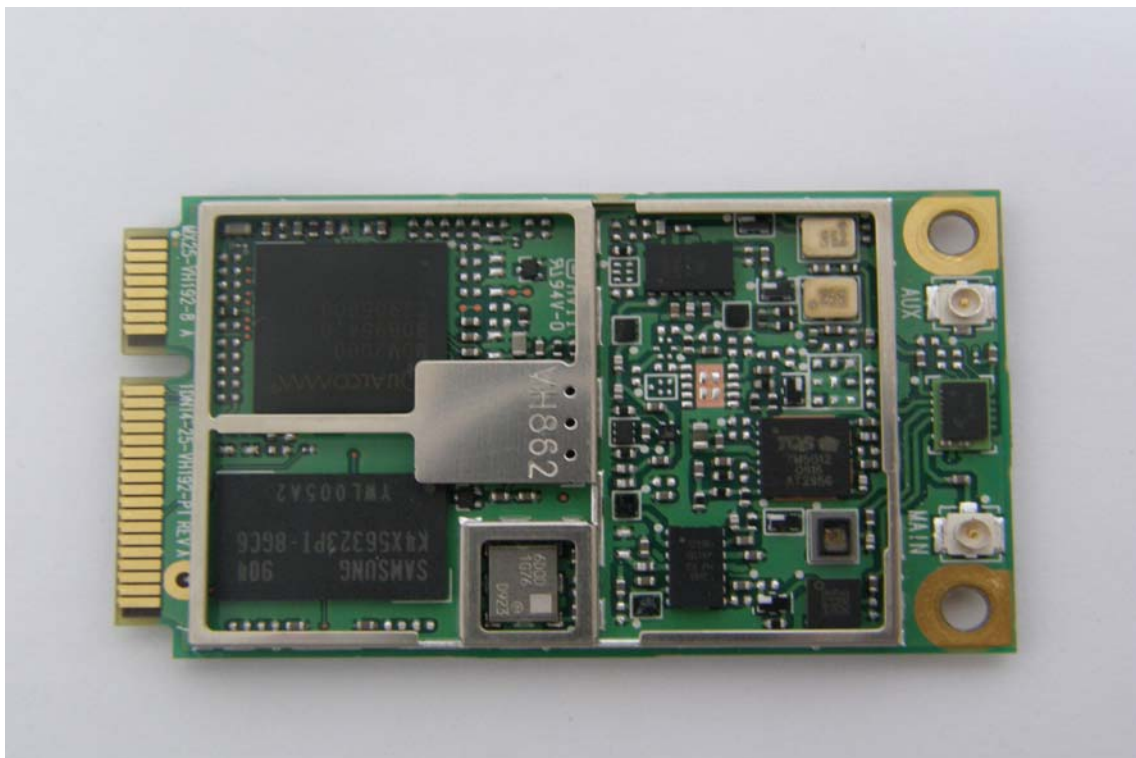

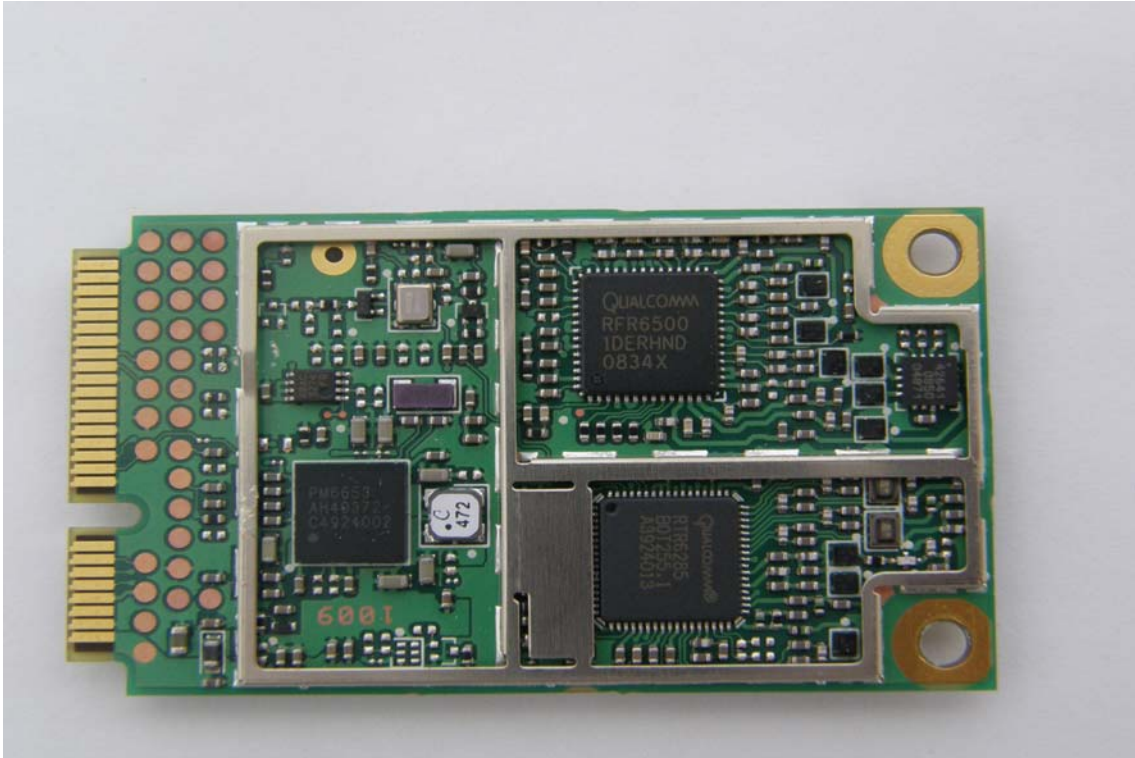
*Internal View of EUT-2 (WWAN Module)*
