Fig.1 Photograph of the SAR measurement System




Fig.2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig. 4 Bottom side of the Notebook is paralleled with flat phantom, open the panel with 90 degrees, bottom side is contact with flat phantom.
