3 TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055, 2.1057, 15.207, 15.209 and 15.247.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

(b) Except as provided in paragraphs (d) and (e), the field strength of emissions appearing within these frequency bands shall not exceed the limits shown in Section 15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in Section 15.35 apply to these measurements.



3.5 DESCRIPTION OF TEST MODES

The EUT (Model: GN-WI02GM) have been tested under operating condition.

Software used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

After verified, the worst data of radiated spurious emission recorded in the test report is from Note Book (Brand Name: HP; Model Name: CNC6000).

After verification, all tests carried out are with the worst-case test modes as shown below except radiated spurious emission below 1GHz's worst case is in normal link mode.

IEEE802.11b: Channel 1(2412MHz), Channel 6(2437MHz) and Channel 11(2462MHz) with 11Mbps higher data rate were chosen for the final testing.

IEEE802.11g: Channel 1(2412MHz), Channel 6(2437MHz) and Channel 11(2462MHz) with 54Mbps higher data rate were chosen for the final testing.

4 INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipment, which is traceable to recognized national standards.



5 FACILITIES AND ACCREDITATIONS

5.1 FACILITIES

All measurement facilities used to collect the measurement data are located at

No. 8, Jiu Ceng Ling, Jiaokeng Village, Sinhua Township, Tainan Hsien 712, Taiwan R.O.C.

The sites are constructed in conformance with the requirements of ANSI C63.7, ANSI C63.4 and CISPR Publication 22.

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

5.3 LABORATORY ACCREDITATIONS AND LISTING

The test facilities used to perform radiated and conducted emissions tests are accredited by National Voluntary Laboratory Accreditation Program for the specific scope of accreditation under Lab Code: 200627-0 to perform Electromagnetic Interference tests according to FCC PART 15 AND CISPR 22 requirements. 

- 2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
- 3. Set the spectrum analyzer as RBW = 100kHz, VBW = RBW, Span = 50MHz, Sweep = auto.
- 4. Mark the peak frequency and –6dB (upper and lower) frequency.
- 5. Repeat until all the rest channels are investigated.
- 6. Offset=Cable loss=1 dB





IEEE 802.11b mode


6dB Bandwidth (CH Low)

7.2 PEAK POWER

LIMIT

The maximum peak output power of the intentional radiator shall not exceed the following:


- 1. For systems using digital modulation in the bands of 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz: 1 watt.
- 2. Except as shown in paragraphs (b)(3) (i), (ii) and (iii) of this section, if transmitting antennas of directional gain greater than 6 dBi are used the peak output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1) or (b)(2) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.





<u>Test Plot</u> <u>IEEE 802.11b mode</u> Peak power (CH Low)





Peak power (CH Mid)


Peak power (CH High)






Peak power (CH Low)

7.3 BAND EDGES MEASUREMENT

LIMIT


According to \$15.247(d), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, In addition, radiated emissions which fall in the restricted bands, as defined in \$15.205(a), must also comply with the radiated emission limits specified in15.209(a). The spectrum plots include reference levels of 54 and 74 dBµV. It would appear that the intention of these reference levels is to demonstrate compliance with the restricted band radiated emission limits of 54 and 74 dBµV/m, i.e. field strength values and not absolute voltage levels.

- 1. The EUT is placed on a turntable, which is 0.8m above the ground plane.
- 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 3. EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission.
- 4. Set the spectrum analyzer in the following setting in order to capture the lower and upper band-edges of the emission:

(a) PEAK: RBW=VBW=1MHz / Sweep=AUTO

- (b) AVERAGE: RBW=1MHz / VBW=10Hz / Sweep=AUTO
- 5. Repeat the procedures until all the PEAK and AVERAGE versus POLARIZATION are measured.
- 6. Offset : Antenna Factor + Cable Loss Amplifier GAIN






Band Edges (IEEE 802.11b mode / CH Low)

Detector mode: Peak Polarity: Vertical




Detector mode: Average Polarity: Vertical






Detector mode: Peak Polarity: Horizontal




Detector mode: Average Polarity: Horizontal






Band Edges (IEEE 802.11b mode / CH High)

Detector mode: Peak Polarity: Vertical




Detector mode: Average Polarity: Vertical






Detector mode: Peak Polarity: Horizontal








Band Edges (IEEE 802.11g mode / CH Low)

Detector mode: Peak Polarity: Vertical




Detector mode: Average Polarity: Vertical






Detector mode: Peak Polarity: Horizontal








Band Edges (IEEE 802.11g mode / CH High)





7.4 PEAK POWER SPECTRAL DENSITY


- 1. For direct sequence systems, the peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3kHz band during any time interval of continuous transmission.
- 2. The direct sequence operating of the hybrid system, with the frequency hopping operation turned off, shall comply with the power density requirements of paragraph (d) of this section.

- 3. Record the max. reading.
- 4. Repeat the above procedure until the measurements for all frequencies are completed.
- 5. Offset=Cable loss=1 dB

Test Plot IEEE 802.11b mode CH Low



7.7 POWER LINE CONDUCTED EMISSIONS

LIMIT

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range is listed as follows:

Compliance with this provision shall be based on the measurement of the radio frequency voltage between each power line (*Live Line* and *Neutral Line*) and ground at the power terminals.

- 3. Repeat above procedures until all frequency measured were complete.




TEST RESULTS

The initial step in collecting conducted data is a spectrum analyzer peak scan of the measurement range. Significant peaks are then marked as shown on the following data page, and these signals are then quasi-peaked.

Conducted emissions (Line)


