# 3. Frequency Hopping System Requirements


# 3.1. Standard Applicable

According to FCC Part 15.247(a)(1), The system shall hop to channel frequencies that are selected at the system hopping rate from a pseudo randomly ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.


- (g) Frequency hopping spread spectrum systems are not required to employ all available hopping channels during each transmission. However, the system, consisting of both the transmitter and the receiver, must be designed to comply with all of the regulations in this section should the transmitter be presented with a continuous data (or information) stream. In addition, a system employing short transmission bursts must comply with the definition of a frequency hopping system and must distribute its transmissions over the minimum number of hopping channels specified in this section.
- (h) The incorporation of intelligence within a frequency hopping spread spectrum system that permits the system to recognize other users within the spectrum band so that it individually and independently chooses and adapts its hopsets to avoid hopping on occupied channels is permitted. The coordination of frequency hopping systems in any other manner for the express purpose of avoiding the simultaneous occupancy of individual hopping frequencies by multiple transmitters is not permitted.

# 3.2. EUT Pseudorandom Frequency Hopping Sequence

The pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage, and the result is fed back to the input of the first stage. The sequence begins with the first ONE of 9 consecutive ONEs; i.e. the shift register is initialized with nine ones. Number of shift register stages: 9 Length of pseudorandom sequence: 29-1 = 511 bits Longest sequence of zeros: 8 (non-inverted signal)

Each frequency used equally on the average by each transmitter. The system receiver have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shift frequencies in synchronization with the transmitted signals.

# 3.3. Frequency Hopping System

This transmitter device is frequency hopping device, and complies with FCC part 15.247 rule. This device uses Bluetooth radio which operates in 2400-2483.5 MHz band. Bluetooth uses a radio technology called frequency-hopping spread spectrum, which chops up the data being sent and transmits chunks of it on up to 79 bands (1 MHz each; centred from 2402 to 2480 MHz) in the range 2,400-2,483.5 MHz. The transmitter switches hop frequencies 1,600 times per second to assure a high degree of data security. All Bluetooth devices participating in a given piconet are synchronized to the frequency-hopping channel for the piconet. The frequency hopping sequence is determined by the master's device address and the phase of the hopping sequence (the frequency to hop at a specific time) is determined by the master's internal clock. Therefore, all slaves in a piconet must know the master's device address and must synchronize their clocks with the master's clock.

Adaptive Frequency Hopping (AFH) was introduced in the Bluetooth specification to provide an effective way for a Bluetooth radio to counteract normal interference. AFH identifies "bad" channels, where either other wireless devices are interfering with the Bluetooth signal or the Bluetooth signal is interfering with another device. The AFH-enabled Bluetooth device will then communicate with other devices within its piconet to share details of any identified bad channels. The devices will then switch to alternative available "good" channels, away from the areas of interference, thus having no impact on the bandwidth used.

\*Example for a Bluetooth device using channel numbers would be : Ch 44, 35, 78, 03, 15, 21, 76, 40, 56, 13, 02, 19, 67, 39, 78, 20, 21, 64, 75 etc.




# 5.1. Test setup

The diagram below shows the test setup that is utilized to make the measurements for emission from 9kHz to 3 0MHz Emissions.



#### 5.2. Limit

According to §15.247(d), in any 100 klb bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 klb bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement , provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval , as permitted under paragraph(b)(3) of this section , the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in section §15.209(a) is not required. In addition, radiated emission which in the restricted band, as define in section §15.205(a), must also comply the radiated emission limits specified in section §15.209(a) (see section §15.205(c))

According to § 15.109(a), for an intentional radiator devices, the general required of field strength of radiated emissions from unintentional radiators at a distance of 3 meters shall not exceed the following values:

#### 5.3. Test procedures

Radiated emissions from the EUT were measured according to the dictates of ANSI C63.10:2013 In case of the air temperature of the test site is out of the range is 10 to 40°C before the testing proceeds the warm-up time of EUT maintain adequately

#### 5.3.1. Test procedures for radiated spurious emissions

- 1. The EUT is placed on a turntable, which is 0.8 m (Below 1 键 )/ 1.5 m (Above 1 键 ) above ground plane.
- 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 3. EUT is set 3 m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emissions.
- 4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 6. Repeat above procedures until the measurements for all frequencies are complete.

#### 5.3.2. Test procedures for conducted spurious emissions

- 1. The transmitter output was connected to the spectrum analyzer through an attenuator.
- 2.The bandwidth of the fundamental frequency was measured with the spectrum analyzer using RBW=100 kHz, VBW=100 kHz.

#### 5.4. Test result

Ambient temperature: 22°C Relative humidity: 46% R.H.

# 5.4.1. Spurious radiated emission

The frequency spectrum from 9k to 30 was investigated. Emission levels are not reported much lower than the limits by over 20 dB. All reading values are peak values.

To get a maximum emission levels from the EUT, the EUT was moved throughout the XY, XZ, and YZ planes.

# 11. AC Conducted power line test

### 11.1 Test setup



### 11.2 **Limit**

According to §15.107(a) for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power lineon any frequency or frequencies, within the band 150 klb to 30 Mb, shall not exceed the limitsin the following table, as measured using a 50 uH/50ohm line impedance stabilization network(LISN).

### 11.3 Test procedures

The test procedure is performed in a  $6.5 \text{ m} \times 3.6 \text{ m} \times 3.6 \text{ m} \text{ (L*W*H)}$  shielded room. The EUTalong with its peripherals were placed on a  $1.0 \text{m}(\text{W}) \times 1.5 \text{m}(\text{L})$  and 0.8 m in heightwooden table and the EUT was adjusted to maintain a 0.4 meter space from a vertical reference plane.

The EUT was connected to power mains through a line impedancestabilization network (LISN) which provides 50 ohm coupling impedance for measuringinstrument and the chassis ground was bounded to the horizontal ground plane of shieldedroom. All peripherals were connected to the second LISN and the chassis ground alsobounded to the horizontal ground plane of shielded room. The excess power cablebetween the EUT and the LISN was bundled. The power cables of peripherals wereunbundled. All connecting cables of EUT and peripherals were moved to find themaximum emission.



# 12. Antenna requirement

# 12.1.Standard Applicable

For intentional device, according to FCC 47 CFR Section §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section §15.247 (b) if transmitting antennas of directional gain greater than 6dBi are used.
