



The assigned channel frequency was considered to be the reference frequency. The temperature was then reduced to -20 °C after which the transmitter was again allowed to stabilize for one hour. The transmitter was keyed ON for one minute, and again frequency readings were noted at 15-second intervals. The worst-case number was again used in the table below. This procedure was repeated in 10-degree increments up to + 50 °C.
