3.2 DESCRIPTION OF TEST MODES

The software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel frequencies individually.

The test result A is for Slave (Wireless JoyStick), and the test result B is for Master (USB Transceiver).

3.3 GENERAL DESCRIPTION OF APPLIED STANDARDS

The EUT is a Wireless JoyStick. According to the specifications of the manufacturer, it must comply with the requirements of the following standards:

All tests have been performed and recorded as per the above standards.



4.1.3 TEST PROCEDURES

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150 kHz to 30 MHz was searched. Emission levels over 10dB under the prescribed limits could not be reported

4.1.5 TEST RESULTS (A)

This EUT is excused from investigation of conducted emission, for it is powered by battery only. 4.2.3 TEST PROCEDURES

- 1. Check the calibration of the measuring instrument (SA) using either an internal calibrator or a known signal from an external generator.
- 2. Turn on the EUT and connect its antenna terminal to measurement via a low loss cable. Then set it to any one measured frequency within its operating range and make sure the instrument is operated in its linear range.
- 3. Set the SA on MaxHold Mode, and then keep the EUT in hopping mode. Record all the signals from each channel until each one has been recorded.
- 4. Set the SA on View mode and then plot the result on SA screen.
- 5. Repeat above procedures until all frequencies measured were complete.























4.3 DWELL TIME ON EACH CHANNEL

4.3.1 LIMIT OF DWELL TIME USED

For FHSS, the average time of occupancy on any frequency shall not be greater than 0.4 seconds within a 30 second period. For hybrid systems, the average time of occupancy on any frequency should not exceed 0.4 seconds within a time period in seconds equal to the number of hopping frequencies employed multiplied by 0.4.

4.3.3 TEST PROCEDURES

- 1. Check the calibration of the measuring instrument (SA) using either an internal calibrator or a known signal from an external generator.
- 2. Turn on the EUT and connect its antenna terminal to measurement via a low loss cable. Then set it to any one measured frequency within its operating range and make sure the instrument is operated in its linear range.
- Adjust the center frequency of SA on any frequency be measured and set SA to zero span mode. And then, set RBW and VBW of spectrum analyzer to proper value.
- 4. Measure the time duration of one transmission on the measured frequency. And then plot the result with time difference of this time duration.
- 5. Repeat above procedures until all frequencies measured were complete.






