Hello Richard,  
How are you doing ? My company, Logitech, manufactures Computer Peripherals products. Here is a question regarding Gaming Device for PC product.

Background :

Gaming Device device is made of two parts. GamePad (J-UE16) and Receiver (C-UG10b). Since, both of the device are bundled together, we have used same FCC ID, JNZ221613, on Gamepad as well as on Receiver. We have done same thing on previous models of Gaming device. But, for this project with different interpretation of the law by FCC, I am being asked to use two different FCC ID on Game pad and Receiver.

Current situation:

We have already produced 4500 units for USA with same FCC ID, JNZ221613, printed on Gamepad and on Receiver.

Request:

I am requesting you to accept same FCC ID, JNZ221613, for Gamepad and Receiver units for this time.

Permit Logitech to use these 4500 units the way it is and roll in the new FCC ID on the next build of the device.
