3.1 Maximum Output Power




3.2 Time-Averaged Power Calculation.

<Considerations Related to Bluetooth for Setup and Testing>

This device has installed Bluetooth engineering testing software which can provide continuous transmitting RF signal. During Bluetooth SAR testing, this device was operated to transmit continuously at the maximum transmission duty with specified transmission mode, operating frequency, lowest data rate, and maximum output power.

The EUT was set to LE mode at the maximum output power. Its duty factor was calculated as below, it specified and designed from manufacturer when devices operate at normal usage condition.



Time-domain plot for Bluetooth transmission signal

The duty factor of Bluetooth signal has been calculated as following. Duty Factor = Pulse Width / Total Period = 6.6%

The calculation of time-averaged power with duty cycle are performed as below.

3.3 SAR Testing Exclusions

According to KDB 447498 D01, the SAR test exclusion condition is based on source-based time-averaged maximum conducted output power, adjusted for tune-up tolerance, and the minimum test separation distance required for the exposure conditions. The SAR exclusion threshold is determined by the following formula.

1. For the test separation distance <= 50 mm

 $\frac{\text{Max. Tune up Power}_{(mW)}}{\text{Min. Test Separation Distance}_{(mm)}} \times \sqrt{f_{(GHz)}} \leq 3.0$

When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion. 2. For the test separation distance > 50 mm, and the frequency at 100 MHz to 1500 MHz

 $\left[(\text{Threshold at 50 mm in Step 1}) + (\text{Test Separation Distance} - 50 \text{ mm}) \times \left(\frac{f_{(MHz)}}{150} \right) \right]_{(mW)}$

3. For the test separation distance > 50 mm, and the frequency at > 1500 MHz to 6 GHz

[(Threshold at 50 mm in Step 1) + (Test Separation Distance -50 mm) × 10]_(mW)

Note:

1. When separation distance <= 50 mm and the calculated result shown in above table is <= 3.0, the SAR testing exclusion is applied.

Summary:

Since the SAR testing for all device orientations apply SAR test exclusion per KDB 447498, SAR testing for this device is not required.
