$$P_d = (P_{out} * G) / (4 * \pi * r^2)$$

where

P_d = power density in mW/cm²

P_{out} = output power to antenna in mW

G = gain of antenna in linear scale

π = 3.1416

R = distance between observation point and center of the radiator in cm

2.3 Classification

The antenna of this product, under normal use condition, is at least 20 cm away from the body of the user. So, this device is classified as **Mobile Device**.
