

Although these tests were performed other than open area test site, adequate comparison measurements were confirmed against 30 m open are test site. Therefore, sufficient tests were made to demonstrate that the alternative site produces results that correlate with the ones of tests made in an open field based on KDB 937606.

allowed in order for them to warm up to their normal operating condition.

Radiated emission measurements are performed at 3m distance with the broadband antenna (Loop antenna, Biconical antenna, Log periodic antenna, Double ridged guide antenna and Broad-band horn Antenna). The antenna is positioned both the horizontal and vertical planes of polarization and height is varied 1m to 4m and stopped at height producing the maximum emission. As for the Loop antenna, it is positioned with its plane vertical, and the center of the Loop antenna is 1m above the ground plane. The EUT is Placed on a turntable, which is 0.8m/1.5m above ground plane. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level. The test results represent the worst case emission for each emission with manipulating the EUT, support equipment, interconnecting cables and varying the mode of operation. The peak power is measured with a spectrum analyzer connected to the antenna terminal, while EUT is operating in transmission mode at the appropriate center frequency.

The spectrum analyzer is set to;

- a) Span = 1.5 times the 6 dB bandwidth.
- b) RBW = 3kHz 100kHz.
- c) VBW \geq 3 x RBW.
- d) Sweep time = auto-couple.
- e) Detector = peak.
- f) Trace mode = max hold.

4.8 AC Power Line Conducted Emissions

4.8.1 Measurement procedure

[FCC 15.207]

Test was applied by following conditions.

Test method : ANSI C63.10

Frequency range : 0.15 MHz to 30 MHz

Test place : 3 m Semi-anechoic chamber

EUT was placed on : FRP table / (W)2.0 m \times (D)1.0 m \times (H)0.8 m Vertical Metal Reference Plane : (W)2.0 m \times (H)2.0 m 0.4 m away from EUT

Test receiver setting

- Detector : Quasi-peak, Average


- Bandwidth : 9 kHz

EUT and peripherals are connected to $50\Omega/50\mu H$ Line Impedance Stabilization Network (LISN) which are connected to reference ground plane, and are placed 80cm away from EUT. Excess of AC power cable is bundled in center.

LISN for peripheral is terminated in 50Ω .

EUT operating mode is selected to emit the maximum noise. Overall frequency range is investigated with spectrum analyzer using peak detector. Maximum emission configuration is determined by manipulating the EUT, peripherals, interconnecting cables. Then, emission measurements are performed with test receiver in above setting to each current-carrying conductor of the mains port. Sufficient time for EUT, peripherals and test equipment is provided in order for them to warm up to their normal operating condition. If the average limit is met when using a quasi-peak detector receiver, the EUT shall be deemed to meet both limits.

5 Antenna requirement

According to FCC section 15.203, an intentional radiator shall be designed to ensure that no antenna other than furnished by the responsible party shall be used with the device. The antenna is a special antenna mounted inside of the EUT. Therefore, the EUT complies with the antenna requirement of FCC section 15.203.








