2.6 Transmit Power Control (TPC)

U-NII devices operating in the 5.25-5.35 GHz band and the 5.47-5.725 GHz band shall employ a TPC mechanism. The U-NII device is required to have the capability to operate at least 6 dB below the mean EIRP value of 30 dBm. A TPC mechanism is not required for systems with an E.I.R.P. of less than 500 mW.

Maximum EIRP of this device is 43.214 mW which less than 500mW, therefore it's not require TPC function.



2.7 Statement of Manufacturer

Manufacturer statement confirming that information regarding the parameters of the detected Radar Waveforms is not available to the end user. And the device doesn't have Ad Hoc mode on DFS frequency band.

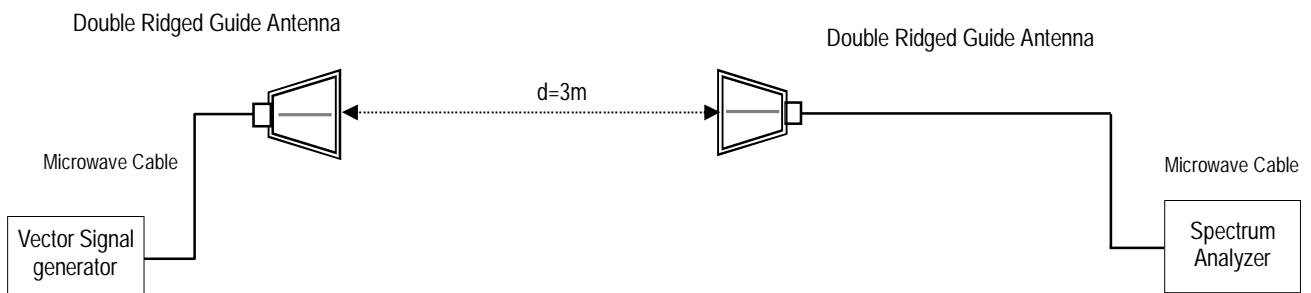

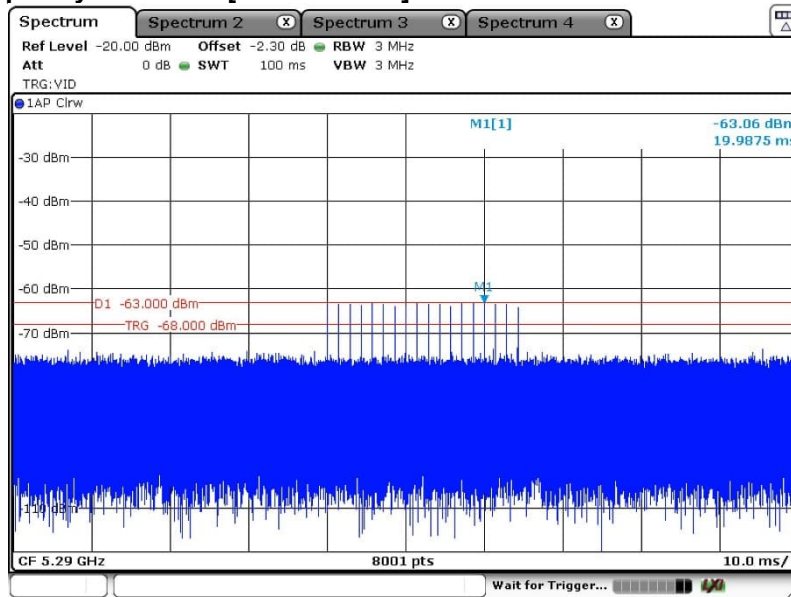

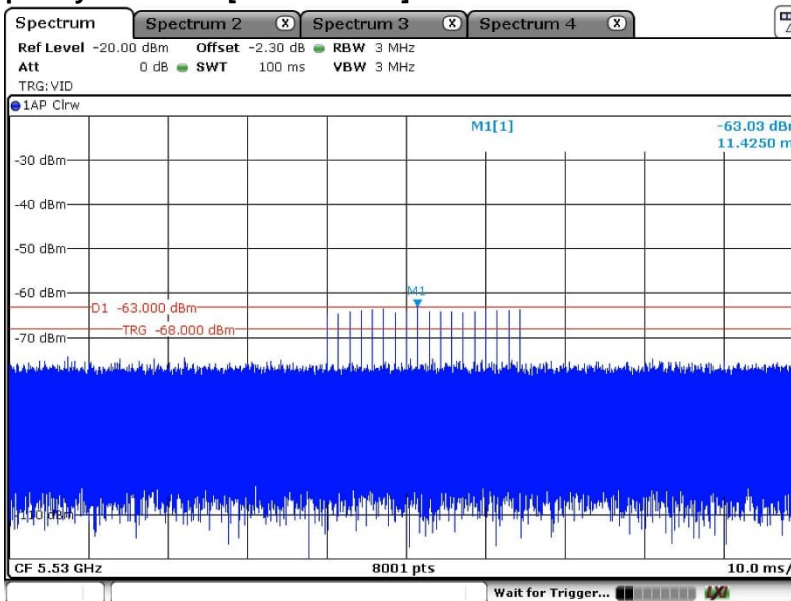
Radar Type 0 Calibration Plot

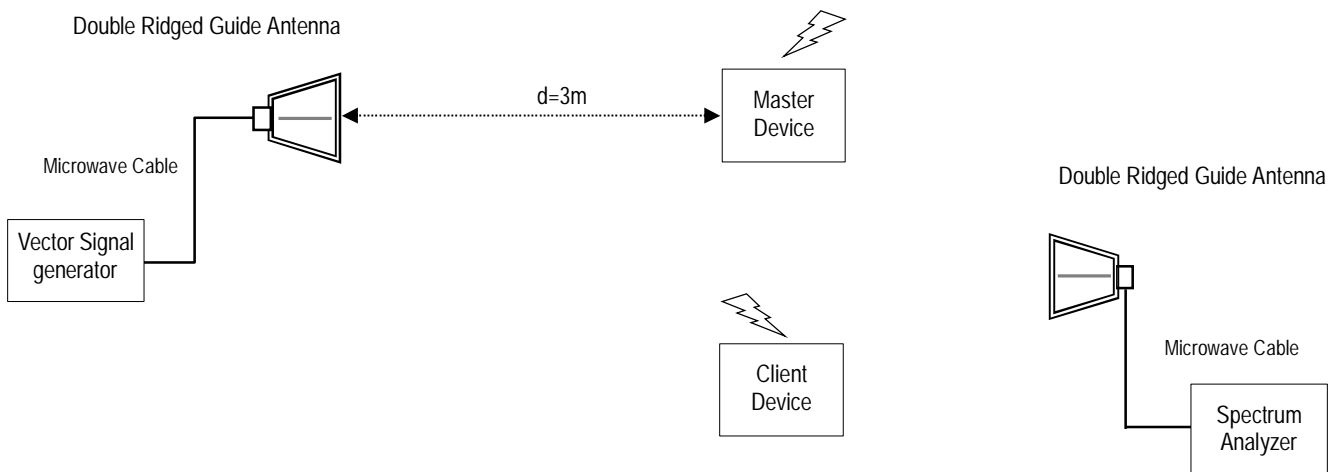

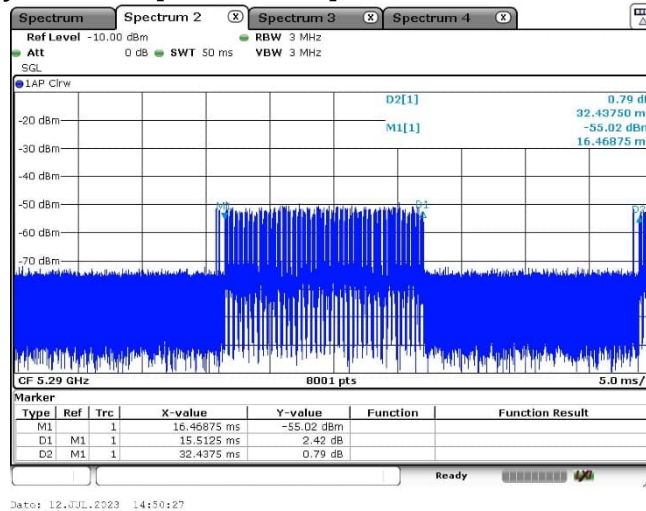

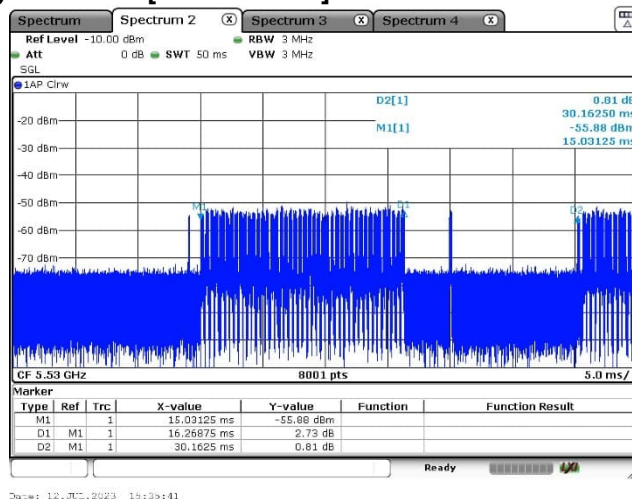
Client device Data Traffic Plot

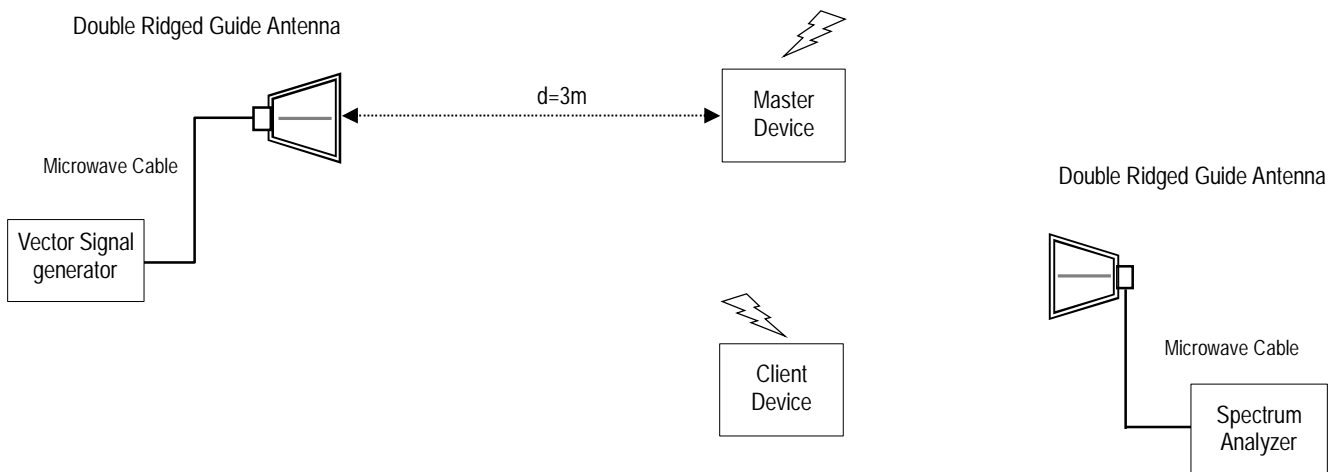

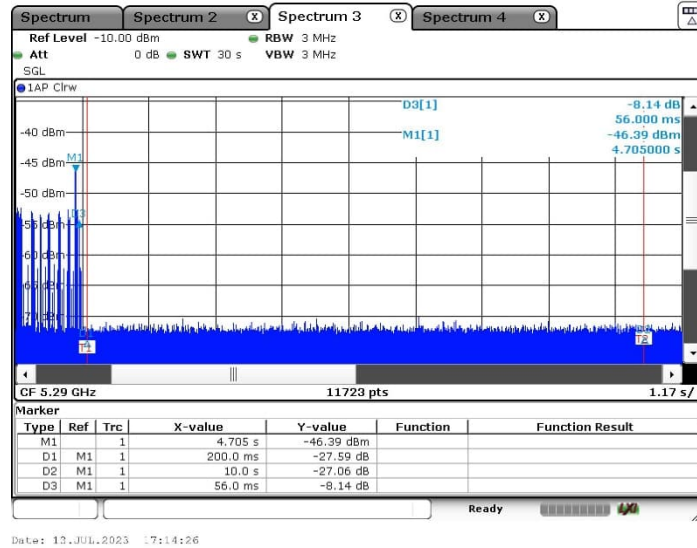

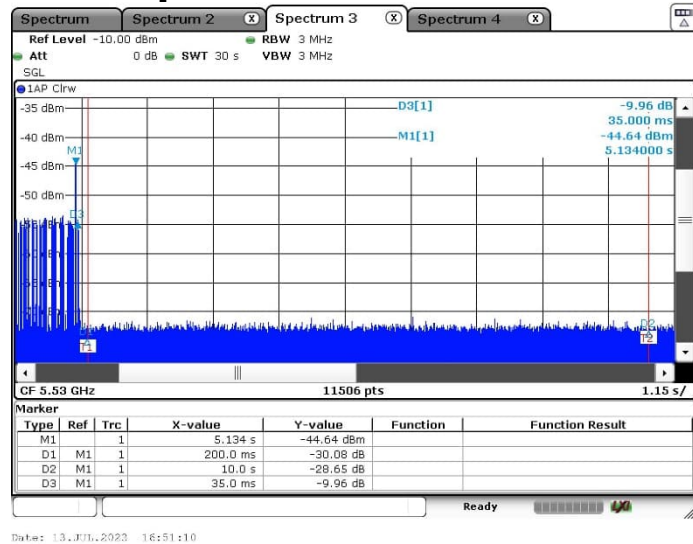
Channel Closing Transmission Time Plot

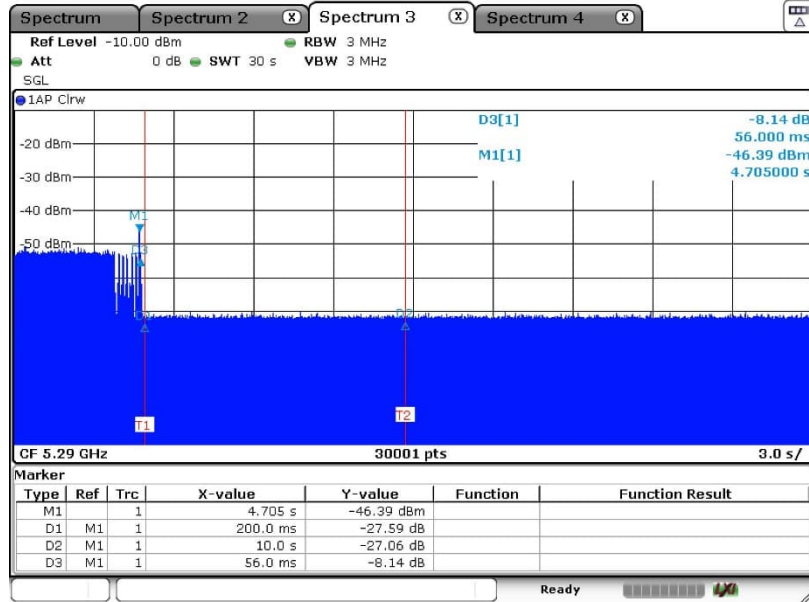

Channel Move Time Plot

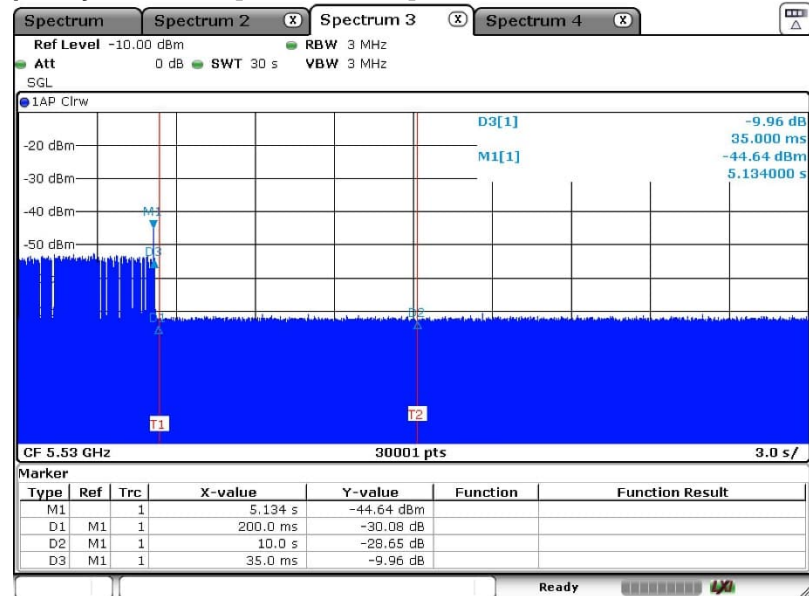

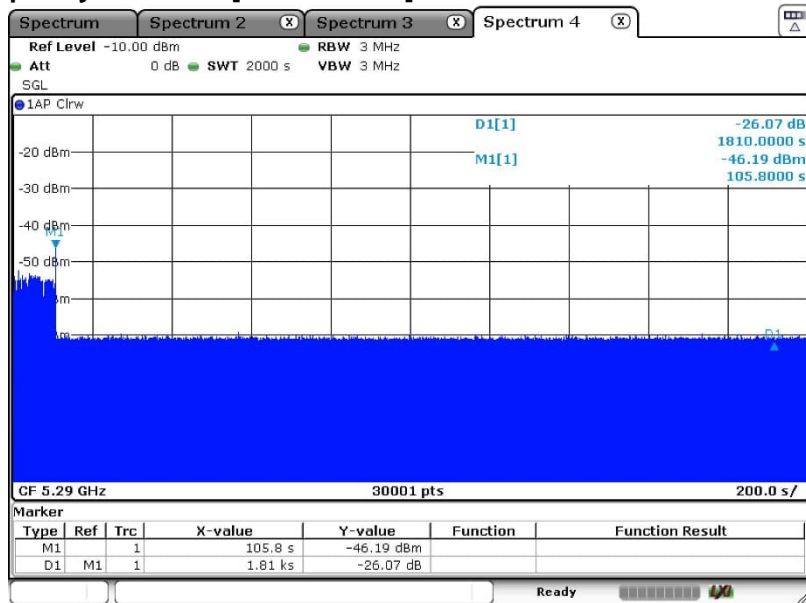

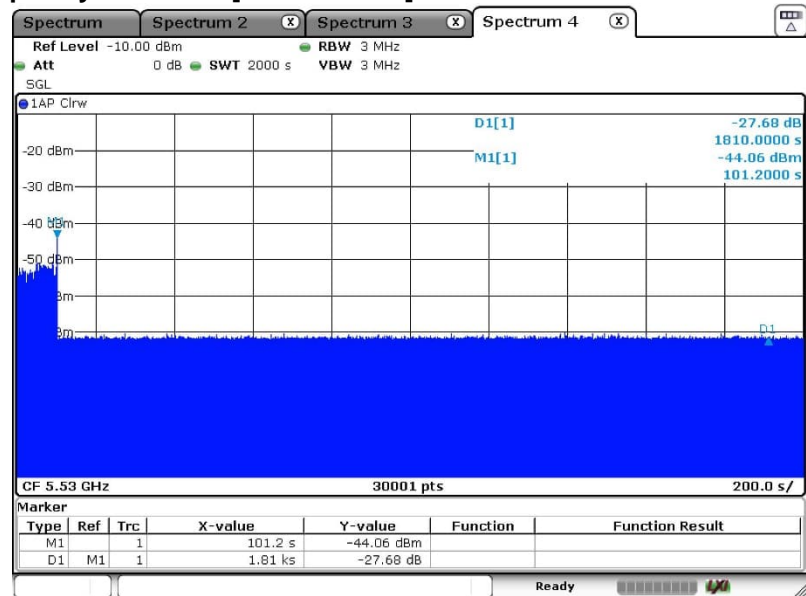
Non-Occupancy Period Plot



