Note 1: Short Pulse Radar Type 0 should be used for the detection bandwidth test, channel move time, and channel closing time tests.

A minimum of 30 unique waveforms are required for each of the Short Pulse Radar Types 2 through 4. If more than 30 waveforms are used for Short Pulse Radar Types 2 through 4, then each additional waveform must also be unique and not repeated from the previous waveforms. If more than 30 waveforms are used for Short Pulse Radar Type 1, then each additional waveform is generated with Test B and must also be unique and not repeated from the previous waveforms in Tests A or B.

For example if in Short Pulse Radar Type 1 Test B a PRI of 3066 usec is selected, the number of pulses




BACL DFS measurement system consists of two subsystems: (1) The radar signal generating subsystem and (2) the traffic monitoring subsystem.

#### **System Block Diagram**






Setup for Master with injection at the Master




Setup for Client with injection at the Master

#### **4.6 Test Procedure**

A spectrum analyzer is used as a monitor verifies that the EUT status including Channel Closing Transmission Time and Channel Move Time, and does not transmit on a Channel during the Non-Occupancy Period after the diction and Channel move. It is also used to monitor EUT transmissions during the Channel Availability Check Time.

#### **TEST RESULTS**

#### **Description of EUT**

The EUT operates in 5250-5350 MHz and 5470-5725 MHz range.

The calibrated radiated DFS detection threshold level is set to -64 dBm.

WLAN traffic is generated by streaming the video file TestFile.mpg, this file is used by IP and Frame based systems for loading the test channel during the In-service compliance testing of the U-NII device. The file is streamed from the Access Point to the Client in full motion video mode using the media player with the V2.61 Codec package.



#### **Radar Waveform Calibration**




Plots of Radar Waveforms

# CHANNEL MOVE TIME AND CHANNEL CLOSING TRANSMISSION TIME

#### **Test Procedure**

Channel Move Time and the Channel Closing Transmission Time should be performed with Radar Type 0. The measurement timing begins at the end of the Radar Type 0 burst. repeat using a long pulse radar type5 waveform.

The Channel Closing Transmission Time is comprised of 200 milliseconds starting at the beginning of the Channel Move Time plus any additional intermittent control signals required to facilitate a Channel move (an aggregate of 60 milliseconds) during the remainder of the 10 second period. The aggregate duration of control signals will not count quiet periods in between transmissions.

The aggregate channel closing transmission time is calculated as follows:

Aggregate Transmission Time = N\*Dwell Time

N is the number of spectrum analyzer bins showing a device transmission Dwell Time is the dwell time per bin (i.e. Dwell Time = S/B, S is the sweep time and B is the number of bin, i.e. 8192)



#### Type 0 radar channel move time result:



#### 5290 MHz channel closing transmission time






