The worst emission was found in X axis and the worst case recorded.

Radiated emission measurements are performed at 3m distance with the broadband antenna (Loop antenna, Biconical antenna, Log periodic antenna, Double ridged guide antenna and Broad-band horn Antenna). The antenna is positioned both the horizontal and vertical planes of polarization and height is varied 1m to 4m and stopped at height producing the maximum emission. [3-DH5] Channel Low Horizontal Peak



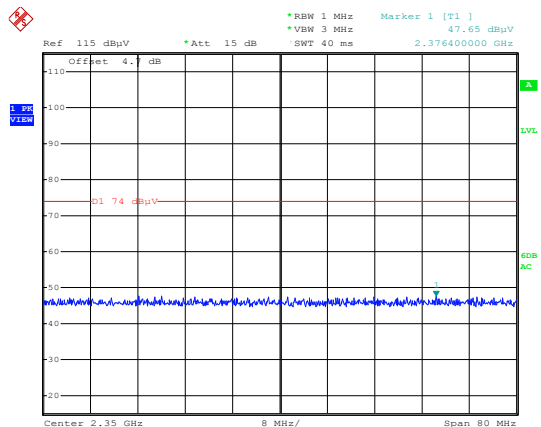

[3-DH5] Channel High Horizontal Peak



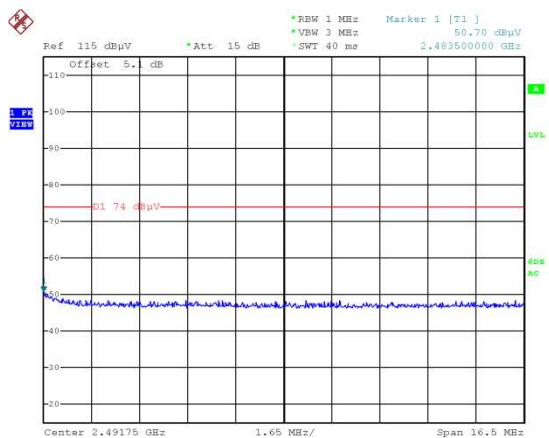

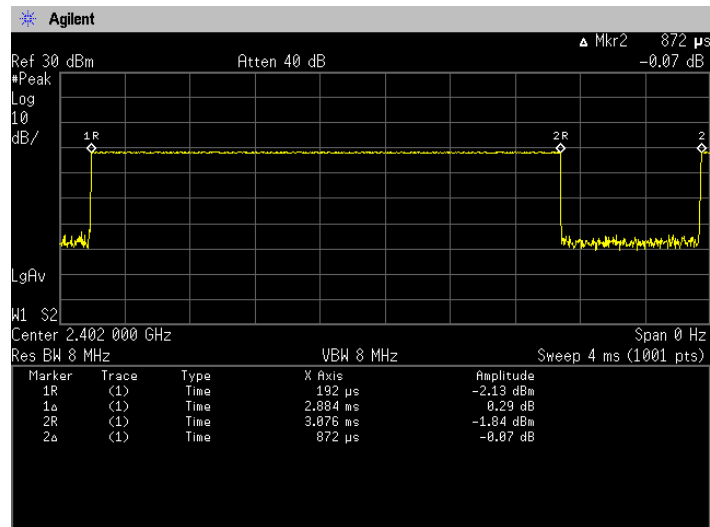
