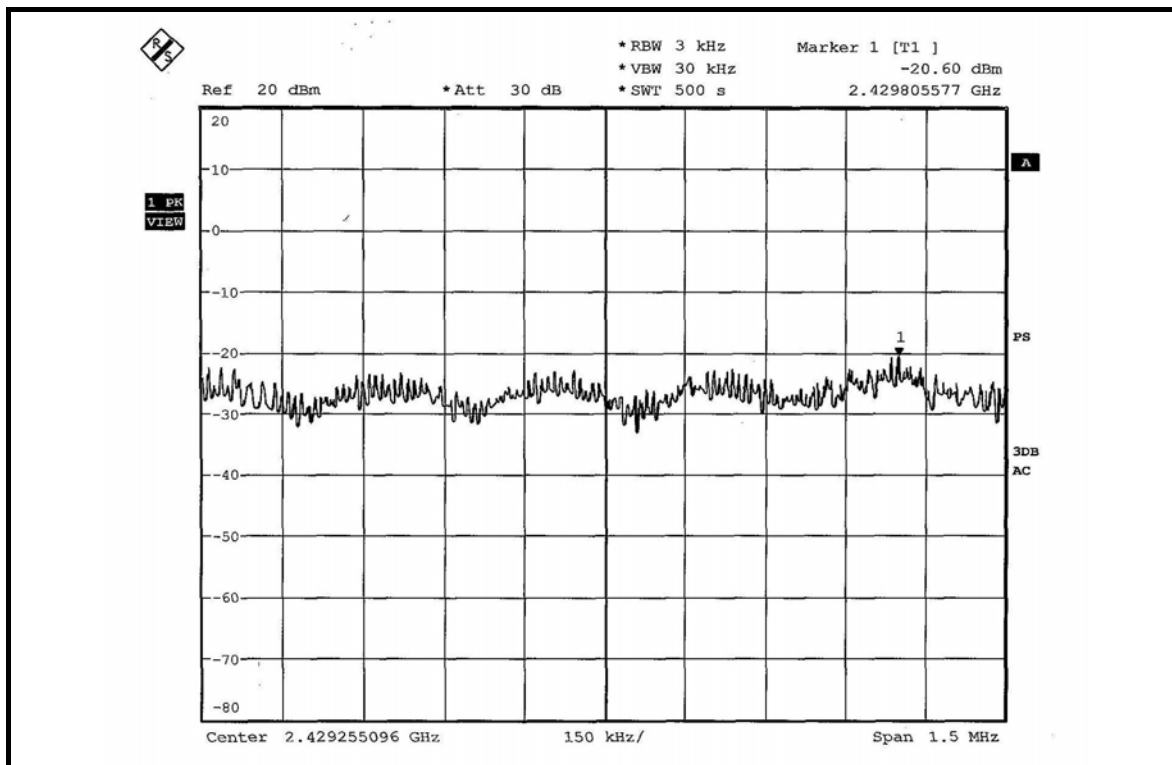
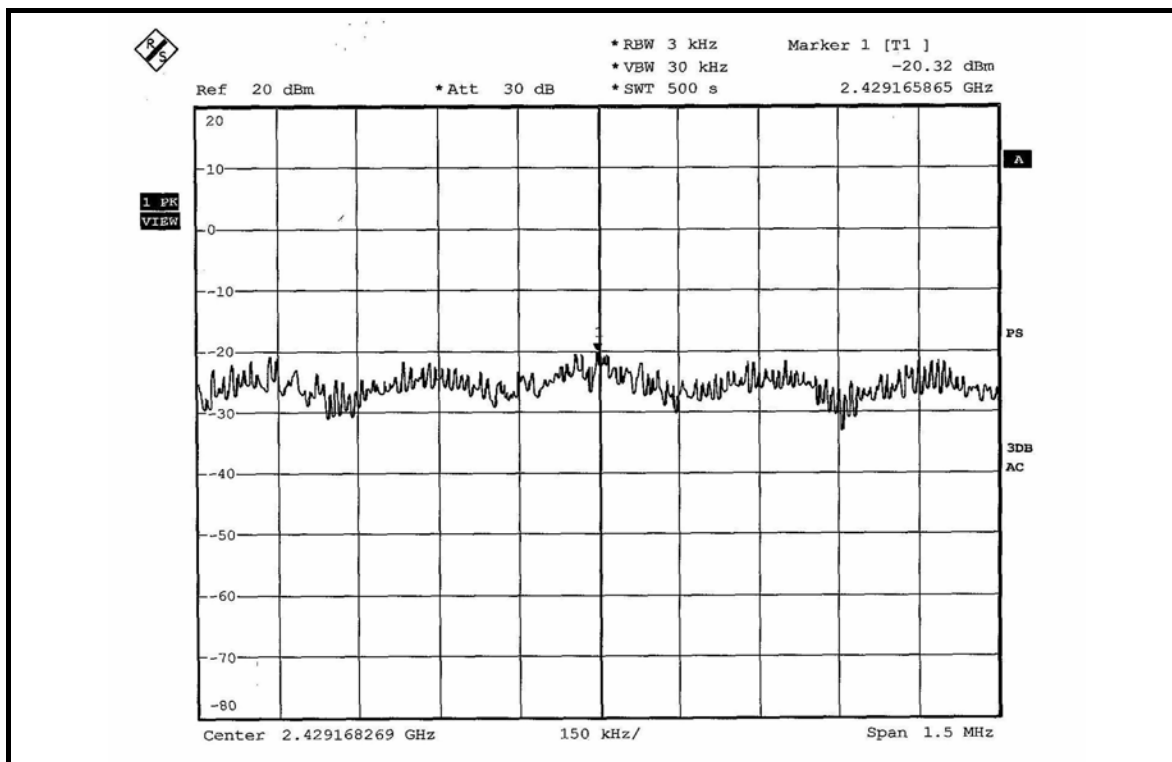


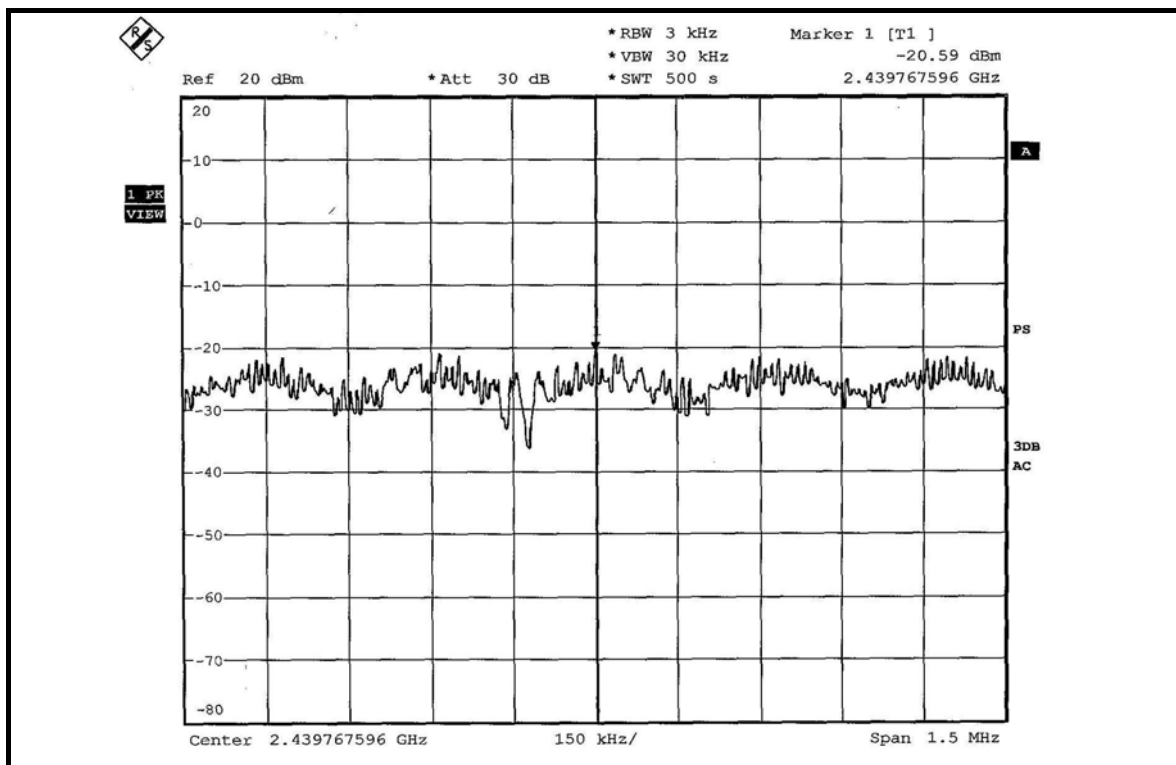

### 4.6.3 TEST PROCEDURE

#### For Single TX:

The transmitter output was connected to the spectrum analyzer via a low loss cable. Set both RBW and VBW of spectrum analyzer to 100kHz with suitable frequency span including 10Hz bandwidth from band edge. The band edges was measured and recorded.

The spectrum plots (Peak RBW = VBW = 100kHz; Average RBW = 1MHz, VBW = 10Hz) are attached on the following pages.

#### For Dual TX:

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. Set both RBW and VBW of spectrum analyzer to 100kHz with suitable frequency span including 100MHz bandwidth from band edge. The band edges was measured and recorded.

The spectrum plots (Peak RBW = VBW = 100kHz; Average RBW = 1MHz, VBW = 10Hz)

**NOTE:** The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 10Hz for Average detection (AV) at frequency above 1GHz.

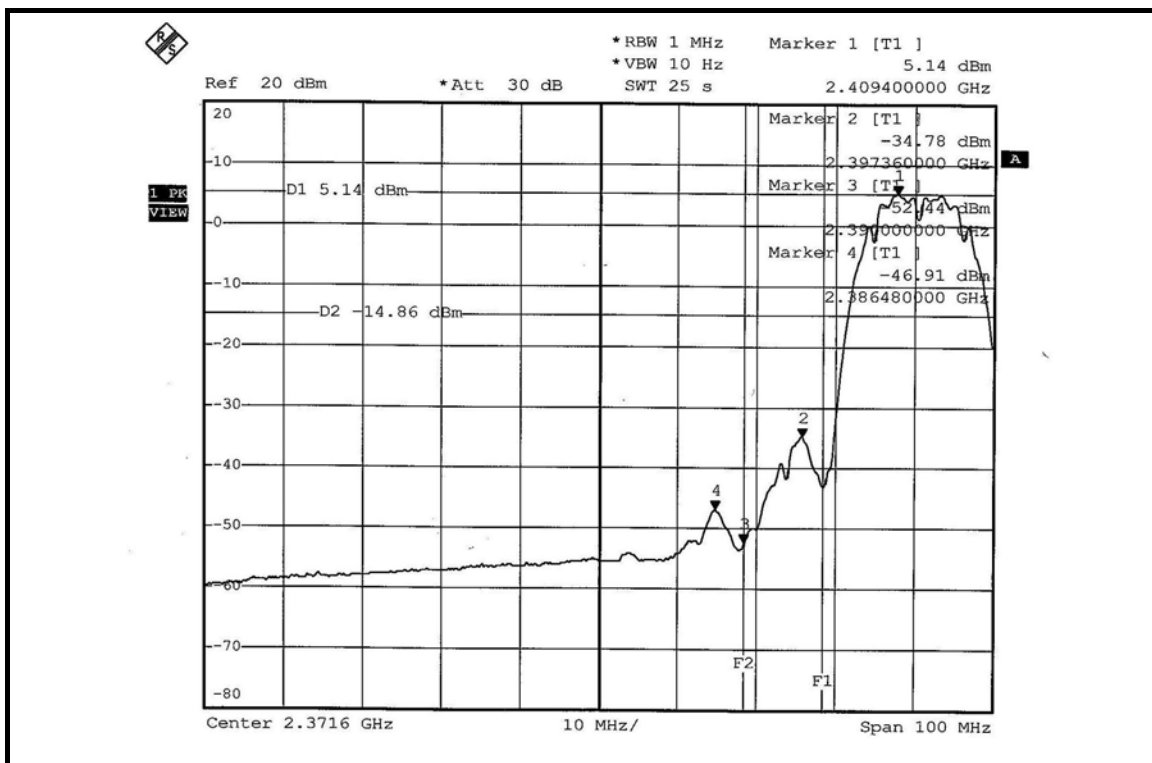
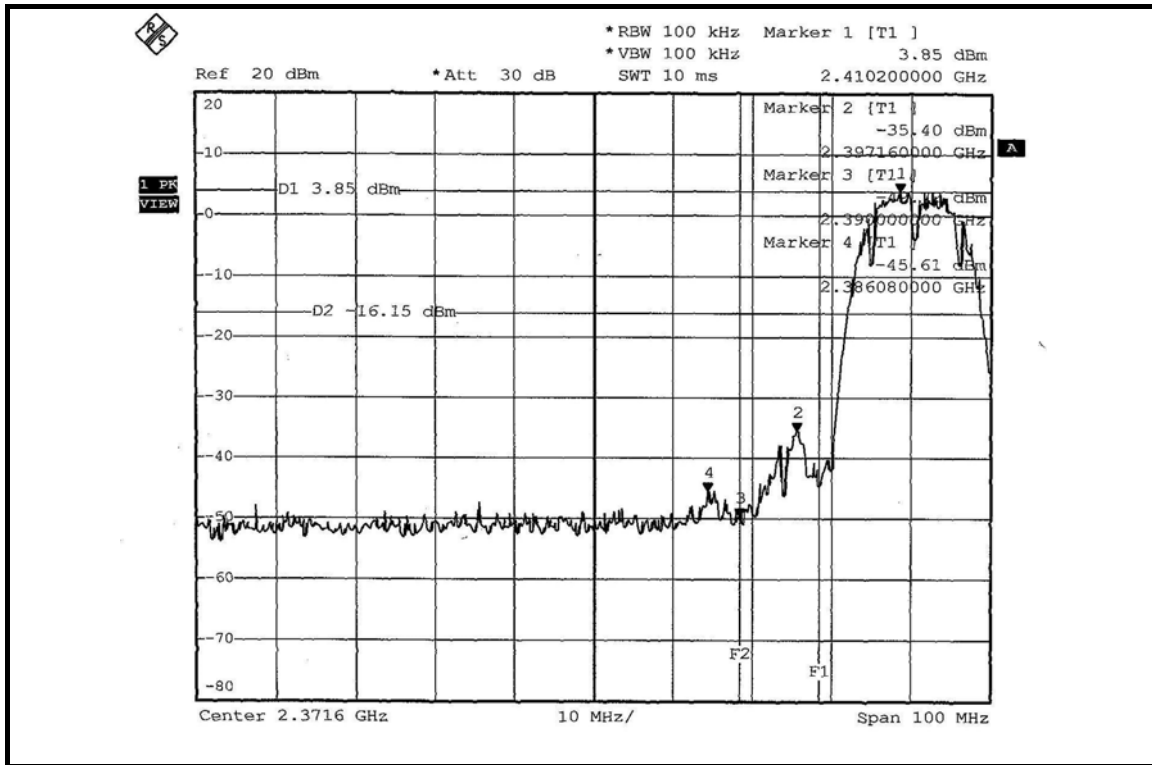
The band edge emission plot of DSSS technique on the next page shows 49.46dBc between carrier maximum power and local maximum emission in restrict band (2.386080000GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 106.15dBuV/m (Peak), so the maximum field strength in restrict band is  $106.15 - 49.46 = 56.69\text{dBuV/m}$  which is under 74dBuV/m limit.

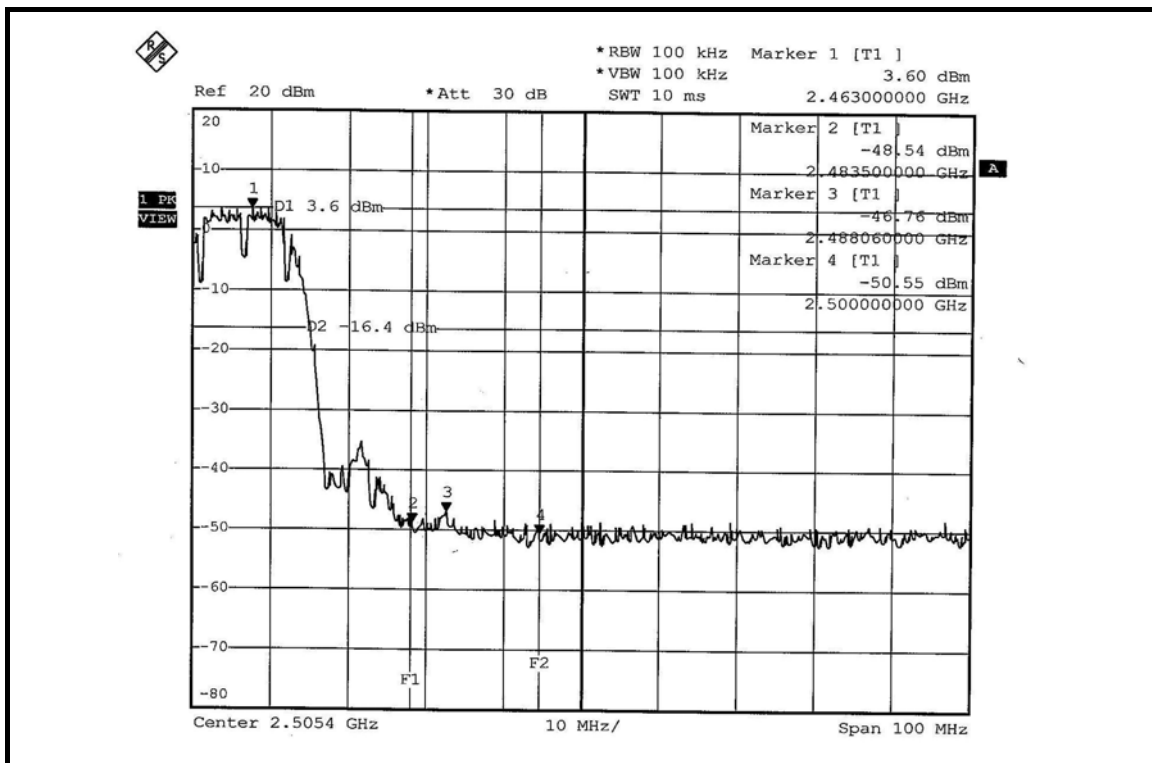
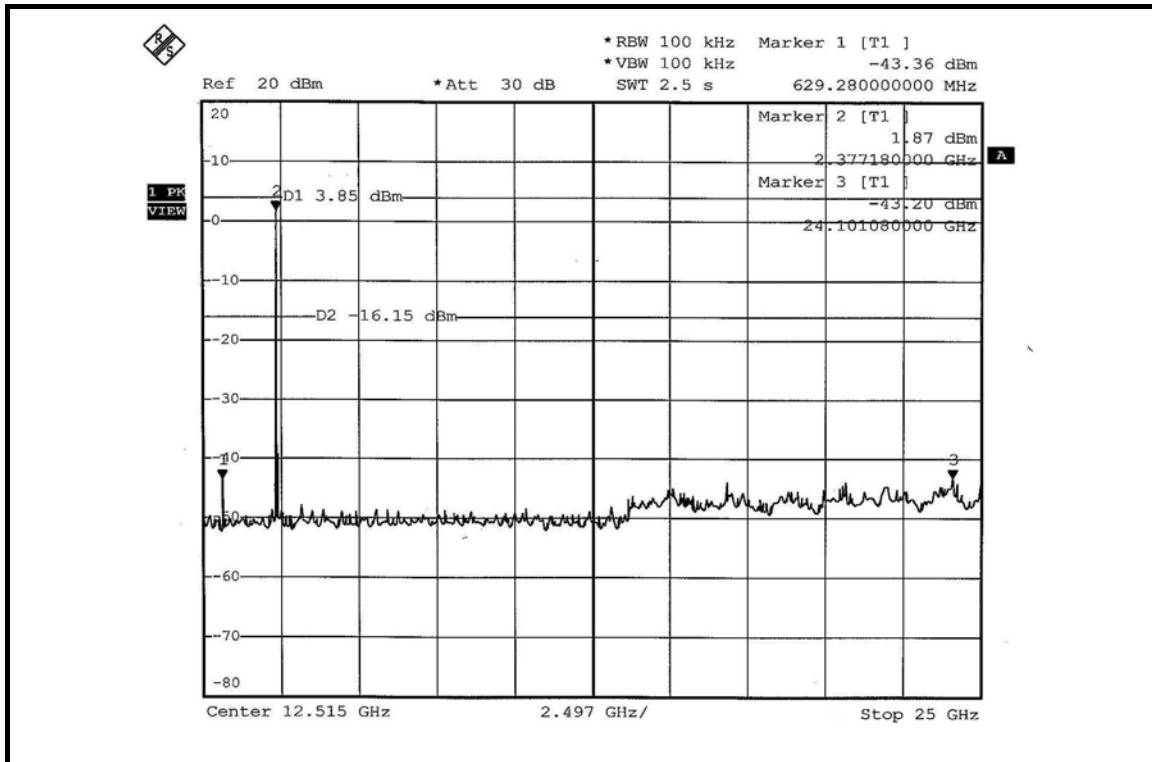
The band edge emission plot of DSSS technique on the next page shows 52.05dBc between carrier maximum power and local maximum emission in restrict band (2.386480000GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 101.63dBuV/m (Average), so the maximum field strength in restrict band is  $101.63 - 52.05 = 49.58\text{dBuV/m}$  which is under 54dBuV/m limit.

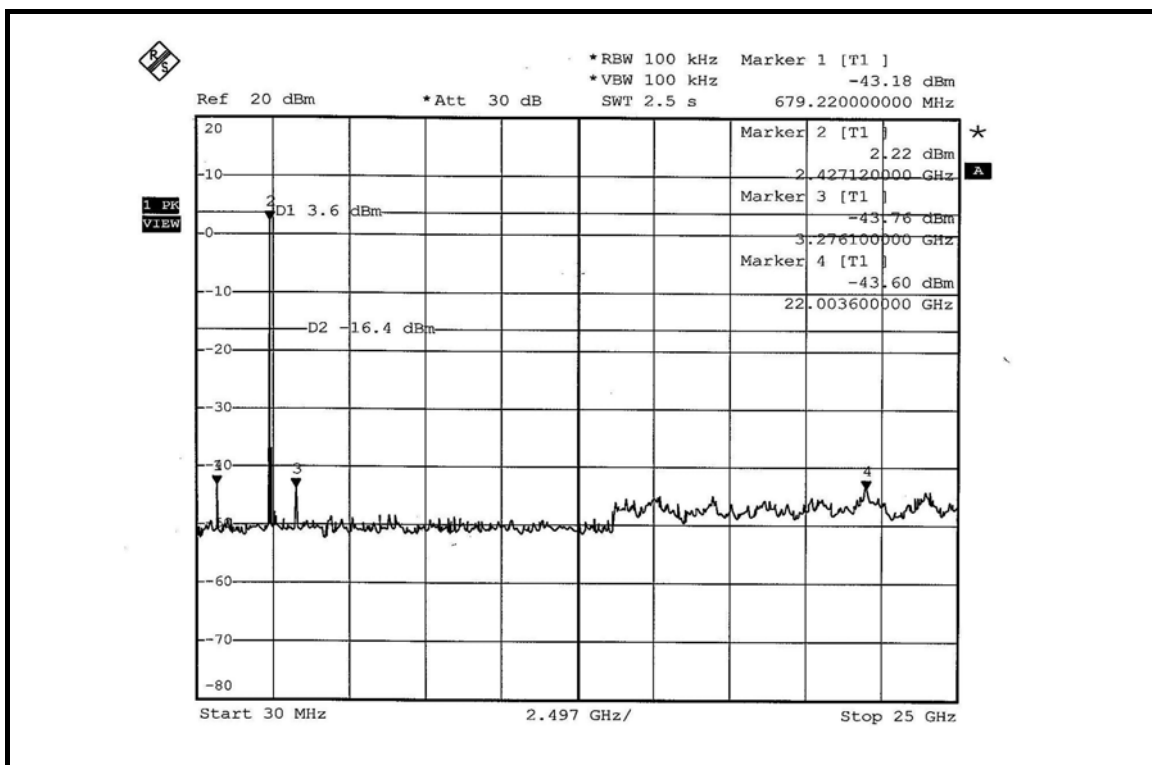
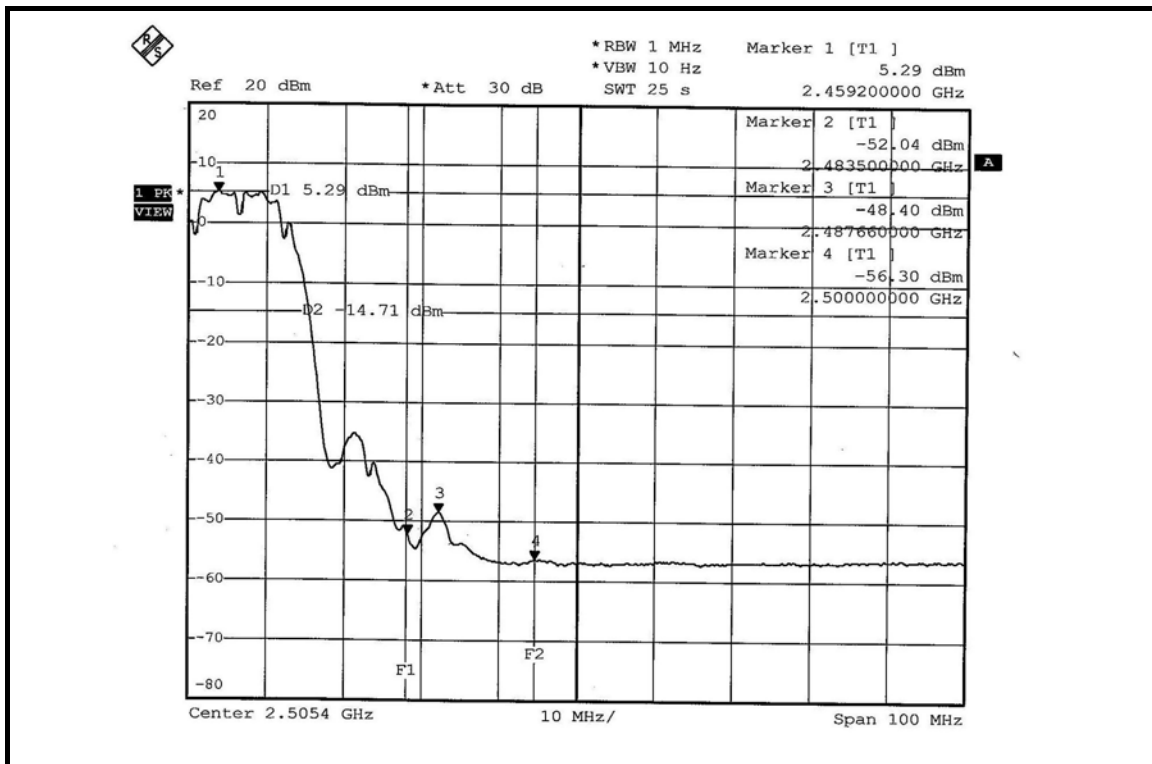
##### **NOTE 2:**

The band edge emission plot of DSSS technique on the next second page shows 50.36dBc between carrier maximum power and local maximum emission in restrict band (2.488060000GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 106.36dBuV/m (Peak), so the maximum field strength in restrict band is  $106.36 - 50.36 = 56.00\text{dBuV/m}$  which is under 74dBuV/m limit.

The band edge emission plot of DSSS technique on the next third page shows 53.69dBc between carrier maximum power and local maximum emission in restrict band (2.487660000GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 102.00dBuV/m (Average), so the maximum field strength in restrict band is  $102.00 - 53.69 = 48.31\text{dBuV/m}$  which is under 54dBuV/m limit.

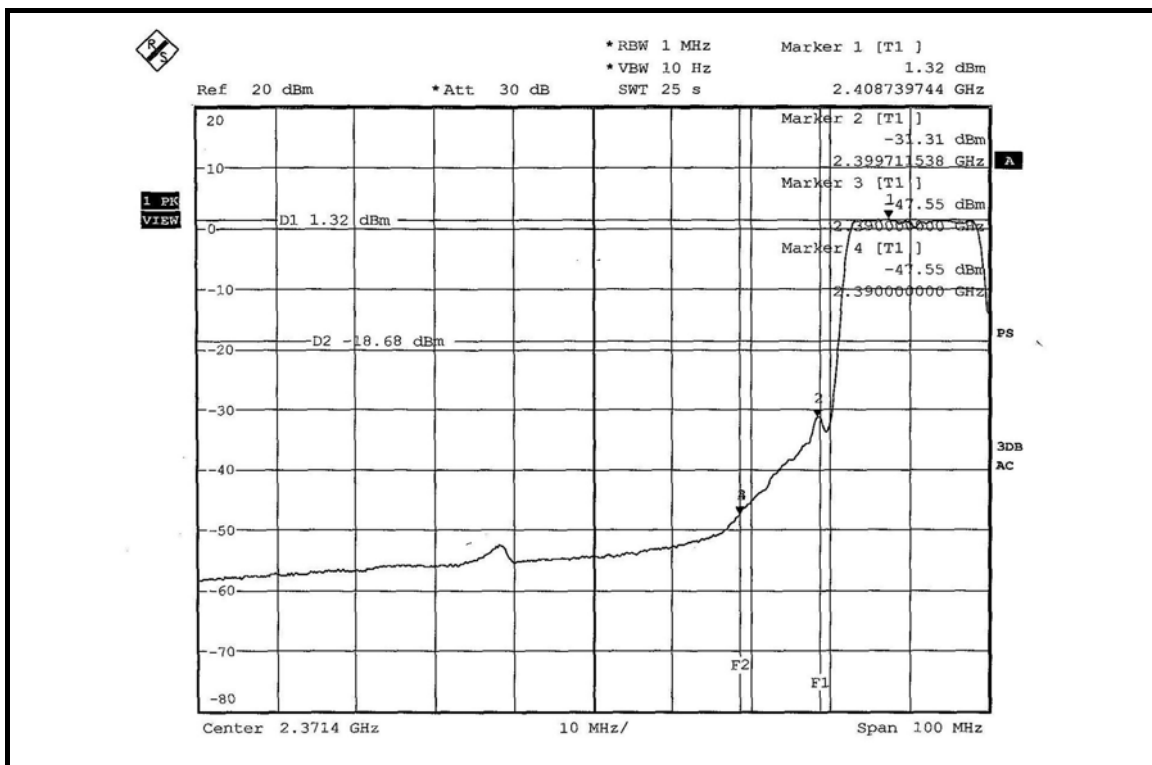
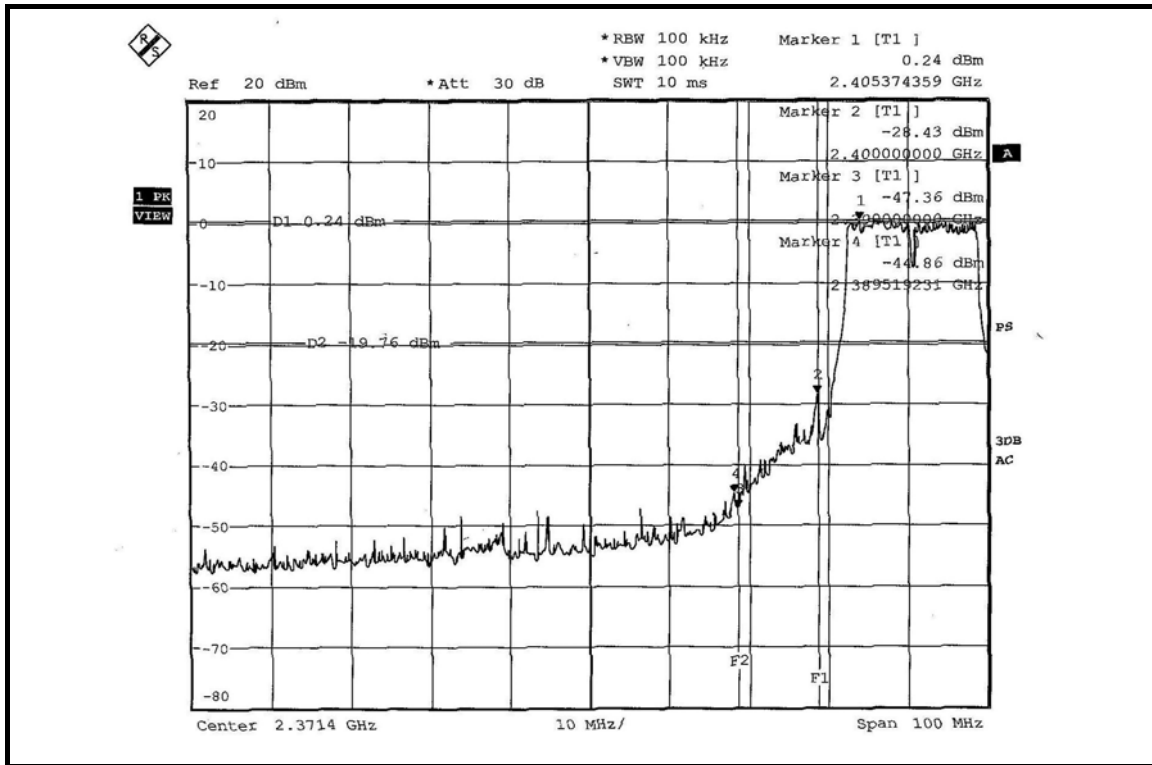
The band edge emission plot of OFDM technique on the next page shows 45.10dBc between carrier maximum power and local maximum emission in restrict band (2.389519231GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 109.34dBuV/m (Peak), so the maximum field strength in restrict band is  $109.34 - 45.10 = 64.24$ dBuV/m which is under 74dBuV/m limit.

The band edge emission plot of OFDM technique on the next page shows 48.87dBc between carrier maximum power and local maximum emission in restrict band (2.390000000GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 97.56dBuV/m (Average), so the maximum field strength in restrict band is  $97.56 - 48.87 = 48.69$ dBuV/m which is under 54dBuV/m limit.

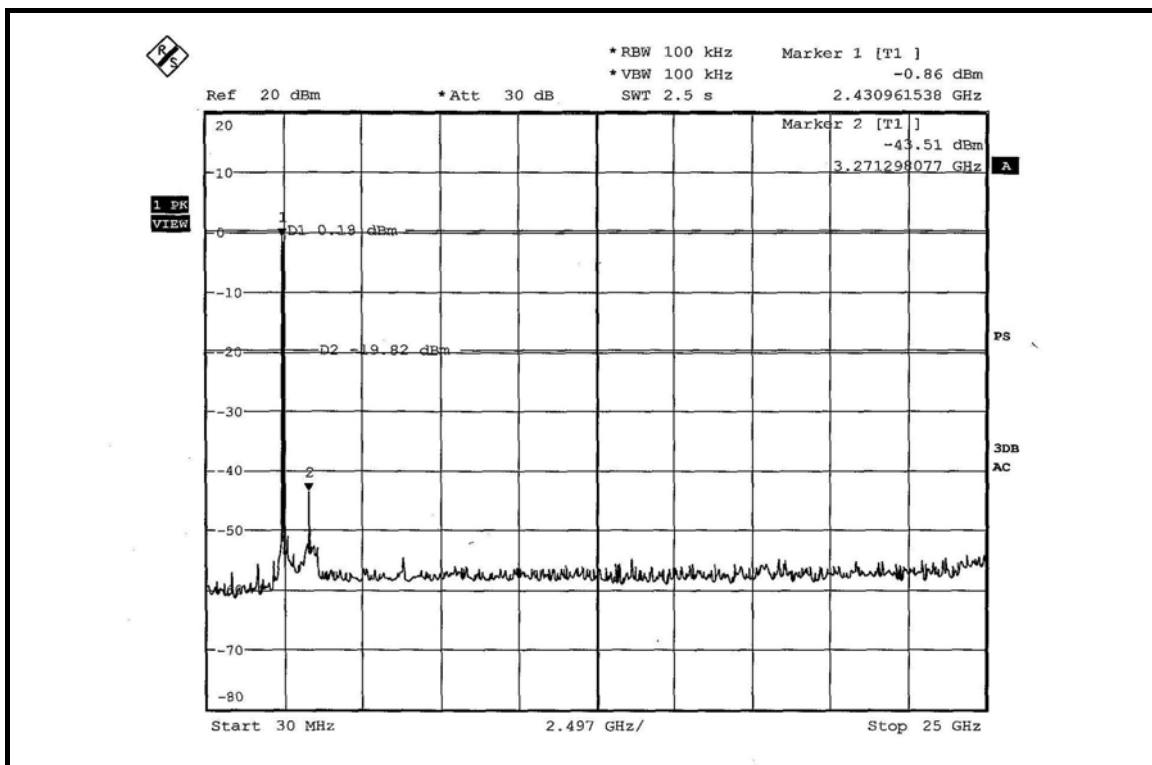
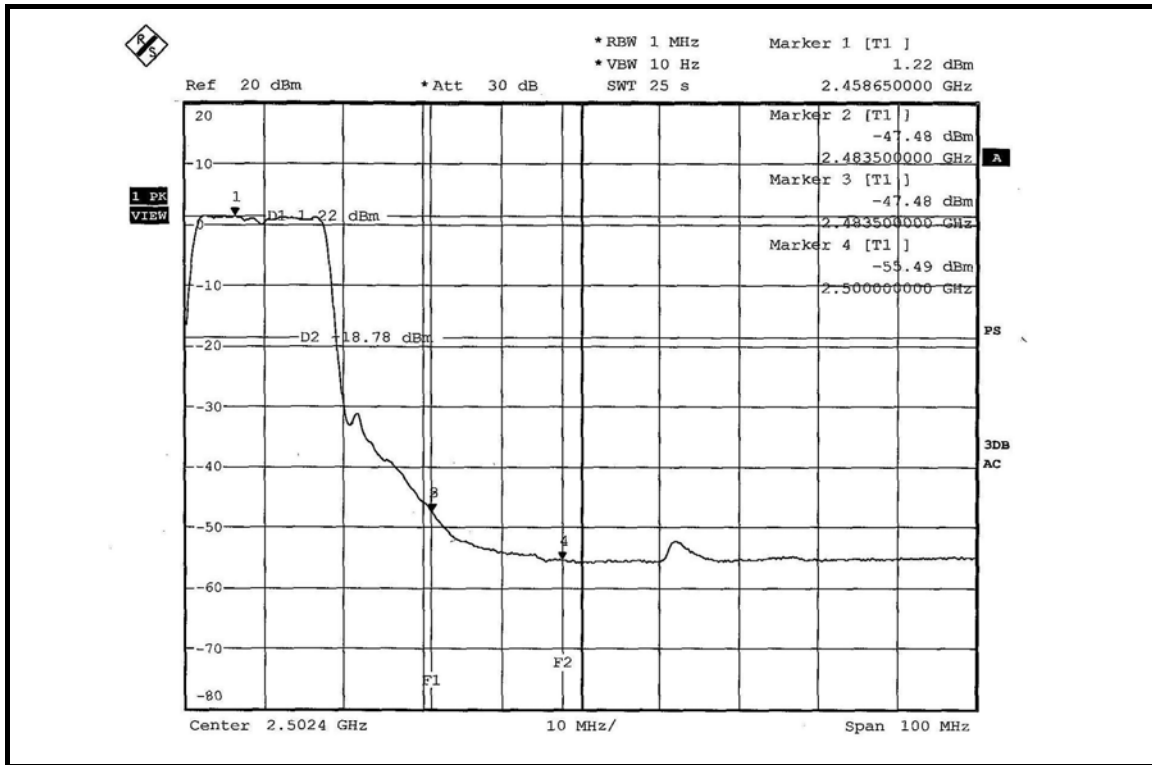
### NOTE 2:

The band edge emission plot of OFDM technique on the next second page shows 46.27dBc between carrier maximum power and local maximum emission in restrict band (2.484141026GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 108.65dBuV/m (Peak), so the maximum field strength in restrict band is  $108.65 - 46.27 = 62.38$ dBuV/m which is under 74dBuV/m limit.

The band edge emission plot of OFDM technique on the next third page shows 48.70dBc between carrier maximum power and local maximum emission in restrict band (2.483500000GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 97.17dBuV/m (Average), so the maximum field strength in restrict band is  $97.17 - 48.70 = 48.47$ dBuV/m which is under 54dBuV/m limit.

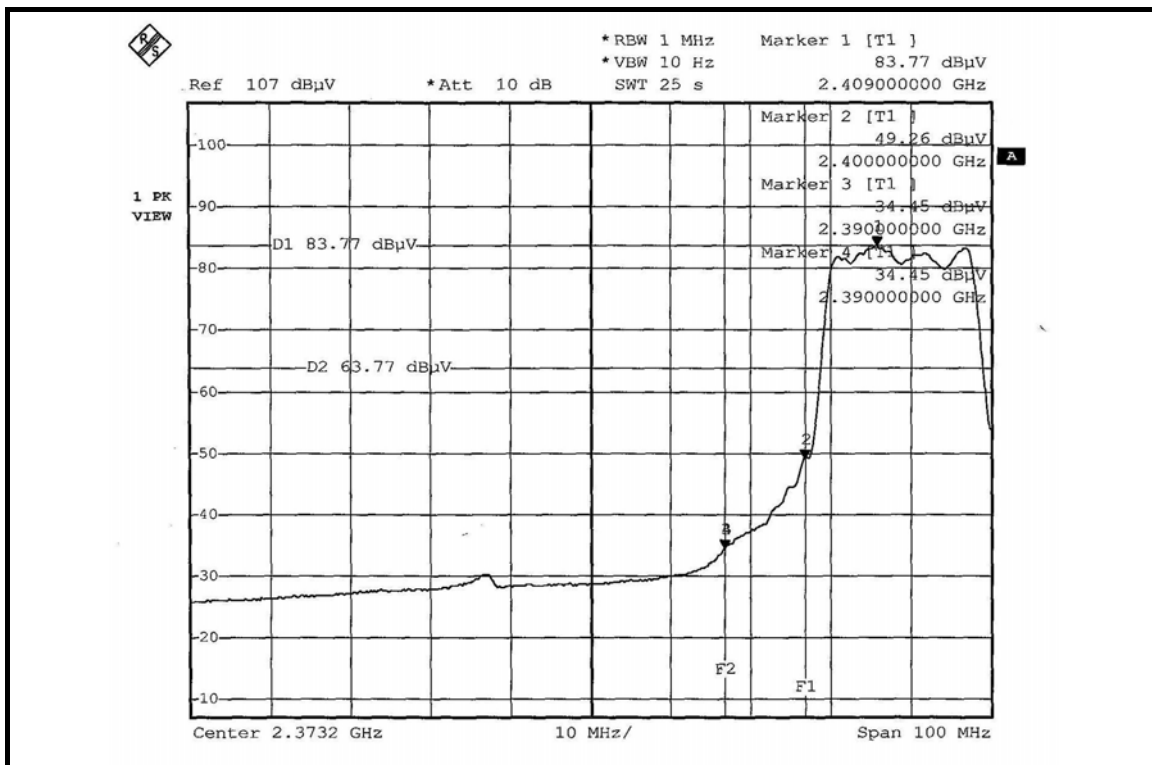
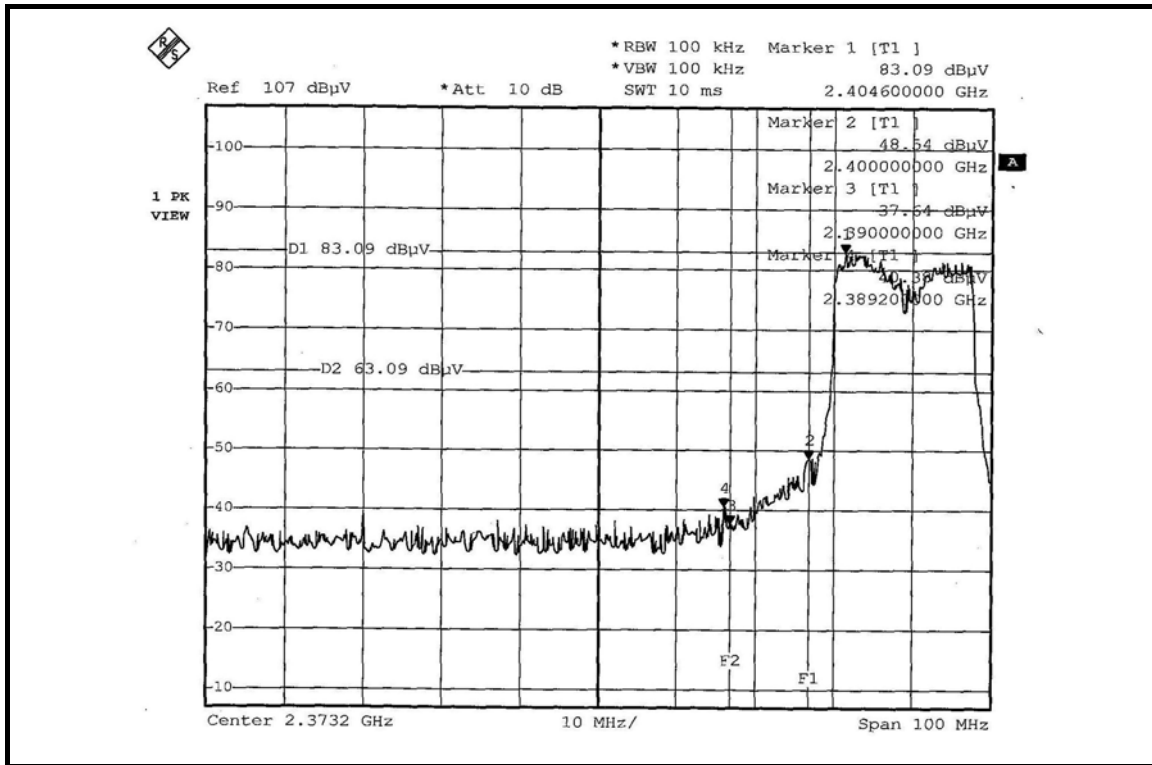
The band edge emission plot of OFDM technique on the next page shows 42.71Bc between carrier maximum power and local maximum emission in restrict band (2.389200000GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 111.04dBuV/m (Peak), so the maximum field strength in restrict band is  $111.04 - 42.71 = 68.33\text{dBuV/m}$  which is under 74dBuV/m limit.

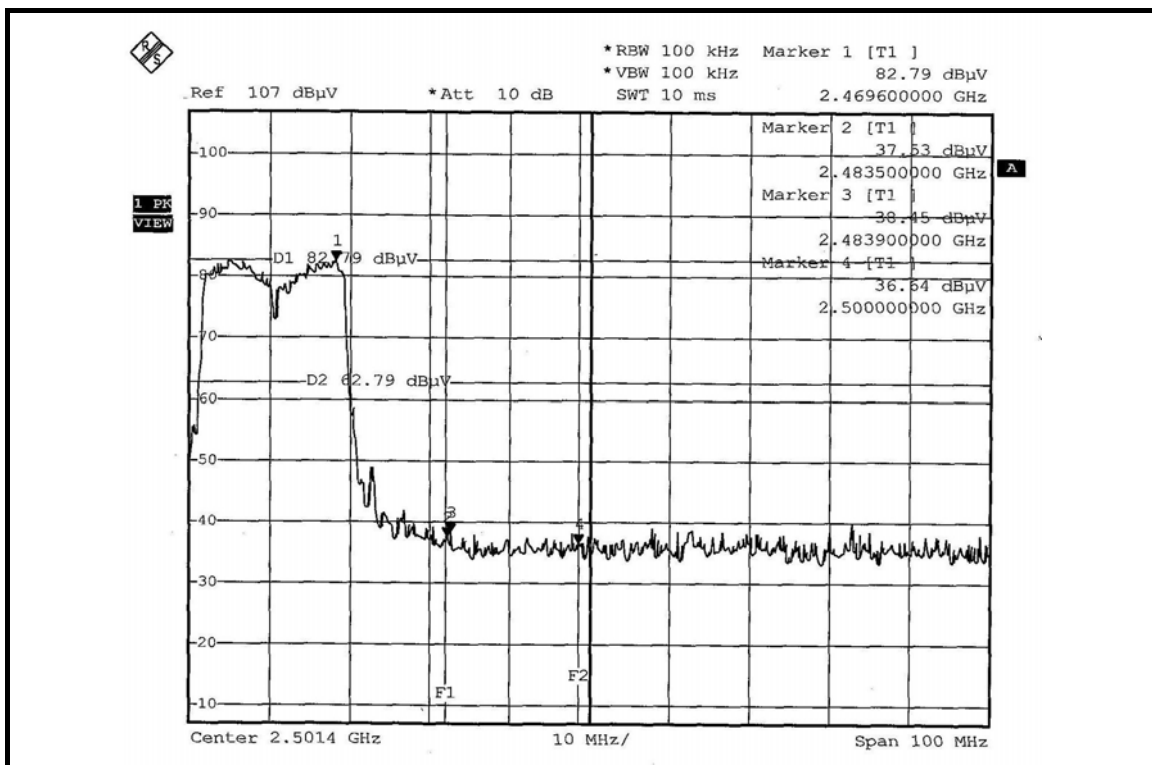
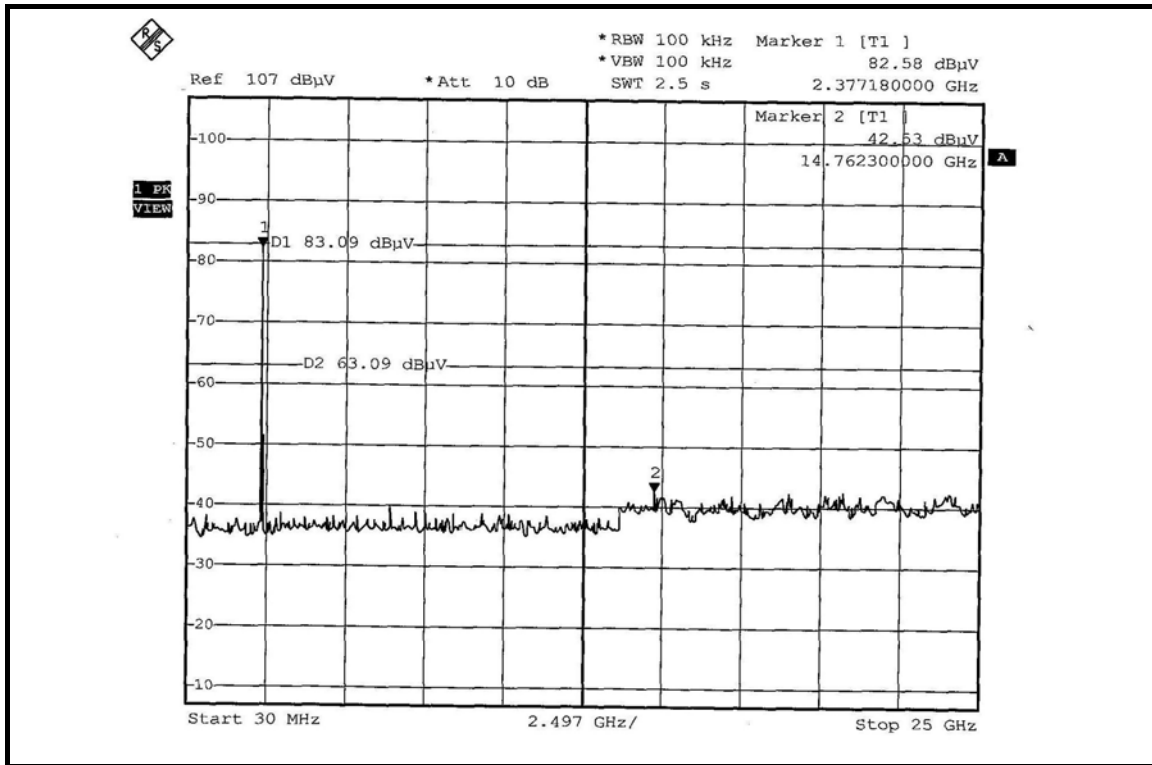
The band edge emission plot of OFDM technique on the next page shows 49.32dBc between carrier maximum power and local maximum emission in restrict band (2.39000GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 101.63dBuV/m (Average), so the maximum field strength in restrict band is  $101.63 - 49.32 = 52.31\text{dBuV/m}$  which is under 54dBuV/m limit.

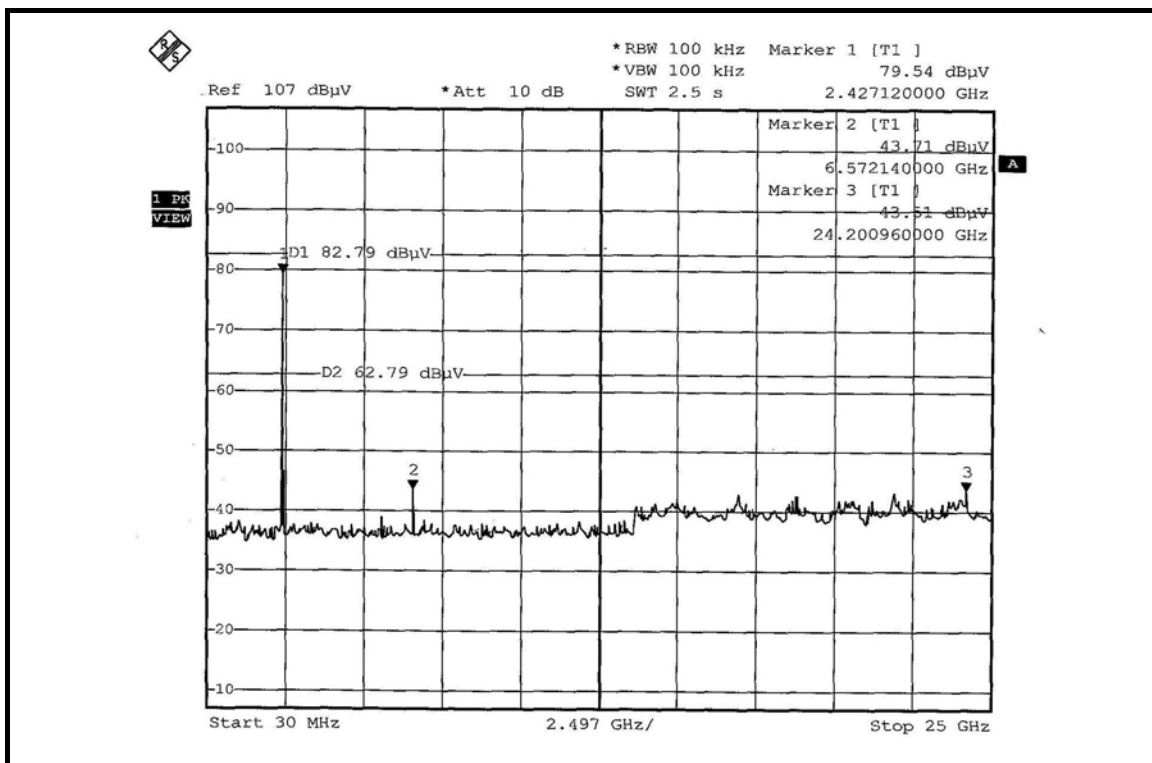
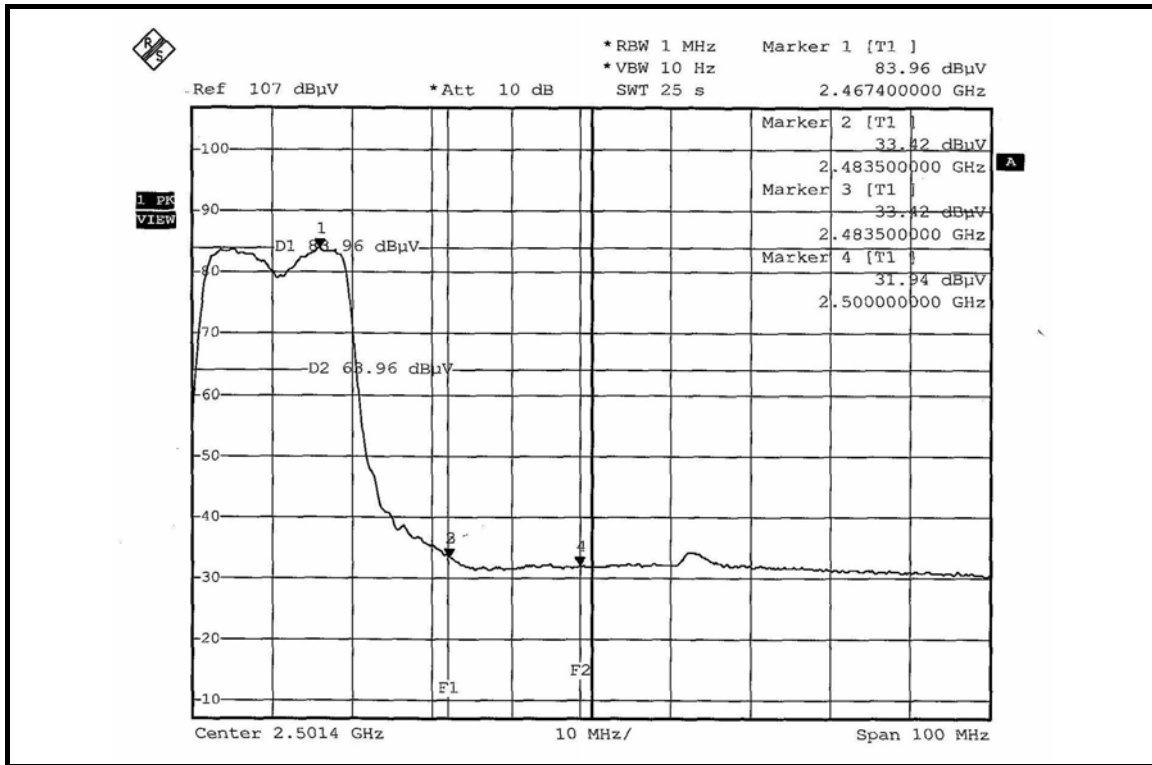
### **NOTE 2:**

The band edge emission plot of OFDM technique on the next second page shows 44.34dBc between carrier maximum power and local maximum emission in restrict band (2.483900000GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 111.27dBuV/m (Peak), so the maximum field strength in restrict band is  $111.27 - 44.34 = 66.93\text{dBuV/m}$  which is under 74dBuV/m limit.

The band edge emission plot of OFDM technique on the next third page shows 50.54dBc between carrier maximum power and local maximum emission in restrict band (2.483500000GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 101.88dBuV/m (Average), so the maximum field strength in restrict band is  $101.88 - 50.54 = 51.34\text{dBuV/m}$  which is under 54dBuV/m limit.

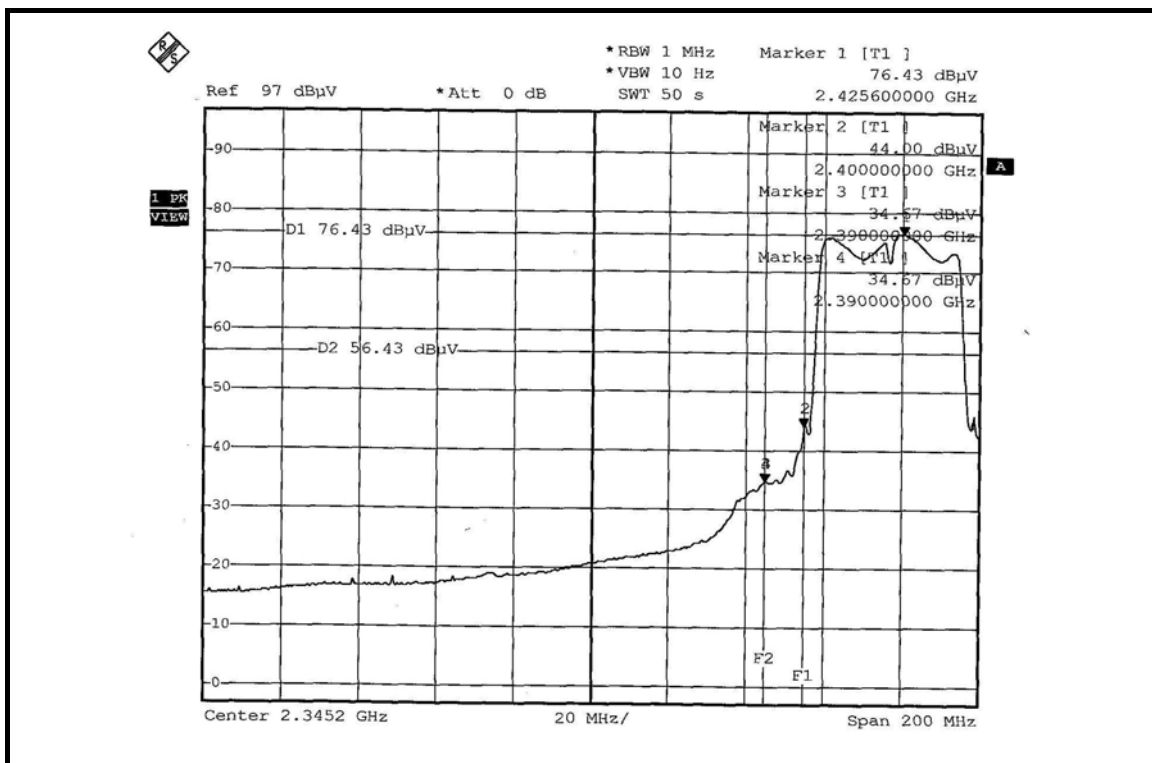
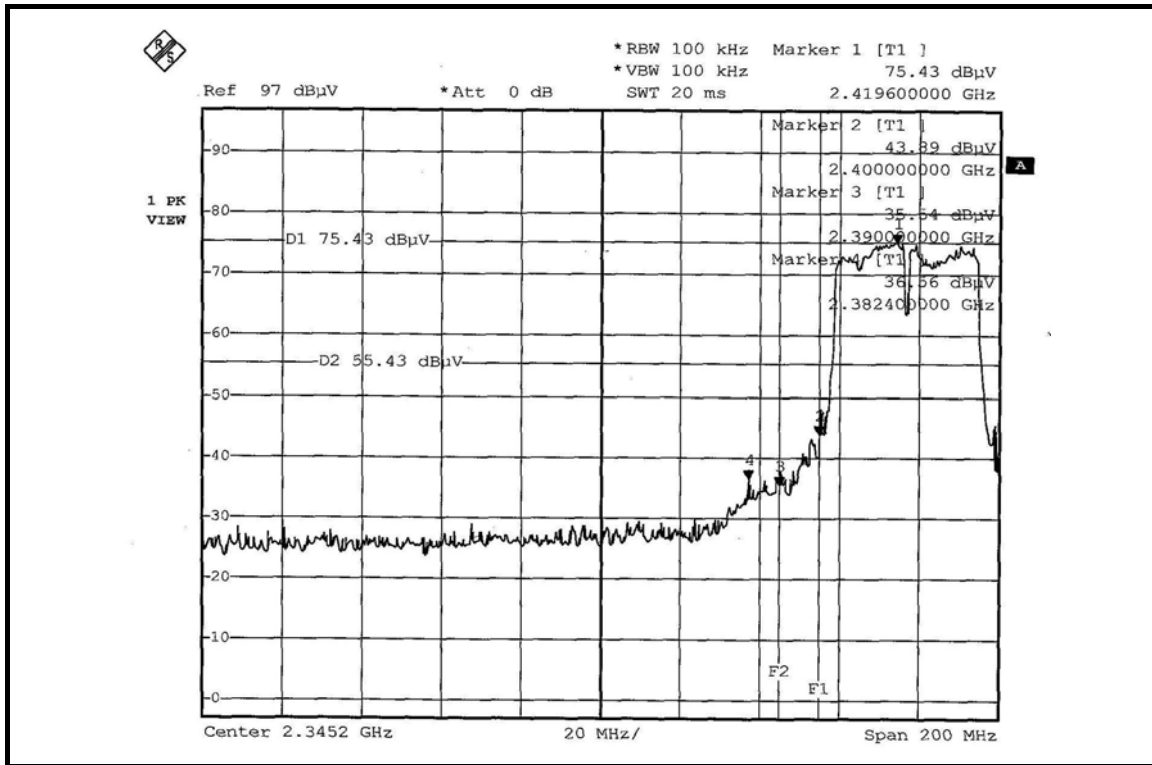
The band edge emission plot of OFDM technique on the next page shows 38.87dBc between carrier maximum power and local maximum emission in restrict band (2.382400000GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 104.50dBuV/m (Peak), so the maximum field strength in restrict band is  $104.50 - 38.87 = 65.63\text{dBuV/m}$  which is under 74dBuV/m limit.

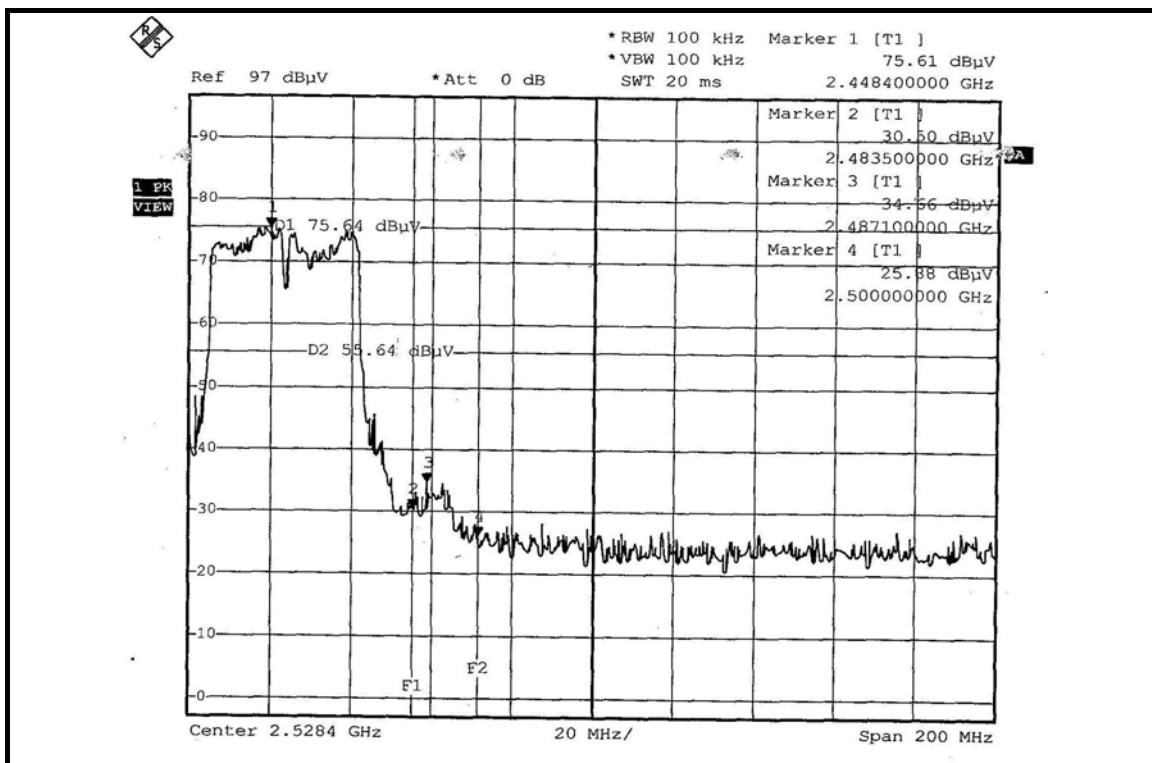
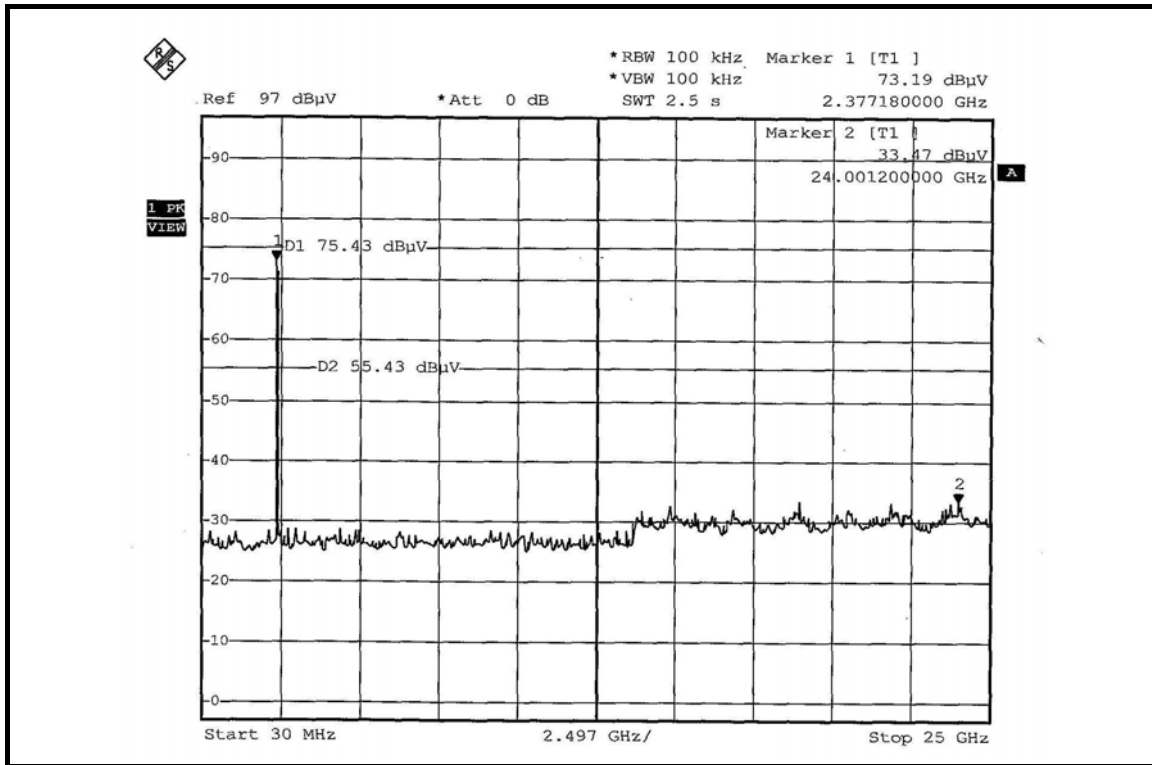
The band edge emission plot of OFDM technique on the next page shows 41.76dBc between carrier maximum power and local maximum emission in restrict band (2.390000000GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 94.71dBuV/m (Average), so the maximum field strength in restrict band is  $94.71 - 41.76 = 52.95\text{dBuV/m}$  which is under 54dBuV/m limit.

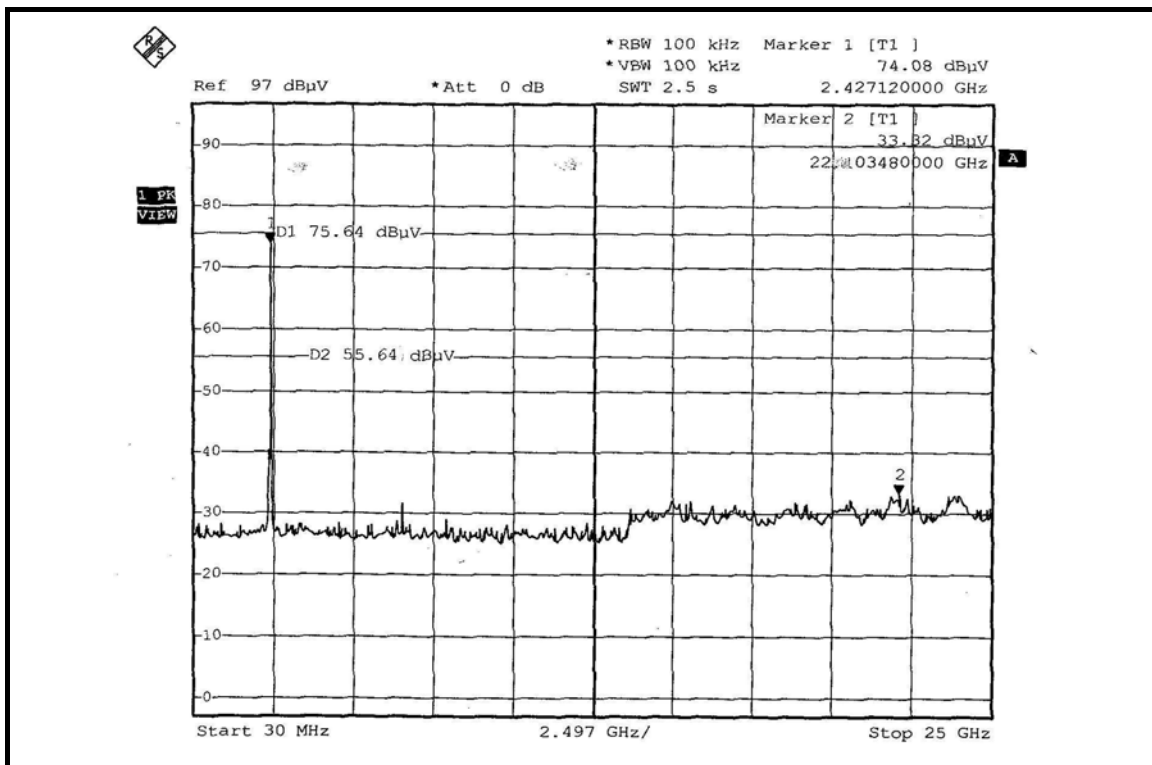
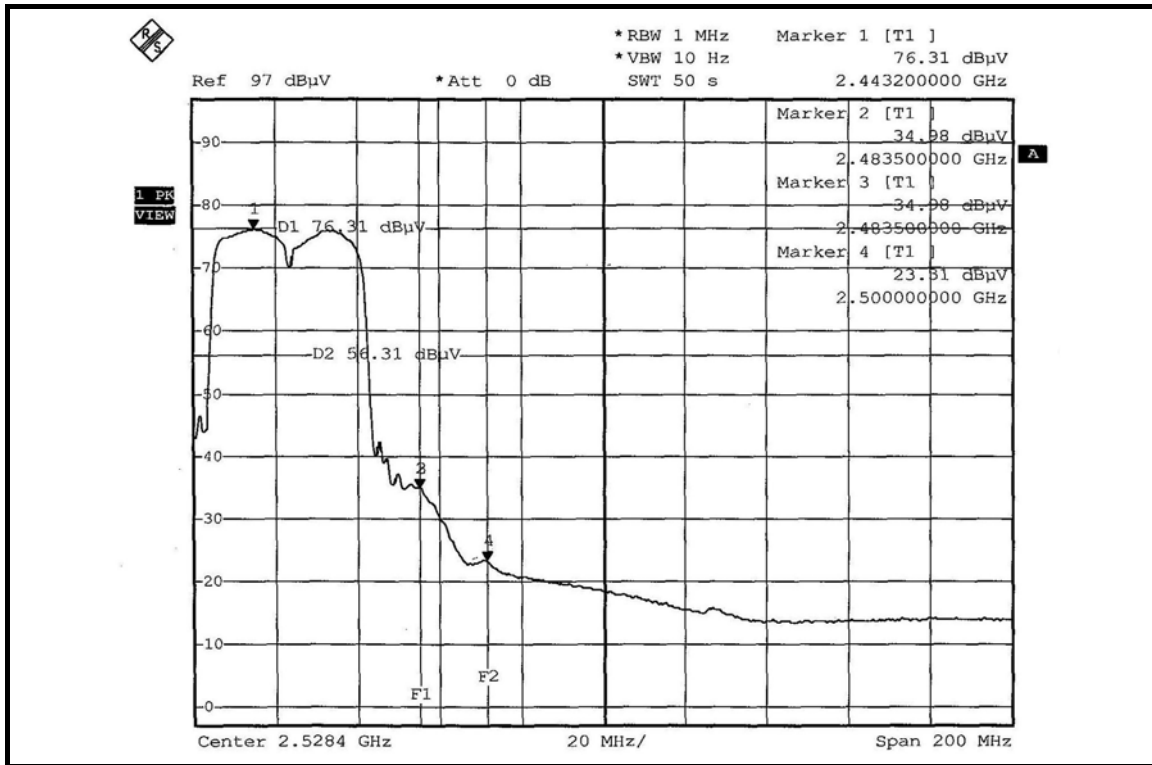

The emission of carrier strength list in the test result of channel 7 at the item 4.2.7 is 103.83dBuV/m (Peak), so the maximum field strength in restrict band is  $103.83 - 40.95 = 62.88\text{dBuV/m}$  which is under 74dBuV/m limit.

The band edge emission plot of OFDM technique on the next third page shows 41.33dBc between carrier maximum power and local maximum emission in restrict band (2.483500000GHz). The emission of carrier strength list in the test result of channel 7 at the item 4.2.7 is 94.30dBuV/m (Average), so the maximum field strength in restrict band is  $94.30 - 41.33 = 52.97\text{dBuV/m}$  which is under 54dBuV/m limit.









## **4.7 ANTENNA REQUIREMENT**

### **4.7.1 STANDARD APPLICABLE**

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

### **4.7.2 ANTENNA CONNECTED CONSTRUCTION**

The antenna used in this product is Printed Dipole antenna without connector. The maximum Gain of the antenna is 1dBi.
