1.5 Operation Configuration

1.6 The SAR Measurement System

A photograph of the SAR measurement System is given in Fig. a. This SAR Measurement System uses a Computer-controlled 3-D stepper motor system (Speag Dasy 4 professional system). A Model ET3DV6 1759 E-field probe is used to determine the internal electric fields. The SAR can be obtained from the equation SAR= σ (|Ei| 2)/ ρ where σ and ρ are the conductivity and mass density of the tissue-simulant.

The DASY4 system for performing compliance tests consists of the following items:

- A standard high precision 6-axis robot (Staubli RX family) with controller, teach pendant and software. An arm extension for accommodating the data acquisition electronics (DAE).
- A dissymmetric probe, i.e., an isotropic E-field probe optimized and calibrated for usage intissue simulating liquid. The probe is equipped with an optical surface detector system.
- A data acquisition electronics (DAE) which performs the signal amplification, signal

multiplexing, AD-conversion, offset measurements, mechanical surface detection, collision detection, etc. The unit is battery powered with standard or rechargeable batteries. The signal is optically transmitted to the EOC.




Fig. a The microwave circuit arrangement used for SAR system verification

In combination with the Twin SAM Phantom V4.0/V4.0C or Twin SAM, the Mounting Device (made from POM) enables the rotation of the mounted transmitter in spherical coordinates, whereby the rotation point is the ear opening. The devices can be easily and accurately positioned according to IEC, IEEE, CENELEC, FCC or other specifications. The device holder can be locked at different phantom locations (left head, right head, flat phantom).

1.8 SAR System Verification

The microwave circuit arrangement for system verification is sketched in Fig. b. The daily system accuracy verification occurs within the flat section of the SAM phantom. A SAR measurement was performed to see if the measured SAR was within +/- 10% from the target SAR values. These tests were done at 1900MHz. The tests were conducted on the same days as the measurement of the DUT. The obtained results from the system accuracy verification are displayed in the table 1 (SAR values are normalized to 1W forward power delivered to the dipole). During the tests, the ambient temperature of the laboratory was in the range 22.3 °C, the relative humidity was in the range 54% and the liquid depth above the ear reference points was above 15 cm in all the cases. It is seen that the system is operating within its specification, as the results are within acceptable tolerance of the reference values.




Fig. b The microwave circuit arrangement used for SAR system verification

1.9 Tissue Simulant Fluid for the Frequency Band 2.4 to 2.5 GHz

The dielectric properties for this body-simulant fluid were measured by using the HP Model 85070D Dielectric Probe (rates frequence band 200 MHz to 20 GHz) in conjuncation with HP 8714ET Network Analyzer(300 KHz-3000 MHz) by using a procedure detailed in Section V.

1.10 Test Standards and Limits

According to FCC 47CFR §2.1093(d) The limits to be used for evaluation are based generally on criteria published by the American National Standards Institute (ANSI) for localized specific absorption rate ("SAR") in Section 4.2 of "IEEE Standard for Safety Levels with Respect to Human Exposure to Radio Frequency Electromagnetic Fields, 3 kHz to 300 GHz," ANSI/IEEE C95.1-1992, Copyright 1992 by the Institute of Electrical and Electronics Engineers, Inc., New York, New York 10017. These criteria for SAR evaluation are similar to those recommended by the National Council on Radiation Protection and Measurements (NCRP) in "Biological Effects and Exposure Criteria for Radiofrequency Electromagnetic Fields," NCRP Report No. 86, Section 17.4.5. Copyright NCRP, 1986, Bethesda, Maryland 20814. SAR is a measure of the rate of energy absorption due to exposure to an RF transmitting source. SAR values have been related to threshold levels for potential biological hazards. The criteria to be used are specified in paragraphs (d)(1) and (d)(2) of this section and shall apply for portable devices transmitting in the frequency range from 100 kHz to 6 GHz. Portable devices that transmit at frequencies above 6 GHz are to be evaluated in terms of the MPE limits specified in § 1.1310 of this chapter. Measurements and calculations to demonstrate compliance with MPE field strength or power density limits for devices operating above 6 GHz should be made at a minimum distance of 5 cm from the radiating source.

(1) Limits for Occupational/Controlled exposure: 0.4 W/kg as averaged over the whole-body and spatial peak SAR not exceeding 8 W/kg as averaged over any 1 gram of tissue (defined as a tissue volume in the shape of a cube). 




Fig.4 Photograph of the edge of the PC at 90° and at a distance of 1.5 cm from the base of the phantom.




Fig.5 Photograph of the Bottom of the Pc is paralleled and at a distance of 0.0 cm from the base of the phantom.




Fig.6 Photograph of the Bottom of the Pc is paralleled and at a distance of 0.0 cm from the base of the phantom.




Fig.7 Photograph of the Bottom of the Pc is paralleled and at a distance of 0.0 cm from the base of the phantom, but 1.0 cm Spacing between EUT & Planar Phantom




Fig.8 Photograph of the Tissue Simulant Fluid liquid depth 15cm





Isotropy Error (ϕ), $\theta = 0^{\circ}$





