1 MPE EVALUATION OF MOBILE DEVICES

Pt= EIRP in mW Pi= 3.1416

R= Measurement distance

CONCULSION:

Both of the WLAN 2.4G & 5.0G can transmit simultaneously, the formula of calculated the MPE is:

CPD1 / LPD1 + CPD2 / LPD2 +etc. < 1

CPD = Calculation power density

LPD = Limit of power density

1. WLAN 2.4G + WLAN 5.2G = 0.043 / 1 + 0.099 / 1 = 0.142

2. WLAN 2.4G + WLAN 5.8G = 0.043 / 1 + 0.073 / 1 = 0.116

Therefore, the maximum calculation of this situation is 0.142, which is less than the "1" limit.
