## Before You Begin

This Quick Installation Guide gives you step-by-step instructions for setting up your DIS-2650AP Wireless Access Point. The model you have purchased may appear slightly different from the one shown in the illustrations. For more detailed information about the router, please refer to the User Manual.

## Hardware Overview

### Front Panel Features

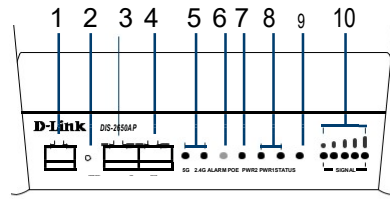


Figure 1: Front Panel

| #  | Feature      | Description   |
|----|--------------|---|
| 1  | Console Port | Console port which is used to connect to the device using an RJ-45 to serial cable. |
| 2  | Reset Button | Press and hold to perform a factory reset.  |
| 3  | LAN2         | 10/100/1000 Mbps Ethernet LAN port.   |
| 4  | LAN1/PoE     | PoE-capable Ethernet LAN port.  |
| 5  | 5G/2.4G LED  | A green LED indicates the DIS-2650AP is receiving power.                            |
| 6  | Alarm        | A light indicates that the power supply has failed.                                 |
| 7  | PoE          | Indicates whether a device is receiving power on the PoE port.                      |
| 8  | PWR1/2       | Indicates whether power sources 1 and 2 are connected.                              |
| 9  | Status       | Indicates the device's operational status.  |
| 10 | Signal       | Indicates the strength of the signal the device is receiving.                       |

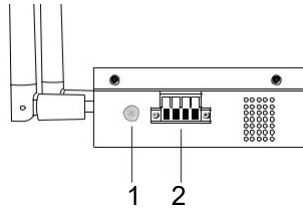


Figure 2: Left Panel Interface Connectors

## Hardware Installation

### Before You Begin

Observe the following precautions to help prevent shutdowns, equipment failures, and personal injury:

- Install the DIS-2650AP in a cool and dry place.
- Install the DIS-2650AP in a site free from strong electromagnetic sources, vibration, dust, excessive moisture, and direct sunlight.
- Place antennas in an unobstructed area with a clear signal. Avoid metal boxes, brick walls, and other dense materials.
- Visually inspect the power connector and make sure that it is fully secure.
- Do not stack any devices on top of the DIS-2650AP.

## Attach the External Antennas

The DIS-2650AP requires two external antennas to function correctly. The included antennas are interchangeable.

1. Attach the two included antennas to the RP-SMA connectors on the side of the DIS-2650AP. Turn clockwise to fasten the antennas.
2. Arrange the antennas so that they're pointing upwards and in a configuration to receive optimal signals.

## Mounting the Device on a Wall

The DIS-2650AP can be installed on a solid surface by using the included wall mounting plates attached to the back of the device. Use the following instructions to install the DIS-2650AP on a wall:

1. Align the cross-section of the mounting plates with the openings on the back of the device. Secure the plates with the included mounting screws.

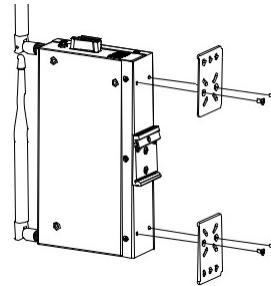


Figure 3: Attaching Mounting Plates

2. Remove the DIN rail mounting clip from the back of the device (if present).

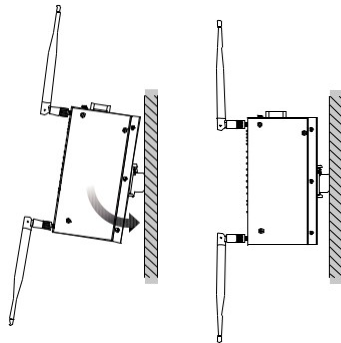
3. Place the mounting brackets (attached to the device) on the location where you want to mount it, and use the brackets as a guide to mark where to drill the screw holes.
4. Drill holes on the marks and insert wall anchors appropriate for the material of the wall.
5. Align the device with the wall anchors and secure it to the wall using appropriate screws for the wall anchors.

### Installing the Device on a DIN Rail

The DIS-2650AP can be mounted on a standard DIN rail using the included DIN mounting kit.

Use the following instructions to install the DIS-2650AP on a rail:

1. Check that the DIN rail is installed properly using at least two screws on each end.
2. Fasten the DIN mounting clip to the rear panel of the device using the included mounting screws.



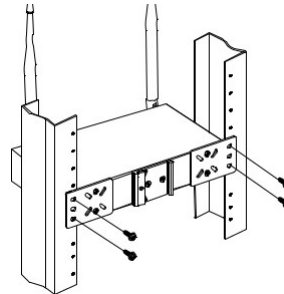
**Figure 4: Hooking onto the Rail**

3. Position the DIS-2650AP against the rail, then tilt it upwards and hook the DIN rail clip on the back of the device against the rail. Snap the device into place to complete the installation.

### Installing the Device into a Rack

The DIS-2650AP can be mounted on a standard rack using the included mounting plates. To install the device on a rack:

1. Attach the mounting brackets to the rear panel of the device using the provided installation screws.

2. Use the provided screws to attach the two rear mounting plates to the rack.

### Grounding the Device

To use the DIS-2650AP safely, it needs to be grounded. Please complete these steps before powering on the device.

1. Remove the grounding screw from the top of the DIS-2650AP and place the grounding cable lug ring on top of the grounding screw opening.
2. Insert the grounding screw back into the grounding screw opening and use a screwdriver to tighten the grounding screw, securing the grounding cable to the DIS-2650AP.
3. Attach the terminal lug ring at the other end of the grounding cable to an appropriate grounding source.

## Powering the Device

The DIS-2650AP can be powered with an 802.3at PoE source or by using the built-in terminal adapter. This allows dual power inputs using wires from the power source(s) to be screwed into the terminal connections.

### Using the Terminal Connections

1. Before continuing, consult the diagram below to decide which wires from the power source need to connect to which contacts on the terminal block. Note that two power sources can be used; one inserted into V1-/V1+ (labeled PWR 1) and the other inserted into V2-/V2+ (labeled PWR2).

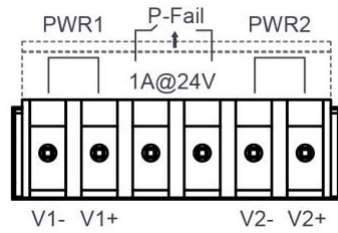


Figure 6: Terminal Block Diagram

2. Use a lever to remove the terminal block from the switch.

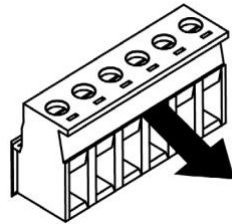


Figure 7: Removing the Terminal Block

3. Use a flat head screwdriver to unscrew the terminal connections that you wish to use.
4. Insert the wires into the terminal connection and use the screwdriver to tighten the screws to secure the wires.

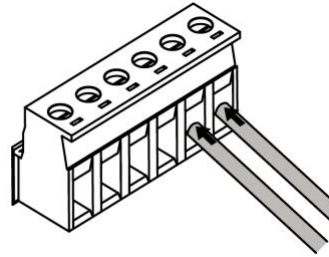


Figure 8: Connecting a Power Source to the Terminal Block

5. Re-insert the terminal block into the socket on the device.

## Connecting Devices

The Ethernet port can be connected to an end device. Use a standard Category 5/5e/6 RJ-45 Ethernet cable to connect the end device to the DIS-2650AP.

The port will auto-negotiate to the highest possible port speed based on the connected device.

## Management Options

The DIS-2650AP can be managed by using the Web User Interface (Web UI), the Nuclias Connect app, or the console port or Telnet management interfaces.

### Nuclias Connect App Configuration

1. Download the free Nuclias Connect app from the App Store or Google Play by searching for **Nuclias Connect** or by scanning the QR code below.



2. Open the Nuclias Connect app and follow the onscreen instructions to discover and set up your device.

### Manual Configuration

**Note:** The management computer, DHCP server and DIS-2650AP must be in the same subnet.

Use one of the following methods to access the web user interface:

#### Connecting through Ethernet

1. Use an Ethernet cable to connect the DIS-2650AP to the management computer, or to the switch or router the management computer is connected to.
2. Manage the access point from a computer. Enter **dis2650ap.local** in the address field of your browser.
3. Log in to the administration user interface. The default information is:

### Connecting Wirelessly

1. Connect the management computer to the default SSID of the DIS-2650AP, "**dlink**."

# Appendix - Statements

## ErP Power Usage

This device is an Energy Related Product (ErP) that automatically switches to a power-saving Network Standby mode within 1 minute of no packets being transmitted. It can also be turned off through a power switch to save energy when it is not needed.
