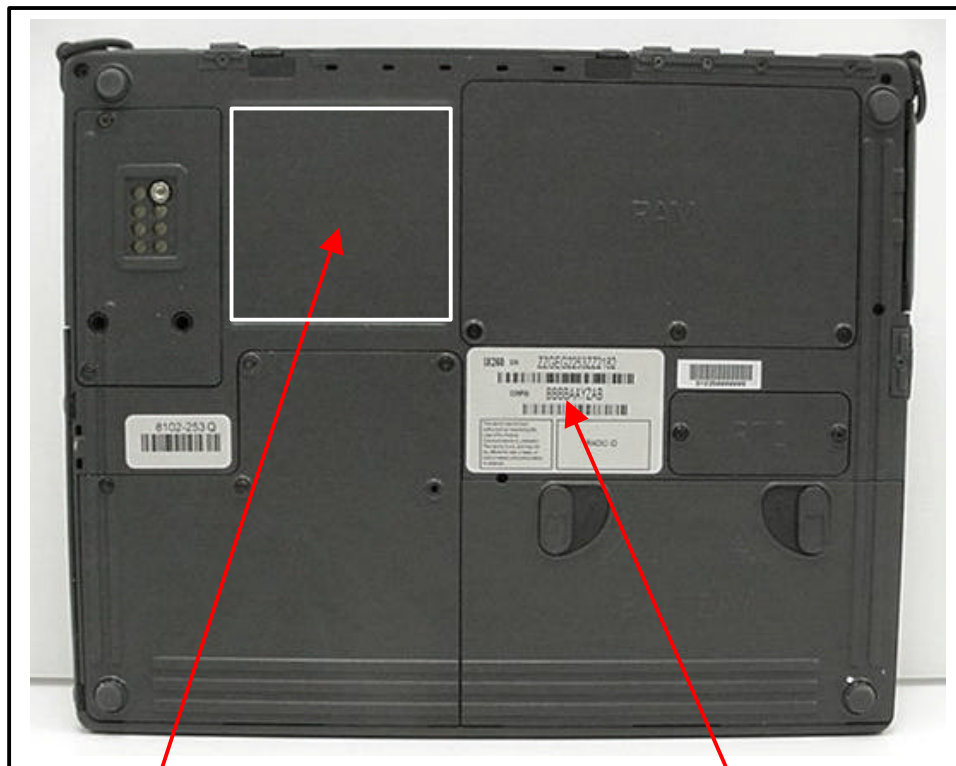

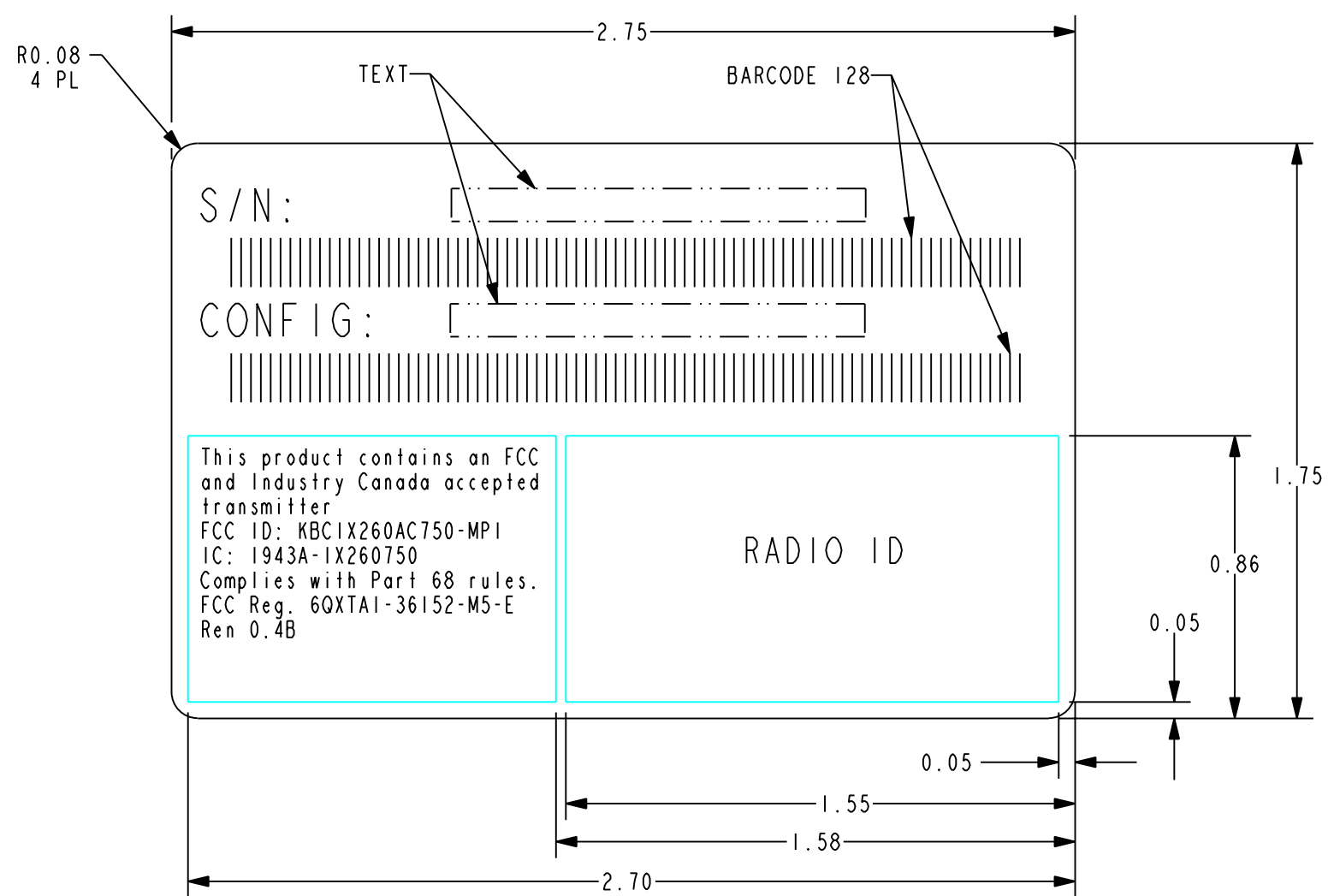
The label shall be permanently affixed at a conspicuous location on the device.



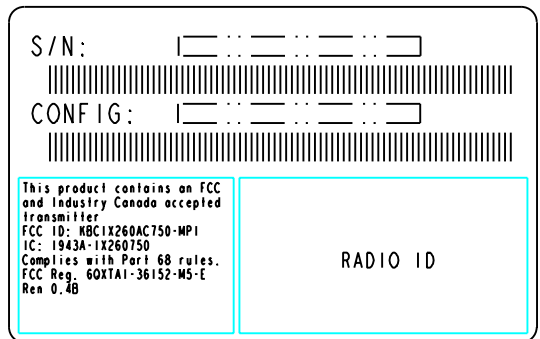

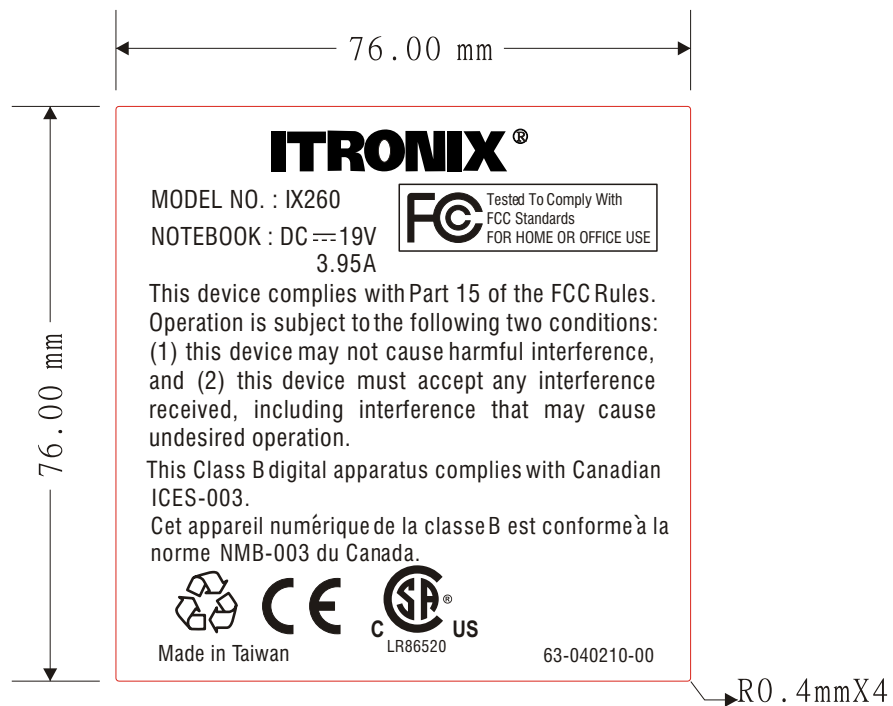
