In authorizing Zacta as our agent, we still recognize that we are responsible to:

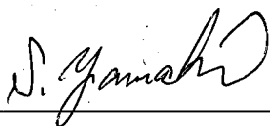
- a) comply with the relevant provisions of the certification program;
