Below is the response I received from Rod Thorne our Compliance Officer which should answer questions 1 and 2:

How to Certify to FCC 15.240

1. Theory of Operation must be consistent with the FCC Public Letter From Wiley Rein & Fielding dated November 30, 2005. [Enclosed]
2. A copy of this letter is to be enclosed with each filing according to the e-mail instructions from Rashmi Doshi of the FCC dated December 6, 2005. This same e-mail carries a declaration from Julius Knapp that the operations described in the letter are permissible. [e-mail enclosed]
3. Readers certified to 15.240 are to have their installed locations registered with the FCC.
4. Reader manuals must contain the notifications to the End User listed in the text of FCC Rule 15.240.
5. Tags certified to 15.240 are mobile slave devices which default to operation under 15.231 unless they are queried by a properly certified and registered Reader. Therefore, tag locations are not registered with the FCC. [See enclosed e-mail correspondence with Dennis Ward on the ST-656 which was certified to 15.240 in December '05.]

Attached is a revised letter confidentiality letter as requested which should answer question 3.
