1. Scope

This test report certifies that the Secure Care Patient ENVisionIT All in One Tag as tested, meets the FCC Part 15, Subpart F requirements. The scope of this test report is limited to the test sample provided by the client, only in as much as that sample represents other production units. If any significant changes are made to the unit, the changes shall be evaluated and a retest may be required. Revision R1 adds 15.519(a)(1) information to the test report, corrects references to 15.515, and removes RF Exposure from the report. Revision R2 clarifies the RMS and Peak Power EIRP Measurements on pages 23 & 24. Revision R3 updates the RMS and Peak Power EIRP measurement plots to dB μ V/m on pages 23 and 24.

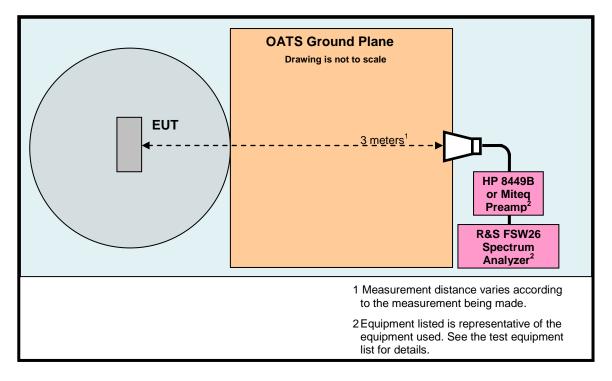

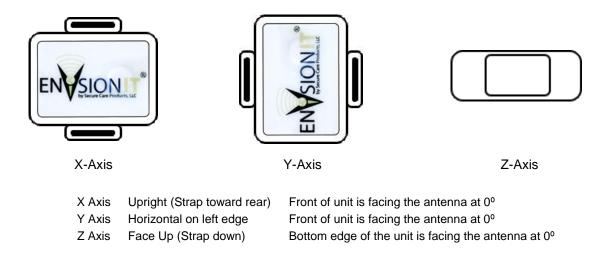

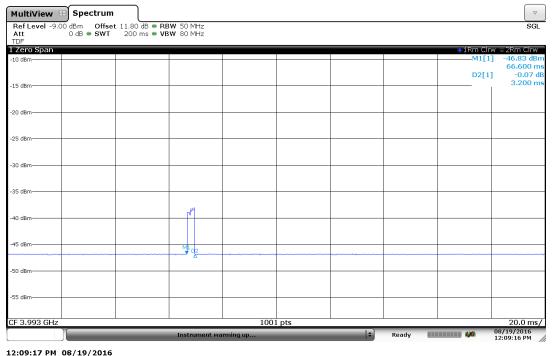

Requirement: UWB device operating under the provisions of this section must be hand held, i.e., they are relatively small device that are primarily hand held while being operated and do not employ a fixed infrastructure. UWB devices operating under the provisions of this section may operate indoors or outdoors.

A UWB device operating under the provisions of this section shall transmit only when it is sending information to an associated receiver. The UWB intentional radiator shall cease transmission within 10 seconds unless it receives an acknowledgement from the associated receiver that its transmission is being received. An acknowledgment of reception must continue to be received by the UWB intentional radiator at least every 10 seconds or the UWB device must cease transmitting.

Result: Compliant, the EUT transmits a 3.2 mS burst of location information every 3 seconds to an associated receiver.

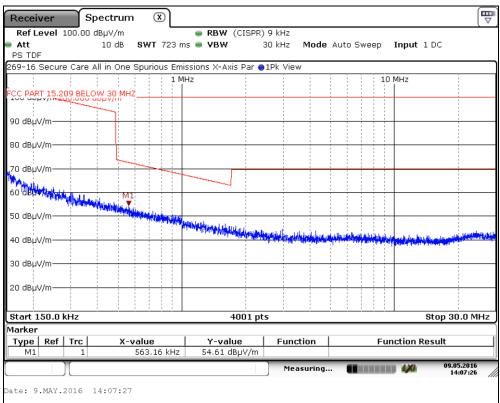

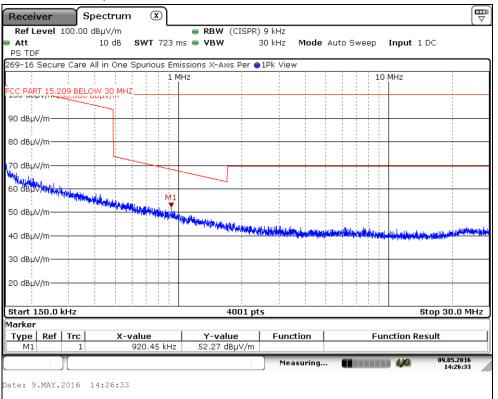

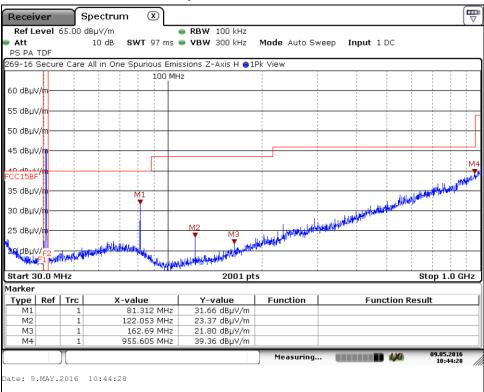

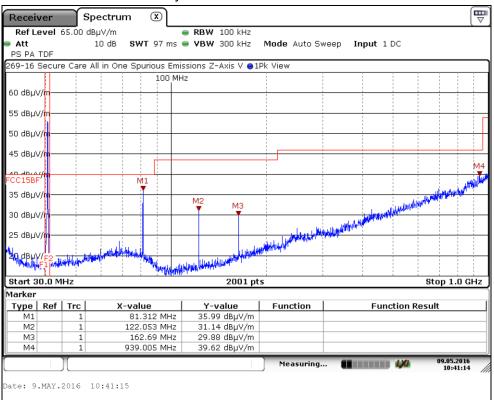

7. Test Site Description

Compliance Worldwide is located at 357 Main Street in Sandown, New Hampshire. The test sites at Compliance Worldwide are used for conducted and radiated emissions testing in accordance with with Federal Communications Commission (FCC) and Industry Canada standards. Through our American Association for Laboratory Accreditation (A2LA) ISO Guide 17025:2005 Accreditation our test sites are designated with the FCC (designation number **US1091**), Industry Canada (file number **IC 3023A-1)** and VCCI (Member number 3168) under registration number A-0208.

Compliance Worldwide is also designated as a Phase 1 CAB under APEC-MRA (US0132) for Australia/New Zealand AS/NZS CISPR 22, Chinese-Taipei (Taiwan) BSMI CNS 13438 and Korea (RRA) KN 11, KN 13, KN 14-1, KN 22, KN 32, KN 61000-6-3, KN 61000-6-4.

The radiated emissions test site is a 3 and 10 meter enclosed open area test site (OATS). Personnel, support equipment and test equipment are located in the basement beneath the OATS ground plane.

The conducted emissions site is part of a 16' x 20' x 12' ferrite tile chamber and uses one of the walls for the vertical ground plane required by EN 55022. A second conducted emissions site is also located in the basement of the OATS site with a 2.3 x 2.5 meter ground plane and a 2.4 x 2.4 meter vertical wall.

Both sites are designed to test products or systems 1.5 meters W x 1.5 meters L x 2.0 meters H, floor standing or table top.
