# 10.1.1 Regulation

15.203 An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of Part 15C. The manufacturer may design the unit so that the user can replace a broken antenna, but the use of a standard antenna jack or electrical connector is prohibited. - (c) The level of any unwanted emissions from an intentional radiator operating under these general provisions shall not exceed the level of the fundamental emission. For intentional radiators which operate under the provisions of other sections within this part and which are required to reduce their unwanted emissions to the limits specified in this table, the limits in this table are based on the frequency of the unwanted emission and not the fundamental frequency. However, the level of any unwanted emissions shall not exceed the level of the fundamental frequency.
- (d) The emission limits shown in the above table are based on measurements employing a CISPR quasi peak detector except for the frequency bands 9-90 kHz, 110-490 kHz and above 1000 MHz. Radiated emission limits in these three bands are based on measurements employing an average detector.

# 10.2.3 Test procedures

The EUT and this peripheral (when additional equipment exist) are placed on a turn table which is 0.8 m above the ground. The turn table would be allowed to rotate 360 degrees to determine the position of the maximum emission level. The test distance between the EUT and the receiving antenna are 3m. To find the maximum emission, the polarization of the receiving antenna is changed in horizontal and vertical polarization, the position of the EUT was changed in different orthogonal determinations. The Receiver reading gives not directly the field strength result in  $(dB\mu V/m)$ . The antenna factors of the loop antenna and cable losses must be added to find the correct result.

The receiver reading is 32.7 dB $\mu$ V. The antenna factor for the measured frequency is +2.5 dB(1/m) and the cable factor for the measured frequency is 0.71 dB, giving a field strength of 35.91dB $\mu$ V/m. The 35.91dB $\mu$ V/m value can be mathematically converted to its corresponding level in  $\mu$ V/m.

#### 10.2.7 Calculation of Average Correction Factor

The average correction factor is computed by analyzing the "worst case" on time in any 100msec time period and using the formula: Corrections Factor + 20\*Iog (worst case on time/100msec) Analysis of the remote transmitter worst case on time in any 100msec time period is an on time of 50msec, there for the correction factor is 20\*Iog(50/100) = -6 dB. The maximum correction factor to be applied is 20 dB per section 15.35 of the FCC rules.
