7. Operational description

7.1 EUT details

RF transmitter, tire guard wheel unit

7.2 EUT configuration

The EUT can operate in different transmitting modes (CW- mode, Burst mode). For activating the modes an external trigger box was used. The EUT operated in normal mode for transmission time measurements.

7.3 EUT measurement description

The EUT was tested in a typical fashion. During preliminary emission tests the EUT was operated in continuous transmitting mode for worst case emission mode investigation. Therefore, the final qualification testing was completed with the EUT operated in continuous modes.

All tests were performed with the applicant's typical voltage: 3.0 V DC

In order to establish the maximum radiation, firstly, there have been viewed all orthogonal adjustments of the test samples, secondly the test ample have been rotated at all adjustments around the own axis between 0° and 360° , and thirdly, the antenna polarization between horizontal and vertical had been varied.

8.2.1 Regulation

For intentional radiators which operate under the provisions of other sections within this part and which are required to reduce their unwanted emissions to the limits specified in this table, the limits in this table are based on the frequency of the unwanted emission and not the fundamental frequency. However, the level of any unwanted emissions shall not exceed the level of the fundamental frequency.

Analysis of the remote transmitter worst case on time in any 100msec time period is an on time of 50msec, therefore the correction factor is $20*\log(50/100) = -6$ dB. The maximum correction factor to be applied is 20 dB per section 15.35 of the FCC rules.

8.6.6 Calculation of the field strengths

The field strength is calculated by the following calculation:

Corrected Level = Receiver Level + Correction Factor (without the use of a pre-amplifier)

Corrected Level = Receiver Level + Correction Factor – Pre-Amplifier (with the use of a pre-amplifier)

Receiver Level: Receiver reading without correction factorsCorrection Factor: Antenna factor + cable loss

For test distance other than what is specified, but fulfilling the requirements of Section 15.31 (f) (1) the field strength is calculated by adding additionally an extrapolation factor of 20 dB/decade (inverse linear distance for field strength measurements).

8.7 Bandwidth (20 dB)

8.7.1 Regulation

(c) The bandwidth of the emission shall be no wider than 0.25% of the center frequency for devices operating above 70 MHz and below 900 MHz. For devices operating above 900 MHz, the emission shall be no wider than 0.5% of the center frequency. Bandwidth is determined at the points 20 dB down from the modulated carrier.
