Re: Request Under Section 2.933 For Change In FCC Identifiers NTTR1920, NTTR1910-1, NTTR810 and NTTR820

Dear Mr. Fabina:

This cover letter accompanies an application (FCC Form 731) submitted by Andrew Corporation ("Andrew") under Section 2.933 of the Rules to request a change in the above referenced FCC Identifiers in connection with the acquisition by Andrew of certain cellular and PCS repeater assets of WJ Communications, Inc. (formerly, Watkins-Johnson Company) ("WJCI"). The sale of WJCI's cellular and PCS repeater business to Andrew was consummated on September 5, 2002. The asset sale included all necessary equipment, material, intellectual property, training, service and warranty provisions for the WJCI repeaters authorized under the above referenced FCC Identifiers. Andrew has not sold any of these repeaters pending FCC grant of the accompanying application. The repeaters and their original and new (requested) FCC Identifiers are as follows:

As indicated by the above dates of grant, none of the original equipment authorizations for the devices involved in this transfer was granted either before August 1, 1996 or five years or more before the filing of this application. Accordingly, Andrew understands that neither a



demonstration of compliance with the RF safety rules nor information listed in Section 2.1033 of the Rules is required to accompany this application.

Pursuant to Section 2.933(b)(3) and (4) of the Rules, Andrew hereby certifies that this equipment, as manufactured and sold by Andrew, will not differ from the original equipment and that the original test results continue to be representative of the equipment bearing the changed identification. Submitted with this application are the external photographs required by Section 2.933(b)(5) in accordance with the specifications set forth in Section 2.1033(c)(12) of the Rules. Also included with this application is a copy of Andrew's FCC ID label for the equipment.

Andrew is a global supplier of communications equipment, solutions and services. Andrew products include a complete line of broadcast, broadband, microwave, earth station and mobile base station antennas, coaxial cables and connectors, and in-building wireless distributed communications systems. In the latter category, Andrew's well established portfolio of in-building distributed communications solutions includes PROPAGATORTM Repeaters, InCellTM Fiber Optic Distributed Antenna Systems, Cell-MaxTM Antennas, RADIAX® Slotted Coaxial Cables and HELIAX® Foam Dielectric Cables. Andrew has been issued numerous equipment authorizations by the Commission under Grantee Code KUW for amplifiers, repeaters and other products similar to those acquired from WJCI. As such, the Commission can be confident that Andrew will adequately ensure and accept responsibility for continued compliance with the Commission's Part 2 regulations with respect to the above-referenced Equipment Authorizations to be transferred from WJCI.
