These units are professionally installed against the wall. The installer will mount the back plate to the wall before attaching the main unit to the back plate with a screw at the bottom of the main enclosure. For long-term visibility of the compliance label – it is installed on the inside of the back plate, rather than the back side, which would be against the wall. It is a permanently visible label whenever the batteries are changed.




