To install and replace the battery

- 1) Unscrew and open the battery door under the vehicle with a screwdriver
- 2) Install 1 x 9V Battery with the correct polarity
- 3) Replace the battery door and tighten the screw

Caution:

- 1. Your transceiver set has been fully adjusted prior to shipment from the factory. Be sure not to touch the internal components other than replace batteries
- 2. When the sound becomes weak, it is time to change the battery

- Press "Talk" (the left car light) to transmit
- Release "Talk" (the left car light) to receive
- When transmitting, speak in a clear voice with the microphone about 3 inches (7.5 cm) from your mouth
