This report details the results of compliance tests which were performed in accordance with the requirements of:

FCC CFR 47 Part 15, Subpart B, Oct. 1, 2000, Class B Digital Devices, Unintentional Radiators IC ICES-003, Nov. 22, 1997, Class B Digital Devices, Unintentional Radiators

## B) Product Identification

The equipment under test (EUT) was tested at the Research In Motion (RIM) EMI test facility, located

The testing began on November 21, 2003 and completed on November 23, 2003. The sample equipment under test (EUT) included:

- 1. BlackBerry Wireless Handheld, model number RAN21CN, ASY-06708-001, identification number E2PRF05, FCC ID L6ARAN21CN, IC: 2503A-RAN21CN.
- 2. Travel Charger, model number PSM05R-050Q, part number ASY-04078-001 with an output voltage of 5.0 volts dc. The output lead length was 1.94 metres long.
- 3. USB Docking/Charging Cradle part number ASY-05821-001. The lead length was 1.9 metres.
- 4. External Battery Charger model number BCM6710A, ASY-06630-001. The dc output was rated at 4.2 volts, 0.75 amps for charging the internal battery and 5.1 volts, 0.75 amps for charging an external battery.
- USB Data Cable part number ASY-06005-001. The lead length was 1.4 metres long. 5.
- 6. Headset model number HDW-03458-001. The lead length was 1.25 metres long.

The transmit frequency bands for the Handheld are: Cellular 824 to 849 MHz and PCS 1850 to 1910 MHz.

#### F) Modifications to EUT

No modifications were required on the EUT.

## G) Summary of Results

#### a) CONDUCTED EMISSIONS

The conducted emissions were measured while using the test procedure outlined in CISPR Recommendation 22 through a 50 ohm Line Impedance Stabilization Network (LISN), which was inserted in the power line to the equipment to provide the specified impedance for measurements. The EUT was placed on a nonconductive wooden table, 80 cm high that was positioned 40 cm from a vertical ground plane. The RF output of the network was connected to an EMI receiver system with characteristics that duplicate those of the receiver specified in CISPR Publication 16.

The following test configurations were measured:

- o The Travel Charger was connected to the Handheld in battery charge mode.
- o The External Battery Charger was connected to the Handheld in battery charge mode. The ac input was 120 volts, 60 Hz.

The sample EUT's conducted emissions were compared with respect to the FCC CFR 47 Part 15, Subpart B and IC ICES-003, Class B limit. The sample EUT's lowest emission test margin was 12.13 dB at 0.484 MHz.

#### b) RADIATED EMISSIONS

The radiated emissions from the EUT were measured using the methods outlined in CISPR Recommendation 22. The EUT was placed on a nonconductive wooden table, 80 cm high that was positioned on a remotely rotatable turntable. The test distance used between the EUT and the receiving antenna was three metres. The turntable was rotated to determine the azimuth of the peak emissions. At this point the emissions were maximized by elevating the antenna in the range of 1 to 4 metres. The maximum emission level was recorded. The frequency range measured was from 30 MHz to 1.0 GHz. Both the horizontal and vertical polarisations of the emissions were measured.

The measurements were done in a semi-anechoic chamber. The semi-anechoic chamber FCC registration number is **778487** and the Industry Canada file number is **IC4240**.

The EUT was configured and operated to produce the maximum radiated emissions while still keeping within RIM's specifications.

The following test configurations were measured:

- o The Handheld was connected to the Travel Charger.
- o The Handheld was connected to the support PC via the USB Docking/Charging Cradle for charging and data link.
- o The Handheld was connected to the External Battery Charger.

The system's radiated emission levels in idle mode were compared with respect to the FCC CFR 47 Part 15, Subpart B and IC ICES-003, Class B limit.

The system **passed** with the lowest emission test margin of 2.09 dB at 66.033 MHz.

#### **Sample Calculation:**

Field Strength ( $dB\mu V/M$ ) is calculated as follows: FS = Measured Level ( $dB\mu V$ ) + A.F. (dB/m) + Cable Loss (dB) - Preamp (dB) + Filter Loss (dB)







The Handheld was operating in battery charging mode and a battery was charging in the External Battery Charger. The ac input to the External Battery Charger was 120 volts, 60 Hz.







