<p>If antenna is detachable bandwidth measurements shall be performed at the antenna connector (conducted measurement) when the transmitter is adjusted in accordance with the tune-up procedure, if applicable. The RF output terminals are connected to a spectrum analyzer. If required, a resistive matching network equal to the impedance specified or employed for the antenna is used as well as dc block and appropriate attenuators (50 Ohms). The electrical characteristics of the radio frequency load attached to the output terminals shall be stated, if applicable.</p> <p>If radiated measurements are performed the same test setups and instruments are used as with radiated emission measurements for the appropriate frequency range.</p> <p>The analyzer settings are specified by the test description of the appropriate test record(s).</p>	



## 6.2 Conducted AC Powerline Emission

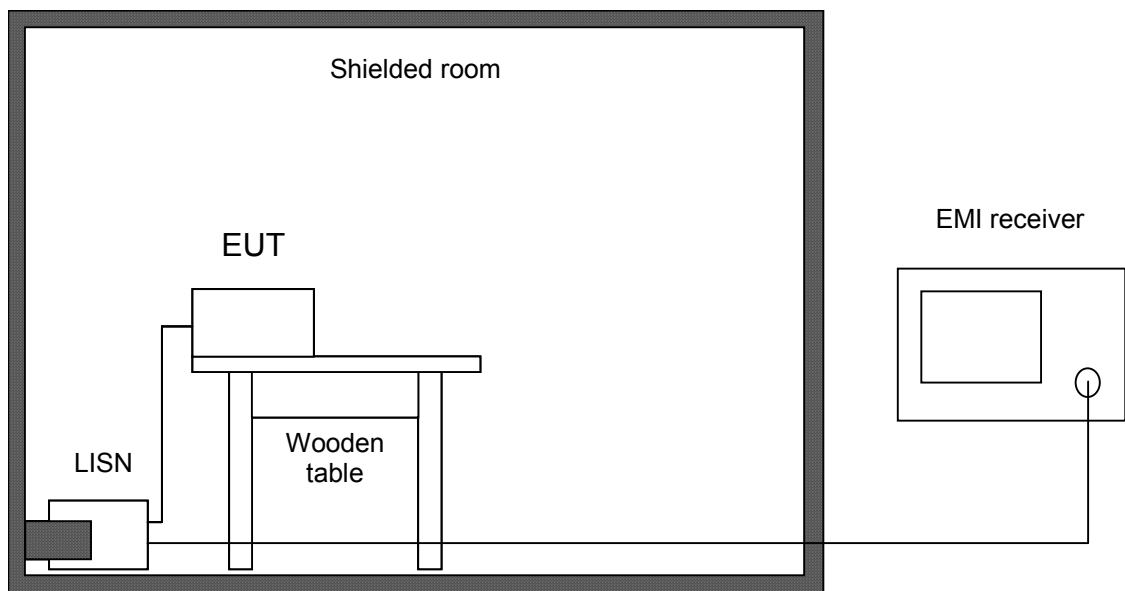
Conducted emission tests in the frequency range 150 kHz to 30 MHz are performed using Line Impedance Stabilization Networks (LISNs). To simplify testing with quasi-peak and average detector the following procedure is used:

First the whole spectrum of emission caused by the equipment under test (EUT) is recorded with detector set to peak using CISPR bandwidth of 10 kHz. After that all emission levels having less margin than 10 dB to or exceeding the average limit are retested with detector set to quasi-peak.

If average limit is kept with quasi-peak levels no additional scan with average detector is necessary. In cases of emission levels between quasi-peak and average limit an additional scan with detector set to average is performed.

According to ANSI C63.10, section 6.2.5, testing of intentional radiators with detachable antenna shall be performed using a suitable dummy load connected to the antenna output terminals. Otherwise, the tests shall be made with the antenna connected and, if adjustable, fully extended.

Testing with dummy load may be necessary to distinguish (unintentional) conducted emissions on the supply lines from (intentional) emissions radiated by the antenna and coupling directly to supply lines and/or LISN. Usage of dummy load has to be stated in the appropriate test record(s) and notes should be added to clarify the test setup.



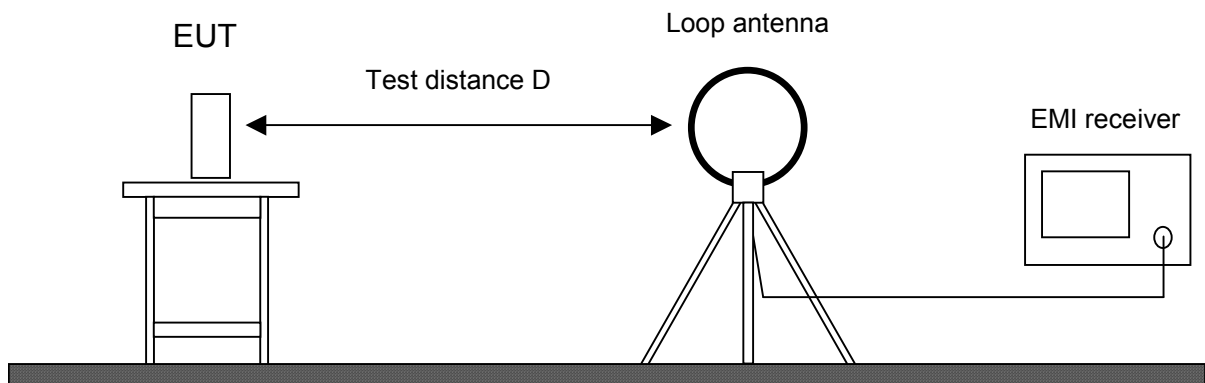

### 6.3 Radiated Emission Measurement 9 kHz to 30 MHz

Measurement Procedure:	
Rules and specifications:	CFR 47 Part 15, sections 15.209, 15.215 and 15.256 IC RSS-GEN Issue 4, sections 8.9 and 8.10 IC RSS-210 Issue 1
Guide:	ANSI C63.4
<p>Radiated emission in the frequency range 9 kHz to 30 MHz is measured using an active loop antenna. First the whole spectrum of emission caused by the equipment is recorded at a distance of 3 meters in a fully or semi anechoic room with the detector of the spectrum analyzer or EMI receiver set to peak. This configuration is also used for recording the spectrum of intentional radiators.</p> <p>Hand-held or body-worn devices are rotated through three orthogonal axes to determine which attitude and configuration produces the highest emission relative to the limit and therefore shall be used for final testing.</p> <p>EUT is rotated all around to find the maximum levels of emissions. Equipment and cables are placed and moved within the range of position likely to find their maximum emissions.</p> <p>If worst case emission of the EUT cannot be recorded with EUT in standard position and loop antenna in vertical polarization the EUT (or the radiating part of the EUT) is rotated by 90 degrees instead of changing the loop antenna to horizontal polarization. This procedure is selected to minimize the influence of the environment (e.g. effects caused by the floor especially with longer distances).</p> <p>Final measurement is performed at a test distance D of 30 meters using an open field test site. In case the regulation requires testing at other distances, the result is extrapolated by either making measurements at an additional distance D of 10 meters to determine the proper extrapolation factor or by using the square of an inverse linear distance extrapolation factor (40 dB/decade). In cases of very low emissions measurements are performed at shorter distances and results are extrapolated to the required distance. The provisions of CFR 47 Part 15 sections 15.31(d) and (f)(2) apply. According to CFR 47 Part 15 section 15.209(d) final measurement is performed with detector function set to quasi-peak except for the frequency bands 9 to 90 kHz and 110 to 490 kHz where, for non-pulsed operation, average detector is employed.</p> <p>If the radiated emission limits are expressed in terms of the average value of the emission there also is a peak limit corresponding to 20 dB above the maximum permitted average limit. Additionally, if pulsed operation is employed, the average field strength is determined by averaging over one complete pulse train, including blanking intervals, as specified in CFR 47 Part 15 section 15.35(c). If the pulse train exceeds 0.1 second that 0.1 second interval during which the value of the emission is at its maximum is selected for calculation. The pulse train correction is added to the peak value of the emission to get the average value.</p>	

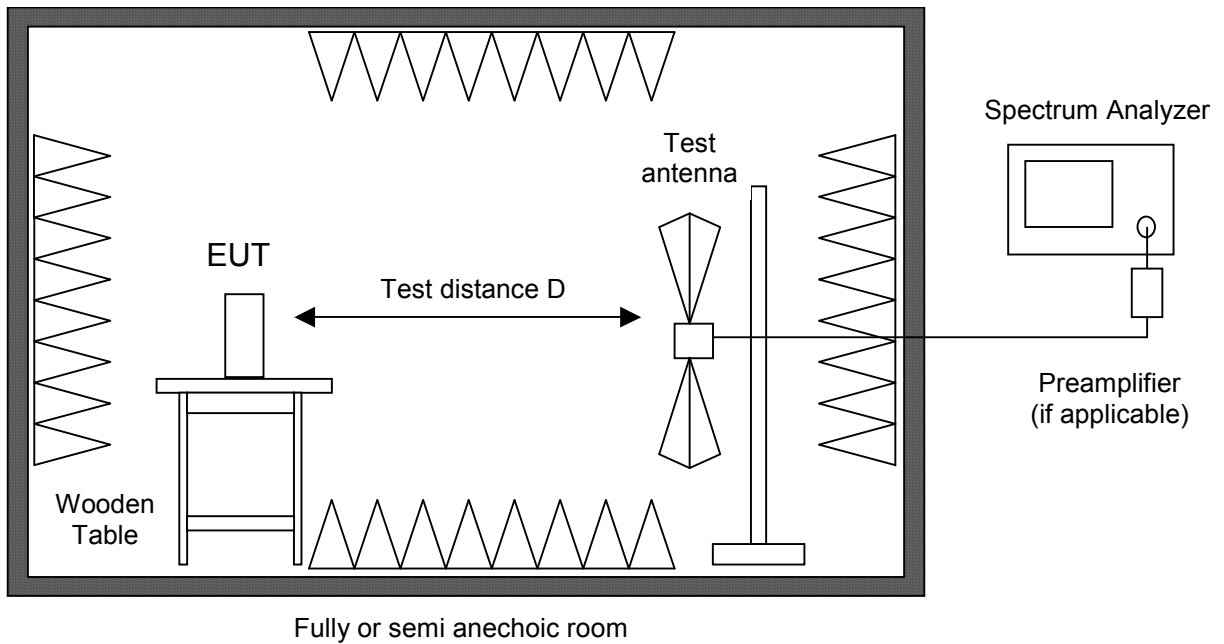

## 6.4 Radiated Emission in Fully or Semi Anechoic Room

Measurement Procedure:	
Rules and specifications:	CFR 47 Part 15, sections 15.209, 15.215 and 15.256 IC RSS-GEN Issue 4, section 8.9 IC RSS-211 Issue 1
Guide:	ANSI C63.4
<p>Radiated emission in fully or semi anechoic room is measured in the frequency range from 30 MHz to the maximum frequency as specified in CFR 47 Part 15 section 15.33.</p> <p>Measurements are made in both the horizontal and vertical planes of polarization using a spectrum analyzer with the detector function set to peak and resolution as well as video bandwidth set to 100 kHz (below 1 GHz) or 1 MHz (above 1 GHz).</p> <p>Testing up to 1 GHz is performed with a linear polarized logarithmic periodic antenna combined with a 4:1 broadband dipole ("Trilog broadband antenna"). For testing above 1 GHz horn antennas are used.</p> <p>All tests below 8.2 GHz are performed at a test distance D of 3 meters. For higher frequencies the test distance may be reduced (e.g. to 1 meter) due to the sensitivity of the measuring instrument(s) and the test results are calculated according to CFR 47 Part 15 section 15.31(f)(1) using an extrapolation factor of 20 dB/decade. If required, preamplifiers are used for the whole frequency range. Special care is taken to avoid overload, using appropriate attenuators and filters, if necessary.</p> <p>If the radiated emission limits are expressed in terms of the average value of the emission there also is a peak limit corresponding to 20 dB above the maximum permitted average limit. Additionally, if pulsed operation is employed, the average field strength is determined by averaging over one complete pulse train, including blanking intervals, as specified in CFR 47 Part 15 section 15.35(c). If the pulse train exceeds 0.1 second that 0.1 second interval during which the value of the emission is at its maximum is selected for calculation. The pulse train correction is added to the peak value of the emission to get the average value.</p> <p>Hand-held or body-worn devices are rotated through three orthogonal axes to determine which attitude and configuration produces the highest emission relative to the limit and therefore shall be used for final testing.</p> <p>During testing the EUT is rotated all around to find the maximum levels of emissions. Equipment and cables are placed and moved within the range of position likely to find their maximum emissions.</p> <p>For final testing below 1 GHz a semi anechoic room complying with the NSA requirements of ANSI C63.4 respectively ANSI C63.10 for alternative test sites is used (see 6.5). If prescans are recorded in fully anechoic room they are indicated appropriately.</p>

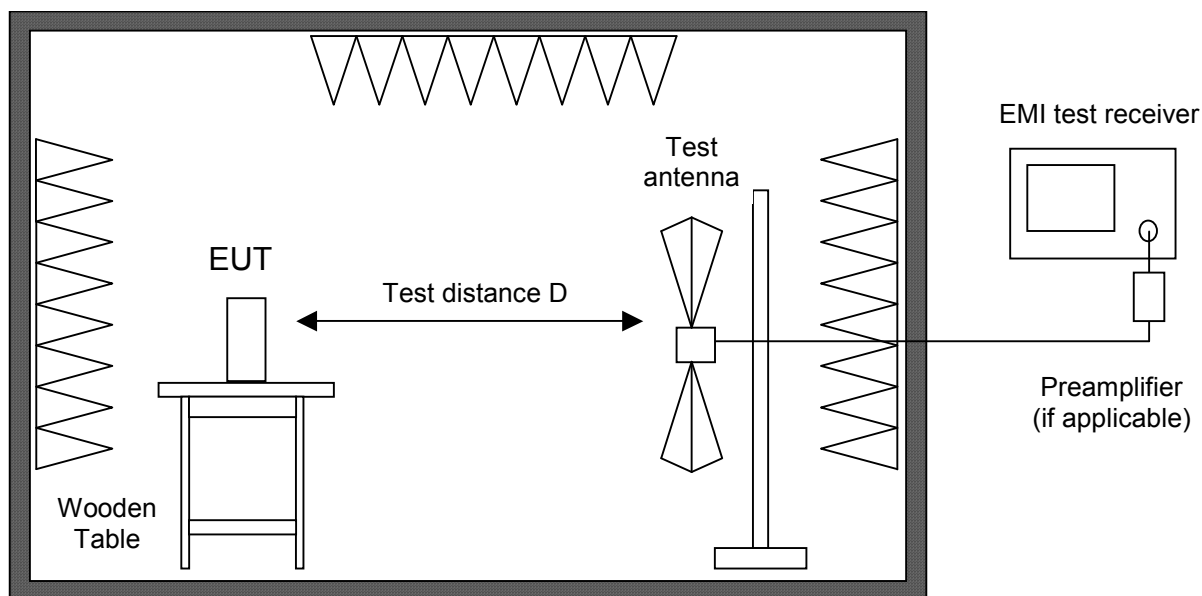

## 6.5 Radiated Emission at Alternative Test Site

Measurement Procedure:	
Rules and specifications:	CFR 47 Part 15, sections 15.209, 15.215 and 15.256 IC RSS-GEN Issue 4, section 8.9 IC RSS-211 Issue 1
Guide:	ANSI C63.10
<p>Radiated emission in the frequency range 30 MHz to 1 GHz is measured within a semi-anechoic room with groundplane complying with the NSA requirements of ANSI C63.4 respectively ANSI C63.10 for alternative test sites. A linear polarized logarithmic periodic antenna combined with a 4:1 broadband dipole ("Trilog broadband antenna") is used. The measurement bandwidth of the test receiver is set to 120 kHz with quasi-peak detector selected.</p> <p>If the radiated emission limits are expressed in terms of the average value of the emission there also is a peak limit corresponding to 20 dB above the maximum permitted average limit. Additionally, if pulsed operation is employed, the average field strength is determined by averaging over one complete pulse train, including blanking intervals, as specified in CFR 47 Part 15 section 15.35(c). If the pulse train exceeds 0.1 second that 0.1 second interval during which the value of the emission is at its maximum is selected for calculation. The pulse train correction is added to the peak value of the emission to get the average value.</p> <p>Hand-held or body-worn devices are tested in the position producing the highest emission relative to the limit as verified by prescans in fully anechoic room.</p> <p>If no prescan in a fully anechoic room is used first a peak scan is performed in four positions to get the whole spectrum of emission caused by EUT with the measuring antenna raised and lowered from 1 to 4 m to find table position, antenna height and antenna polarization for the maximum emission levels.</p> <p>Data reduction is applied to these results to select those levels having less margin than 10 dB to or exceeding the limit using subranges and limited number of maximums. Further maximization is following.</p> <p>With detector of the test receiver set to quasi-peak final measurements are performed immediately after frequency zoom (for drifting disturbances) and maximum adjustment.</p> <p>Equipment and cables are placed and moved within the range of position likely to find their maximum emissions.</p> <p>In cases where prescans in a fully anechoic room are taken (e. g. if EUT is operating for a short time only or battery is discharged quickly) final measurements with quasi-peak detector are performed manually at frequencies indicated by prescan with EUT rotating all around and receiving antenna raising and lowering within 1 meter to 4 meters to find the maximum levels of emission.</p> <p>Equipment and cables are placed and moved within the range of position likely to find their maximum emissions.</p> <p>For measuring emissions of intentional radiators and receivers a test distance D of 3 meters is selected. Testing of unintentional radiators is performed at a distance of 10 meters. SAR evaluation is required if the separation distance between the user and/or bystander and the antenna and/or radiating element of the device is less than or equal to 20 cm, except when the device operates at or below the applicable output power level (adjusted for tune-up tolerance) for the specified separation distance defined in the table.

For controlled use devices where the 8 W/kg for 1 gram of tissue applies, the exemption limits for routine evaluation in the table are multiplied by a factor of 5. For limb-worn devices where the 10 gram value applies, the exemption limits for routine evaluation in the table are multiplied by a factor of 2.5. If the operating frequency of the device is between two frequencies located in the table, linear interpolation shall be applied for the applicable separation distance. For test separation distance less than 5 mm, the exemption limits for a separation distance of 5 mm can be applied to determine if a routine evaluation is required.

For medical implants devices, the exemption limit for routine evaluation is set at 1 mW. The output power of a medical implants device is defined as the higher of the conducted or e.i.r.p to determine whether the device is exempt from the SAR evaluation.
