Section 1: Overview

1.1 Test Summary

2.1 General



Radiated Transmitter Spurs, 5300MHz, All Rates, All Modes, Average 1-18 GHz


Radiated Transmitter Spurs, 5300MHz, All Rates, All Modes, Peak 1-18 GHz








Radiated Test Setup 1–18GHz




