Equation（1）and the measured peak power are used to calculate the MPE distance．Note that for mobile or fixed location transmitters such as an access point，the minimum separation distance is 20 cm even if the calculations indicate that the MPE distance may be less．
$\mathrm{S}=1 \mathrm{~mW} / \mathrm{cm}^{\wedge} 2$ maximum．Using the peak power levels recorded in the test report along with Equation 1 above，the MPE distances are calculated as follows．
