### 2.2 Test Mode



The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

#### Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10 dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 4.2 + 10 = 14.2 (dB)

1. The EUT is placed on a turntable with 0.8 meter for frequency below 1 GHz and 1.5 meter for frequency above 1 GHz respectively above ground.

- 2. The EUT is set 3 meters away from the receiving antenna, which is mounted on the top of a variable height antenna tower.
- 3. For each suspected emission, the EUT is arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. 


#### For radiated test below 30MHz



#### For radiated test from 30MHz to 1GHz



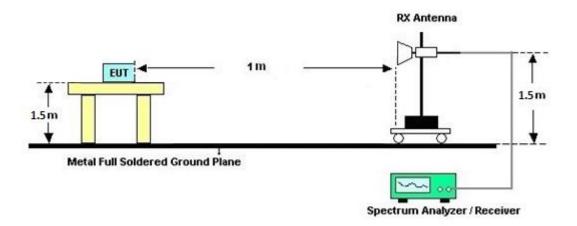

# 2.4GHz 2400~2483.5MHz BT (Band Edge @ 3m)



# Emission above 18GHz 2.4GHz BT (SHF @ 1m)




# Emission below 1GHz 2.4GHz BT (LF)

#### **Duty Cycle Correction Factor Consideration for AFH mode:**

Bluetooth normal hopping rate is 1600Hz and reduced to 800Hz in AFH mode; due to the reduced number of hopping frequencies, with the same packet configuration the dwell time in each channel frequency within 100msec period is longer in AFH mode than normal mode.

In AFH mode, the minimum hopping frequencies are 20, to get the longest dwell time DH5 packet is observed; the on time period to have DH5 packet completing one hopping sequence is

$$2.89 \text{ ms x } 20 \text{ channels} = 57.8 \text{ ms}$$

There cannot be 1 complete hopping sequences within 100ms period, considering the random hopping behavior, maximum 1 hops can be possibly observed within the period. [100 ms / 57.8 ms] = 1 hops Thus, the maximum possible ON time:

$$2.89 \text{ ms } x 1 = 2.89 \text{ ms}$$

Worst case Duty Cycle Correction factor, which is derived from the maximum possible ON time,

$$20 \times log(2.89 \text{ ms/}100 \text{ ms}) = -30.78 \text{ dB}$$
