

## A.1 Duty Cycle

## **Duty Cycle Test Requirement**

#### From KDB 558074, Section 6

#### 6.0 Duty cycle, transmission duration and maximum power control level

Preferably, all measurements of maximum conducted (average) output power will be performed with the EUT transmitting continuously (*i.e.*, with a duty cycle of greater than or equal to 98%). When continuous operation cannot be realized, then the use of sweep triggering/signal gating techniques can be utilized to ensure that measurements are made only during transmissions at the maximum power control level. ...

When continuous transmission cannot be achieved and sweep triggering/signal gating cannot be implemented, alternate procedures are provided that can be used to measure the average power; however, they will require an additional measurement of the transmitter duty cycle. Within this guidance document, the duty cycle refers to the fraction of time over which the transmitter is on and is transmitting at its maximum power control level. The duty cycle is considered to be constant if variations are less than  $\pm 2$  percent, otherwise the duty cycle is considered to be non-constant.

## **Duty Cycle Test Method**

#### From KDB 558074, Section 6:

The zero-span mode on a spectrum analyzer or EMI receiver if the response time and spacing between bins on the sweep are sufficient to permit accurate measurements of the on and off times of the transmitted signal. Set the center frequency of the instrument to the center frequency of the transmission. Set RBW  $\geq$  OBW if possible; otherwise, set RBW to the largest available value. Set VBW  $\geq$  RBW. Set detector = peak or average. The zero-span measurement method shall not be used unless both RBW and VBW are > 50/T and the number of sweep points across duration T exceeds 100. (For example, if VBW and/or RBW are limited to 3 MHz, then the zero-span measurement method of measuring duty cycle shall not be used if T  $\leq$  16.7 microseconds.)

The 26 dB emission is the width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 26 dB relative to the maximum level measured in the fundamental emission.

1. Set the radio in the continuous transmitting mode.

2. Allow the trace to stabilize.

- 4. Select the automatic OBW measurement function of an instrument to perform bandwidth measurement.

5. Capture graphs and record pertinent measurement data.

#### 6.9.3 Occupied bandwidth—power bandwidth (99%) measurement procedure

The occupied bandwidth is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers are each equal to 0.5% of the total mean power of the given emission. The following procedure shall be used for measuring 99% power bandwidth:

- a) The instrument center frequency is set to the nominal EUT channel center frequency. The frequency span for the spectrum analyzer shall be between 1.5 times and 5.0 times the OBW.
- b) The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1% to 5% of the OBW, and VBW shall be approximately three times the RBW, unless otherwise specified by the applicable requirement.
- c) Set the reference level of the instrument as required, keeping the signal from exceeding the maximum input mixer level for linear operation. In general, the peak of the spectral envelope shall be more than [10 log (OBW/RBW)] below the reference level. Specific guidance is given in 4.1.5.2.
- d) Step a) through step c) might require iteration to adjust within the specified range.
- e) Video averaging is not permitted. Where practical, a sample detection and single sweep mode shall be used. Otherwise, peak detection and max hold mode (until the trace stabilizes) shall be used.
- f) Use the 99% power bandwidth function of the instrument (if available) and report the measured bandwidth.
- g) If the instrument does not have a 99% power bandwidth function, then the trace data points are recovered and directly summed in linear power terms. The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5% of the total is reached; that frequency is recorded as the lower frequency. The process is repeated until 99.5% of the total is reached; that frequency is recorded as the upper frequency. The 99% power bandwidth is the difference between these two frequencies.
- h) The occupied bandwidth shall be reported by providing plot(s) of the measuring instrument display; the plot axes and the scale units per division shall be clearly labeled. Tabular data may be reported in addition to the plot(s).



### **Maximum Conducted Output Power Test Requirement**

#### FCC, 15.247/ LP0002:3.10.1(2.3):

(b) The maximum peak conducted output power of the intentional radiator shall not exceed the following: (3) For systems using digital modulation in the 902-928 MHz, **2400-2483.5 MHz**, and 5725-5850 MHz bands: **1 Watt**. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. 





Conducted Spurs Peak Upper, All Antennas








