# 1.0: Attestation Statement of Compliance

The Cisco 802.11AC radio has been evaluated for Maximum Permissible Exposure in compliance with 47 Code of Federal Regulations 2.1091. The evaluation was in accordance with methodology as referenced in FCC Bulletin OET 65C (rev 01-01) along with KDB 447498 D01 General RF Exposure Guidance. This report serves as the additional technical analysis of the Cisco radio modules

This study addresses the addition of an additional pair of transmitters using the data derived in the afore mentioned report #

The limits used for this evaluation are in line with the recommendations of the World Health Organizations (WHO) International Committee on Non Ionizing Radiation Protection (ICNIRP) as well as the American National Standards Institute (ANSI) C95.1.

The limits chosen are of General Population/Uncontrolled Exposure.

the following case scenarios were used:

2.4GHz WLAN 5GHz WLAN

This device must be installed to provide a separation distance of at least 60 cm from all persons. Installers must be provided with antenna installation and transmitter operating conditions for satisfying RF exposure compliance.

Based on the study this case scenario, the General Population/Uncontrolled Exposure and the minimum recommended distance is around 60cm (23.6 inches) from the antenna.

# 2.0 EUT Description.

The Cisco Aironet 802.11ac Radio supports the following modes of operation. The modes are further defined in the radio Theory of Operation. The modes included in this report represent the worst case data for all modes.

#### 5.0 Calculations

Given

 $E=\sqrt{(30*P*G)}/d$  and  $S=E^2/3770$ 

where

E=Field Strength in Volts/meter

P=Power in Watts

G=Numeric Antenna Gain d=Distance in meters

S=Power Density in mW/cm^2

Combine equations and rearrange the terms to express the distance as a function of the remaining variables:

d=√((30\*P\*G)/(3770\*S))

Changing to units of power in mW and distance in cm, using:

P(mW)=P(W)/1000 d(cm)=100\*d(m)

yields

 $d=100*\sqrt{((30*(P/1000)*G)/(3770*S))}$ 

 $d=0.282*\sqrt{(P*G/S)}$ 

where

d=Distance in cm P=Power in mW

G=Numeric Antenna Gain S=Power Density in mW/cm^2

Substituting the logarithmic form of power and gain using:

 $P(mW)=10^{(P(dBm)/10)}$   $G(numeric)=10^{(G(dBi)/10)}$ 

yields

 $d=0.282*10^{(P+G)/20}/\sqrt{S}$  Equation (1)

and

 $s=((0.282*10^{(P+G)/20)})^2$  Equation (2)

where

d=MPE distance in cm P=Power in dBm G=Antenna Gain in dBi

S=Power Density in mW/cm^2

#### 6.0 Results

#### MPE Calculations: Antennas up to 8dBi Gain

Equation (1) and the measured peak power are used to calculate the MPE distance. Note that for mobile or fixed location transmitters such as an access point, the minimum separation distance is 25 cm even if the calculations indicate that the MPE distance may be less.

S=1mW/cm^2 maximum. Using the peak power levels recorded in the test report along with Equation 1 above, the MPE distances are calculated as follows.

#### Calculations with additional transmitters

The Cisco 802.11ac Radio support operation with, 2.4GHz WLAN & 5GHz WLAN.

Scenerio

2.4GHz WLAN (Highest power) 5GHz WLAN (Highest power)

$$TX1 + TX2 = \%$$
 of standard  $(0.48) + (0.38) = 0.86$   
D (estimate) =  $25*\sqrt{\%}$ 

D = 23.3cm which is less than 25cm recommended

The configuration above co-location calculation is for **General Population/Uncontrolled exposure**. The minimum distance recommended is **25cm (9.8 inches)** for antennas upto 8dBi Gain.

#### MPE Calculations: Antennas greater than 8dBi up to 14dBi Gain

Equation (1) and the measured peak power are used to calculate the MPE distance. Note that for mobile or fixed location transmitters such as an access point, the minimum separation distance is 60 cm even if the calculations indicate that the MPE distance may be less.

S=1mW/cm<sup>2</sup> maximum. The highest supported antenna gain is 14dBi. Using the peak power levels recorded in the test report along with Equation 1 above, the MPE distances are calculated as follows.

 of standard  $(0.27) + (0.27) = 0.54$ 

D (estimate) = 
$$60*\sqrt{\%}$$

D = 44.09 cm which is less than 60cm recommended

The configuration above co-location calculation is for **General Population/Uncontrolled exposure**. The minimum distance recommended is **60cm (23.6 inches)** for antennas up to 14dBi Gain.
