2.1. Test Mode


The EUT is tested along with the peripherals, operating under possible configurations in compliant with normal operation. The maximum emissions can be identified by a pre-scan carried out in different orientations of placement pursuant to ANSI C63.4-2014. Frequency range covered: Radiation Emission (30 MHz to the 5th harmonics of the highest fundamental frequency or to 40 GHz, whichever is lower).

- **2.** For Radiation Emission after pre-scanned the cellular band between 30MHz ~ 960MHz (LTE Band 5); only the worst case for cellular band test data of this mode was reported.
- 3. TC1 stands for test configuration, and consists of EUT, "Teddy Jr Load Box (X1 + X2), External Antenna (Molex PN 85660742) with metal plate (X3), Ethernet connector cable (X7), Battery", Teddy Jr Load Box, "Notebook (USB Cable *2), Adapter, DC Cable" and External Antenna (Molex PN 85660742, "Power Connector(DC12V)".
- 4. TC2 stands for test configuration, and consists of EUT, "Teddy Jr Load Box (X1 + X2), External Antenna (Continental_GM PN 85556753) with metal plate (X3), Ethernet connector cable (X7), Battery" and Teddy Jr Load Box, "Notebook (USB Cable *2), Adapter and DC Cable".

2.4. EUT Operation Test Setup

The EUT is in LTE idle mode during the test. The EUT is synchronized with the BCCH, and has been continuous receiving mode by setting paging reorganization of the system simulator.

At the same time, the following programs installed in the EUT are programmed during the test:

1. Execute "Ite_x24_hwtool_0.6.24.exe" to make the EUT receive continuous signals from GPS station.

3. Test Result

3.1. Test of Radiated Emission Measurement

3.1.1. Limit of Radiated Emission

The emissions from an unintentional radiator shall not exceed the field strength levels specified in the following table:


3.1.3. Test Procedures

- 1. The EUT is placed on a turntable with 0.8 meter above ground.
- 2. The EUT is set 3 meters from the interference receiving antenna, which is mounted on the top of a variable height antenna tower.
- 3. The table is rotated 360 degrees to determine the position of the highest radiation.
- 4. The antenna is a Bi-Log antenna and its height is adjusted between one to four meters above ground to find the maximum value of the field strength for both horizontal polarization and vertical polarization of the antenna.
- 5. For each suspected emission, the EUT is arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading.
- Set the test-receiver system to Peak Detect Function and specified bandwidth with Maximum Hold Mode (RBW=120 kHz/VBW=300 kHz for frequency below 1 GHz; RBW=1 MHz VBW=3 MHz (Peak), RBW=1 MHz/VBW=10 Hz (Average) for frequency above 1 GHz).
- If the emission level of the EUT in peak mode is 3 dB lower than the limit specified, peak values of EUT will be reported. Otherwise, the emission will be repeated by using the quasi-peak method and reported.


