

Bluetooth Communication mode (GFSK, 2441MHz)



Bluetooth Communication mode (GFSK, 2480MHz)





Bluetooth Communication mode (π/4 DQPSK, 2441MHz)







Bluetooth Communication mode (8DPSK, 2402MHz)

3.1.2 Radiated Spurious Emissions

Test Method:

For emission measurements at or below 1 GHz, the sample was placed 0.8m above the ground plane of semi-anechoic Chamber*. For emission measurements above 1 GHz, the sample was placed 1.5m above the ground plane of semi-anechoic Chamber*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.




Channel separation = 1MHz (>858.0kHz) (Mid) (8DPSK)



[Pulse duration of Highest Channel]





Fig. E [Pulse duration of Middle Channel]





Fig. F [Pulse duration of Highest Channel]









Fig. I [Pulse duration of Highest Channel]


