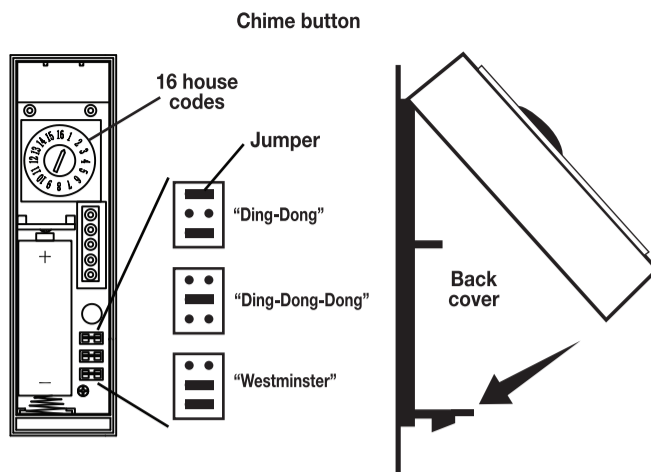

MOUNTING BACK COVER OF CHIME BUTTON

Note: Mounting the button directly on metal, concrete or near metal studs reduces the range.

1. Remove cover from back of chime button by inserting flat head screwdriver into the larger rectangular slot on bottom of chime button and gently twist on tab. Lift chime button away from the back cover.
2. Place chime button back cover where desired and mark screw locations.
3. Place chime button back cover against mounting surface and screw into marked locations using screws enclosed (may require drilling pilot holes on hardwoods).
4. Insert the 12-volt alkaline battery in chime button according to the (+, -) placement guides shown. Use of another battery may cause failure of the chime button and will void manufacturer's warranty and liability.
