Introduction

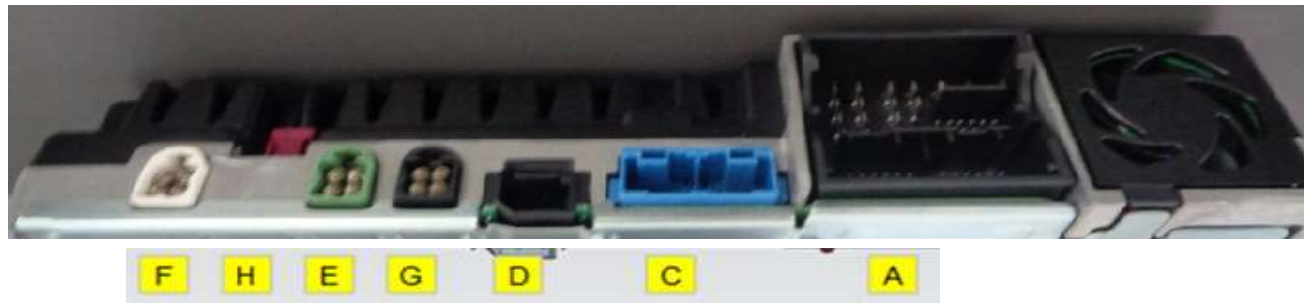
This document shall describe the Product Iveco IHP its functionalities and services in context to the truck.

This product is a Head Unit for Iveco Daily and Stralis Vehicles, with the model name **IHP**.

This unit receives analogue radio signal (AM, FM), digital radio signal (DAB), also supports CarPlay/Android Auto functions.

It handles media USB up to two ports, supports Bluetooth connection 5.1 core specification (BR/EDR and LE) and WiFi 6 capabilities (802.11 a/b/g/n/ac/ax = WIFI6 with 20/40/80 MHz of Bandwidth, 2.4 GHz, 5 GHz with SISO and MIMO (2x2) capabilities).

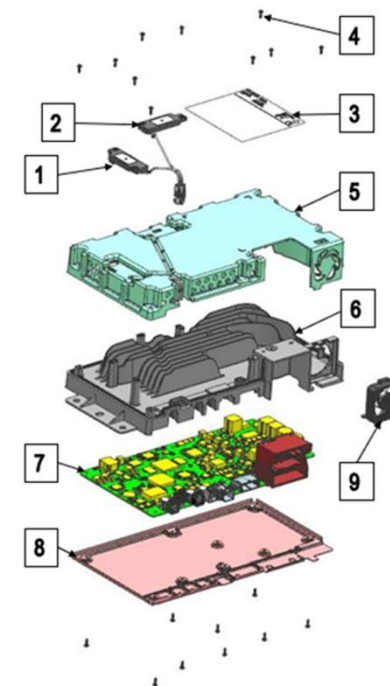

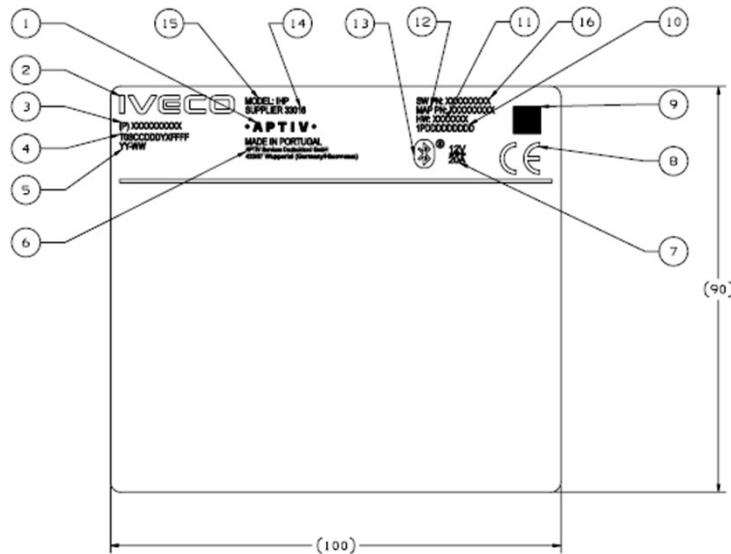
