
Duty Cycle Correction During 100msec

Each function key sends a different series of characters, but each packet period (20.75msec) never exceeds a series of 4 long (1.75msec) and 10 short (625 μ sec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 4x1.75 μ sec+10x625 μ sec per 20.75msec=63.8% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.



Front View of the product




Inner Circuit Top View
