
#### **Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (29.4msec) never exceeds a series of 5 long (2msec) and 4 short (1.2msec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 5x2msec+4x1.2msec per 29.4msec=50.3% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.


